5.2 Ffurflen flynyddol 2024-2025/ *Annual Return 2024-2025* - Mae'r Ffurflen Flynyddol ac y cyfrifon ar hyn o bryd gyda'r archwiliwr mewnol yn cael ei harchwilio. Bydd RDJ yn cysylltu a pawb unwaith y bydd wedi'i derfynu fel y gall gael ei gymeradwyo/ *The Annual Return and accounts are currently with the internal auditor being audited. RDJ will be in touch with everyone once it has been finalised so that it can be approved.*

5.3 Cais am Grant - Gwynedd Ni/ *Grant Application - Gwynedd Ni* - Cadarnhaodd RDJ fod grant ar gael am £6,500 i helpu'r gymuned. Awgrymodd MR y gellid defnyddio'r arian yma i ymestyn y parc ac adeiladu ffens newydd. Cadarnhaodd RDJ mai syniad yw hwn, ac ein bod yn croesawu unrhyw awgrymiadau eraill gan y Cynghorwyr ynghylch sut y gellid defnyddio'r arian. Cadarnhaodd pawb y byddent yn hapus i'r arian gael ei ddefnyddio ar gyfer y ffens. AJ yn cynnig ac eiliodd GVJ/ *RDJ confirmed that there is a grant available for £6,500 to help the community. MR suggested that we could use these funds to extend the park and construct new fencing. RDJ confirmed that this is an idea at this stage and that we welcome any other suggestions that the Councillors have for what the money could be used for. All*

*confirmed that they would be happy for the funds to be used for the fencing.
Proposed by AJ and seconded by GVJ*

- 5.4 Rheoliadau Ariannol Diwygiedig 2025/ *Revised Financial Regulations 2025 - Cafodd y mater ei ystyried a'i basio gan y Cyngor. MR yn cynnig a AJ yn eilio. / The matter was considered and passed by the Council. Proposed by MR and seconded by AJ.*

6. Eitemiau sefydlog/Regular items

- 6.1 Mynwent Minffordd Cemetery - Dim byd i'w adroddi nol, ond mae MR wedi derbyn cyfathrebiad gan aelod o'r cyhoedd yn gofyn a ellid gosod mainc yn adran plant y fynwent. Mae'r grisiau sy'n arwain o'r ffordd waelod hefyd yn llithrig. Cyngorodd RE y gallai ef a SM gynorthwyo gyda glanhau'r grisiau. Cadarnhaodd MR fod mainc sbar yn y sied y gellid ei gosod yn y fynwent. Ar gyfer beddau'r plant nad oes ganddynt garreg fedd, bydd MR yn trefnu i hadau blodau gwyllt gael eu plannu wrth ymyl y beddau/*Nothing to report however, MR has received communication from a member of the public to ask if a bench could be placed in the children's section of the cemetery, the steps leading from the bottom road are also slippery. RE advised that he and SM could assist with cleaning the steps. MR confirmed that there is a spare bench in the shed that we could install at the cemetery. For the children's graves that do not have a headstone, MR would organise for wild seeds to be planted next to the graves.*
- 6.2 Parc Mileniwm/ *Millennium Park* - Mae fandaliaeth wedi digwydd yn y parc unwaith eto. Mae'r wal gerrig wrth ymyl y parc sgleftrio wedi cael ei difrodi/dymchwel. Mae hyn wedi cael ei hysbysu i'r heddlu ac rydym yn aros am ymateb. Mae CCTV ar gael y bydd angen i'r heddlu gael mynediad iddo. Mae MR hefyd wedi gofyn i Ysgol Cefn Coch a all yr heddlu gael mynediad at eu CCTV i weld y fandaliaeth. Mae Howard wedi trwsio'r dail pren yn y parc – diolch yn fawr iawn i Howard am wneud hyn. Mae Y Dref Werdd wedi dechrau'r gwaith yn y parc. Mae'r diwrnod plannu wedi'i ohirio oherwydd y tywydd, ond bydd bellach yn cael ei gynnal ar 17 Mehefin/*There has been vandalism in the park again. The stone wall next to the skate park has been damaged/pulled down. This has been reported to the police and we are awaiting a response. There is CCTV which the police will need to access. MR has also asked Ysgol Cefn Coch if the police can access their CCTV to view the footage of the vandalism. Howard has fixed the wooden leaves in the park, a big thank you to Howard for doing this. Y Dref Werdd have started the work in the park. The planting day has been postponed due to the weather but will now take place on the 17th June.*
- 6.3 Cae Cookes - Mae Cyfoeth Naturiol Cymru yn hapus i ni symud ymlaen ac i gael gwared ar rai planhigion/coed yn yr ardal. Bydd yr adroddiad gan Caulmert yn ein cwmpasu am y tair blynedd nesaf. Mae SM i fod i gael cyfarfod safle gyda Dŵr Cymru ar 20 Mehefin i drafod y materion ymhellach gyda nhw. Bydd angen i ni aros tan fis Awst cyn y gallwn dynnu coed oherwydd y tymor nythu. Soniodd RE fod

Blaenau Ffestiniog wedi gwneud rhywbeth tebyg ac gofynnodd a allem gysylltu a nhw am gyngor ar sut i'w sefydlu. Cadarnhaodd MR ei bod wedi siarad gyda Wil Gritten am hyn, ac roedd ef wedi dweud y gallem gysylltu ag o i drafod ymhellach./ *Natural Resources Wales are happy for us to proceed and remove some plants/trees in the area. The report from Caulmert will cover us for the next 3 years. SM is due to have a site meeting with Dwr Cymru on the 20th June to discuss matters further with them. We will need to wait until August before we can remove trees due to the nesting season. RE mentioned that Blaenau Ffestiniog have done something similar and asked if we could get in touch with them for advice on how to set it up. MR confirmed that she had spoken with Wil Gritten about this and he had stated that we could get in touch with him to discuss further.*

- 6.4 Cae Chwaraeu Minffordd *Playground* - Rydym wedi derbyn y llwyth gan y chwarel. Bydd AJ a TO yn delio a'r tyllau yn y ffordd unwaith y bydd AJ yn gwybod pryd fydd TO ar gael. Diolchwyd i'r ddau am eu cymorth/*We have received the delivery from the quarry. AJ and TO will deal with the potholes once AJ knows TO's availability. Both were thanked for their help.*
- 6.5 Maes y Parc - Gofynnodd SH, ar ran y Clwb Pel-droed, a ellid defnyddio'r arian sy'n cael ei ddal gan CTP tuag at y gwaith sydd ei angen ar y cae. Mae'r clwb pel-droed wedi cael dyfynbris ar gyfer y gwaith, sy'n dod i £4,482.00. Cadarnhaodd SH y byddai angen cwblhau'r gwaith cyn diwedd Awst 2025. Gofynnodd AJ a oedd SH wedi cael unrhyw ddyfynbrisiau pellach gan gwmnïau eraill. Dywedodd SH nad oeddent, ond bod y cwmni hwn yn arbenigwr ac wedi cyflawni gwaith i glybiau pel-droed eraill yn yr ardal. Dywedodd SH y gallai wneud hyn, os oes angen. Cynghorodd RDJ y byddai angen adolygu'r "Trust Deed" i weld a ellid rhyddhau arian. Gofynnodd SM, os yw'r amodau'n caniatáu hynny, a yw pawb yn hapus i'r arian gael ei ddefnyddio fel hyn. Ystyriwyd y mater ac roedd pawb yn cytuno nad oedd ganddynt unrhyw wrthwynebiad/ *SH asked, on behalf of the Football club if the money held by CTP could be used towards the work needed on the field. The football club has obtained a quote for the works which amount to £4,482.00. SH confirmed that the work would need to be completed before the end of August 2025. AJ asked if SH had obtained any further quotes from other companies, SH stated that they had not but that this company is a specialist and had carried out work for other football clubs in the area. This is something that SH could do, if necessary. RDJ advised that we would need to review the "Trust deed" to see if the money could be released in this way. SM asked if the conditions do permit it, is everyone happy for the funds to be used in this way. The matter was considered and all advised that they had no objections.*

Cynghorodd RDJ ei bod wedi darllen trwy'r ohebiaeth ond na allai ddod o hyd i unrhyw brosiectau cyfredol gan CTP a fyddai'n gymwys ar gyfer y cyllid. Cynghorodd GVJ ei fod yn meddwl y gallai fod yn briodol i MR/ *GVJ confirmed that there is funding available (between £5,000-£25,000) for local communities to help support energy efficiency, decarbonisation, low carbon projects etc. RDJ advised that she read through the correspondence but could not find any current projects that CTP are involved with that would benefit from the funding. GVJ advised that he thought it may be appropriate for MR.*

9.1 Adroddiad Misol Cyngorydd Sir Meryl Roberts *County Councillor Monthly Report* - Cyhoeddodd MR ei bod wedi mynychu Cyfarfod Cyffredinol Blynyddol Awdurdod Parc Cenedlaethol ddoe. Roedd hi hefyd wedi mynychu cyfarfod One Voice Wales yn Nolgellau, a fu'n llwyddiannus. Dywedodd fod eu cyfarfod nesaf efallai yn Penrhyndeudraeth. Bydd yn rhoi gwybod i'r Cynghorwyr os ydy. Mae MR wedi sefydlu clwb newydd o'r enw "Clwb Clonc a Thrwsio" sy'n cael ei gynnal yn y Neuadd Drefol bob yn ail ddydd Mawrth yn y prynhawn. Mae'r nifer sy'n mynychu yn cynyddu. Mae MR yn bwriadu cynnal sesiwn crefft yn y cyfarfod nesaf/ *MR advised that she had attended the National Park Authority's AGM yesterday. She had also attended One Voice Wales's meeting in Dolgellau which was successful. She advised that their next meeting may be in Penrhyndeudraeth. She will let the Councillors know if it is. MR has set up a club called "Clwb Clonc a Thrwsio" which is held in the Neuadd Drefol every other Tuesday afternoon. Attendance is increasing. MR is looking to do a craft session at the next meeting.*

10. Eitemau i'w trafod/ Items for Discussion

10.1. Cyflymder Band Eang ym Mhenrhyndeudraeth/ *Broadband Speed in Penrhyndeudraeth* - Cadarnhaodd RDJ ein bod wedi derbyn dau e-bost gan aelodau o'r cyhoedd ynghylch cyflymder y rhyngwyd ym Mhenrhyndeudraeth. Mae RDJ wedi anfon y ddau at y Cynghorwyr er mwyn iddynt ystyried y mater. Cadarnhaodd SM ein bod wedi rhannu linc y mae pawb yn gorfod ei dilyn a'i llofnodi cyn i BT Openreach gymryd unrhyw gamau pellach. Cadarnhaodd AJ ymhellach fod angen i nifer penodol o bobl gwblhau'r linc er mwyn galluogi gosod ffibr. Y trafferth yw bod Penrhyndeudraeth, ar y cyfan, yn meddu ar safon "derbyniol" o ran rhyngwyd o'i gymharu a mannau eraill yn yr ardal. Cytunwyd y byddai'r linc yn cael ei hanfon at yr aelodau o'r cyhoedd a fu'n cysylltu a ni. Gall trafodaeth bellach hefyd gael ei chynnal fis nesaf gyda MR i weld os fedrith hi wneud unrhyw beth pellach i helpu./ *RDJ confirmed that we have received two emails from members of the public regarding the broadband speed in Penrhyndeudraeth. RDJ has forwarded both to the Councillors for their consideration. SM confirmed that we had shared the link that all must follow and sign up to before BT Openreach will take any further action. AJ further confirmed that it needs a certain number of people to complete the link in order to trigger the installation of fibre. The difficulty is the fact that*

Penrhyndeudraeth, on the whole, has an "acceptable" standard of internet compared to other places in the area. It was agreed that the link would be sent to the members of public that had been in contact with us. A further discussion could also take place next month with MR to see if she is able to do anything further to assist.
