8.2 Neuadd Drefol: Cytunwyd ar pris i'r gwaith o baentio y neuadd, a buasia'r gwaith yma wedi

gorffen cyn ddiwedd y mis./ A price had been received for the painting of the Memorial Hall, and it was hoped that this would be completed by the end of the month.

8.3 Parc Y Mileniwm: Yn dilyn y sylwadau yn y cyfarfod ynglyn a cyflwr y ffens yn Rhesdai Penbryn, bydd angen ail godi'r ffens o flaen y tai, ac fydd hyn yn cael ei wneud mor fuan a phosib. Yn ogystal i gael asesiad o'r gwaith sydd ei angen gan gwmni fel Rock Engineering i asesu a priso'r gwaith. Byddwn hefyd yn trafod/gwirio'r costau gyda'n cwmni yswiriant.

Nodwyd hefyd pryderon rhai Cynghorwyr ynglyn a pobl yn cerdded eu cwn yn y Parc, ac ddim yn clirio ar eu hol, ac yn gadael baw ci ar lwybrau ag ati. Codi gyda Cyngor Gwynedd /Following the comments in the meeting regarding the fence at Penbryn Terrace, and the land beneath the fence, it was agreed that the fence would be rebuilt, and this would be done as a matter of urgency. In the longer term, it was suggested a civil engineering company (such as Rock Engineering Ltd) would assess the work required to make it safe and secure. Also to discuss the possible costs with our insurance Company.

It was also noted that some residents were walking their dog in the Parc and leaving dog feces on footpaths etc. this to be reported to Gwynedd Council

Following these discussions, it was agreed that we should commission a new report with an improved cross-section of samples taken at the site before making any further decisions regarding its suitability.

It was noted that many white and yellow lines need to be re-painted because of fading in several locations around the town. For example outside of the neuadd drefol The white arrows on the humps at Adwy Ddu, and various double yellow lines across the town. It was noted that the design of the new 20mph signage Gwynedd County Council intends to use, has been designed by a pupil at the local Primary School, as part of a competition.
