8. Eitemau Sefydlog / Standing Items:

8.1 Mynwent Minffordd Cemetery: Oedd yna broblem efo gor-dyfiant yn y mynwent, Cadeirydd eisoes wedi cysylltu efo'r cwmni sydd yn yn cynnal a chadw y mynwent i'w ddatrys./There have been problems with the overgrowth of weeds etc in the cemetery. The Chair has contacted the company that maintains the cemetery on behalf of the council, to resolve the issue.

8.2 Neuadd Drefol: Yn dilyn cynnig y gwaith paentio i gwmni/unigolyn lleol, bydd y gwaith yma yn cael ei gwblhau yn fuan./The contract was offered to a local company, and this work is due to be completed soon.

8.3 Parc Y Mileniwm/Millennium Park: Mae'r ffens newydd wedi ei gwblhau yn Penbryn. Mae'r Cyngor yn disgwyl adrodd yn ol gan Gareth Jones ynglyn a cysylltu efo Rock Engineering i gael adroddiad ar y sefyllfa yno. Nodir fod yna 'blockage' gyda'r draeniau o dan Ty'n Ffrwd ac mae angen ei ddatrys. Ar y Parc Pel (Ball Park) mae angen trwsio wal yno, gan fod y gornel wedi disgyn. Cadeirydd am gysylltu efo cwmni lleol i gael amcangyfrif o'r pris. Codwyd hefyd y mater o fwy o lwch chwarel ar y llwybrau. Hefyd, nifer y biniau baw ci o gwmpas llwybrau yr Ystad Ddiwydiannol ei drafod. Noder hefyd, fod yn ddiweddar oedd yna gynnydd yn y fandaliaeth yn y parc./ A new fence has been completed in Penbryn. The Council is awaiting feedback from Gareth Jones regarding contacting Rock Engineering, to get a detailed report about any issues. There is a drainage blockage at Ty'n Ffrwd that needs to be addressed. The wall in the Ball Park needs repair and the Chair will be contacting a local company to get a quote. The issue of more quarry waste on the paths was also mentioned. The amount of Dog Waste bins on the paths around the Industrial Estate was also discussed. There was an increase in the incidents of vandalism in the parc.

8.7 Ffyrdd a Parcio/Roads & Parking: Trafodwyd yr angen am fwy o biniau baw ci ar y llwybr o gwmpas yr Ystad Ddiwydiannol Eryri Minffordd. Codwyd pryderon ynglyn a'r parcio anhrefnus a pheryg y tu allan i Spar yn y pentre. Yn ogystal cyflwr y llinellau gwyn a melyn (eu ail-baentio) y tu allan i Neuadd Drefol – yn dal i ddigwyl ymateb gan Cyngor Gwynedd./ As previously mentioned, there were discussions about the amount of Dog Waste Bins around the Industrial Estate Eryri Minffordd. Concerns were raised about the dangerous/irresponsible parking outside Spar. Also, the clarity of the white & yellow lines located outside the Neuadd Drefol nearby – these need to be re-painted. We are still awaiting a response from Gwynedd Council.
