In the meantime, a signs needs to be placed on the tree stating that it is diseased, and could be dangerous, and is due for removal.

8.7 Ffyrdd a Parcio/Roads & Parking: Codwyd pryderon ynglyn a'r parcio anhrefnus a pheryg yn y pentre. clerch i ysgrifennu at cyngor gwynedd yn dweud am ein pryderon ni. Hefyd, oedd yna stryd tuag Pant yn cae dros dro, ac oedd yna bryder dros trigolion yn cael mynediad gyda'i ceir yn ystod y cyfnod yma. Gofynwyd i osod yr arwydd 'Aberstalwm' o dan yr arwydd i Penrhyndeudraeth pan yn gyfleus./Concerns were raised about

the dangerous/irresponsible parking in various places around the village. cleric to write to cyngor gwynedd with our concerns. Also, the road to Pant was to be closed temporarily for utility works, and there were concerns raised by residents regarding being able to access their properties while the work is taking place. asked in putting up the 'Aberstalwm' sign under the sign for Penrhyndeudraeth when possible.

9. Ceisiadau Cynllunio Lleol: Local Planning Applications

Cais C23/0416/08/DT: dim gwrthwynebiad i'r cais, ond fydd angen cadw y llwybr ar agor trwy gydol y gwaith atgyweirio os yn bosib. Angen caniatad gan y Cyngor os maent yn bwriadu cau y llwybr./no objections to the application; however, they would like to see the footbath nearby kept open during any renovation work. Should they wish to close the footpath for any reason, this would need the permission of the Council beforehand.

Cais C23/0430/08/LL: . Nid oedd gan y Cyngor gwrthwynebiad i niferoedd y cerbydau gwyliau, ond nid oedd yn cytuno efo ymestyn yr misoedd oedd y gwersyllt/safle ar agor drwy'r flwyddyn, mae angen cadw hwn i'r dyddiadau arferfol, o ystyried cyfyngiadau agor busnesau gwersyllau eraill yn yr ardal/ The Council has no objection to increasing the amount of campervans that can use the new facilities, however it objects to the increase in months the site is open to the public, compared to other campsites in the area.

10. Gwefan:/Website Yn disgwyl fydd o ar gael erbyn y 10/11 o'r mis. It is likely to be up and running by the 10/11th of the month.
