6. Eitemiau sefydlog/*Regular items*

- 6.1 Mynwent Minffordd *Cemetery* - Cadarnhaodd SM ein bod wedi gofyn i Alan glirio'r llwybr/grisiau yn y fynwent, sy'n agos at yr ardal y plant/ *SM confirmed that we have asked Alan to clear the steps/path in the cemetery, which are nearest to the children's section.*
- 6.2 Parc Mileniwm/ *Millennium Park* - Bydd y ffensio newydd yn y parc yn cael eu gosod ddydd Llun. Bydd y parc ar gau yn ystod y cyfnod hwn am tua wythnos. Roedd y heddlu wedi cysylltu â ni ynghylch y difrod i'r wal yn y parc sglefrio. Maent wedi cyflwyno dau opsiwn, un ai i fynd ymlaen a'r cam "yn y llys" neu'r cam "tu allan i'r llys". Pleidleisiodd y Cynghorwyr a phenderfynwyd eu bod am fynd ymlaen gyda opsiwn 1, sef "yn y llys". Cadarnhaodd RDJ y byddai hi'n cysylltu a'r heddlu i gadarnhau hyn. Gofynnodd AJ os oedd unrhyw beth wedi'i wneud ynghylch y llifogydd yn y parc. Cadarnhaodd SM ei fod wedi cysylltu â Dŵr Cymru, ond y byddai'n cysylltu â nhw eto i gael diweddariad.
- The new fencing will be installed in the park on Monday. The park will be closed during this time for approximately a week. The police had been in touch regarding the vandalism to the wall in the skatepark. They had presented us with two options, either to proceed with in court or out of court action. The Councillors voted and decided they wished to proceed with option 1, being the in-court action. RDJ confirmed that she would get in touch with the police to confirm this. AJ asked if anything had been done about the flooding in the park. SM confirmed that he had contacted welsh water but would contact them again for an update.*
- 6.3 Cae Cookes - Cynhaliwyd cyfarfod yn y Neuadd Drefol neithiwr i'r rhai oedd â diddordeb mewn sefydlu pwyllgor rhandiroedd. Fynychodd SM, RDJ, EW a SR. Mae'r Pwyllgor ar y ffordd i gael ei sefydlu, ac mae Victoria yn trefnu hyn/ *A meeting was held at the Neuadd Drefol yesterday evening*

for those who were interested in setting up an allotments committee. SM, RDJ, EW and SR attended. The Committee is in the process of being set up, Victoria is arranging this.

- 6.4 Cae Chwaraeu Minffordd *Playground* - Cadarnhaodd SM ein bod wedi derbyn e-bost gan un o drigolion Minffordd a oedd wedi dioddef codwm ar y llwybr wrth ymyl y parc yn Minffordd. Ers hynny, rydym wedi gofyn i Alan lanhau'r ardal, gan fod dail wedi casglu a'i wneud yn beryglus. Byddwn hefyd yn trefnu i arwydd gael ei roi yno pan fo tywydd gwael. Mae MR wedi dechrau is-bwyllgor cymunedol i helpu gyda'r parciau yn yr ardal. Mae hi wedi derbyn nodyn gan un o drigolion Minffordd yn nodi nad oes llawer yn y parc yn Minffordd o'i gymharu â'r un ym Mhenrhyndeudraeth. Mae hi'n gobeithio y bydd yr is-bwyllgor yn gallu helpu gyda hynny./ *SM confirmed that we had received an email from a resident of Minffordd who had suffered a fall on the path by the park in Minffordd. We have since asked Alan to clear the area as leaves had collected making it a hazard. We will also arrange for a sign to be placed there when there are poor weather conditions. MR has started a sub community committee to help with the parks in the area. She has received a note from a resident in Minffordd stating that there is very little in the park in Minffordd, compared to the one in Penrhyndeudraeth. She hopes that the sub-committee will be able to help with that.*

9.1 Adroddiad Misol Cynghorydd Sir Meryl Roberts *County Councillor Monthly Report* - Fynychodd MR gyfarfod Un Llais Cymru yn ddiweddar. Roedd y lefelau presenoldeb yn isel iawn, a oedd yn siomedig i'w weld. Gofynnodd MR os oes modd i'r Cynghorwyr wneud pob ymdrech i fynychu'r cyfarfod nesaf. Ymwelodd MR hefyd â'r stad newydd yn Harlech (Maes Meillion) drwy ei rôl yn Parc Eryri. Roedd Gwyndaf o Barc Eryri wedi canmol CTP am eu noson agorad/sesiwn galw mewn yn y Neuadd Drefol yn gynharach yn y flwyddyn. Fynychodd MR wasanaeth Sul y Cofio yn Eglwys y Drindod Sanctaidd, lle darllenodd hi enwau'r milwyr a fu farw yn ystod y rhyfel byd cyntaf/ *MR recently attended the One Voice Wales annual meeting. The attendance levels were very low which was disappointing to see. MR asked if every effort could be made by the Councillors to attend the next meeting. MR also visited the new estate in Harlech (Maes Meillion) through her role in Parc Eryri. Gwyndaf from Parc Eryri had praised CTP for their opening evening/drop-in session in the Neuadd Drefol earlier in the year. MR attended the remembrance sunday service at the Holy Trinity Church where she read out the names of the soldiers who had died during the first world war.*
