457-2015 - Planning applications for consideration:

Planning application no: 15/P/01595 - Koning, Clay Lane, Jacobs Well, Guildford, GU4 7PF - Erection of a single storey rear addition. Creation of a first floor habitable space including three dormer windows to the front and flat roof dormer to the rear. Proposed detached garage following demolition of existing garage.

Comment: Loss of yet another small dwelling from the current housing stock.

Planning Application No: 15/P/01635 - 85 Oak Hill, Wood Street Village, Guildford, GU3 3DA - Construction of a single storey side and rear infill extension.
