#### Setting the Scene

- Government Austerity Measures
- Major Reduction in Public Sector Funding
- Reductions in County and Borough Council Grants
- 'New Big Society' whatever happened to that?
- 'Old Big Society' Town and Parish Councils have been doing it for years!

#### **Austerity Measures**

- County Council reductions over the past 5 years:
  - ❖ 2011/12 £61m
  - ❖ 2012/13 £66m
  - ❖ 2013/14 £62m
  - ❖ 2014/15 £69m
  - ❖ 2015/16 Anticipated savings of £90m need to be made
- Surrey PCC 2015/16 Savings required £22m
- Guildford Borough Council Savings of £7m By 2017 GBC will have lost all of its Government Revenue Support Grant and the small element of business rate income will also start to reduce

### The impact on County and Borough Councils

- No longer able to provide 'Discretionary Services' in a way that Communities expect
- Statutory services being reviewed
- The impact of the cuts is now impacting across the board:
  - Community Buildings
  - Leisure Services
  - **Bus Subsidies**
  - Library Services
  - Youth Service
  - Highway Maintenance

## Opportunity for Local Councils to provide services for its local community

- Democratically Elected
- Community Leaders
- Facilitators
- Deliverers of Services

#### Questions

- ❖ Is our Business Plan appropriate to meet the communities expectations?
- Should we take over the delivery of more services?
- Should we take over assets, or are they simply liabilities?
- What do you, the Community, want us to do?
- Would you be willing to pay yet more tax to the Parish Council for additional services?

#### Precept 2016/17

- Increased by 29% or £13.01 per Band D property
- Various expert advice/opinions will be required to contest the Draft Local Plan
- Legal advice, once freely available to the Parish Council now costs £240 per hour
- Increased assets have to be maintained
- Increased staff hours
- Need for a dedicated parish office/meeting room

#### Work of the Parish Council

- The work of the Parish Council has increased significantly over the years. Central Government frequently makes changes to the law governing town and parish councils. The latest act to make a considerable impact on the Parish Council is the Localism Act 2011.
- In addition to the routine work, the Parish Council also carries out a wide range of projects and events on behalf of the local community.


