<p>4</p>	<p><u>Maintenance and Protection of Cromarty Links</u></p> <p>Sheila Currie was invited to the meeting to share her observations on the management and protection of the Links (Minutes 29.6.2015, 14.3). She feels this area is one of the most important assets to the Community and is also Nature's own coastal defence for the Town (other parts of Cromarty's coast have sea walls and armouring in place). The danger of cutting grass close to the edge of the beach and preventing a natural build of of stones and debris may allow more damage and erosion to occur. It was therefor suggested to:</p> <ul style="list-style-type: none"> • Allow vegetation along the edge of the beach to grow naturally • Plant maram grass • Cut access paths through the long grass to the beach, to be in different points each year • Maintain a clean edge between the short cut grass and naturalised growth so that it is a controlled and neat system • Erect small temporary signs along the grass edge at the beginning of next season to remind contractors and inform the community about the demarcation. <p>Members agreed with these proposals outlined. VP will put information on the CC notice board. CF will contact Sam Lowe at HC to inform contractors. EQ will speak with Links residents and CF & Sheila will continue to liaise. 5	<p><u>Cromarty Care Project</u></p> <p>Apologies were sent from Jill Stoner, so Nigel Shapcott, representing Cromarty Care Project (CCP) reported on matters relating to a resilient town:</p> <ul style="list-style-type: none"> the snow plough was not currently being maintained. An email would go to HC regarding this. Defibrillators (Minutes 29.6.2015, 14.1) - Nigel has approached the British Heart Foundation who can offer grant aid of up to two thirds of the cost of each defibrillator which would leave a shortfall of £400 per unit. (Three defibrillators have been suggested for Cromarty, to be located at the Hugh Miller Institute, the Victoria Hall and the Harbour). VP has sourced a possible good deal on the cabinets and will follow up. The C&DCC is unable to fund this shortfall at present but DA suggested the Fire Service may offer support through their initiatives. DB will contact Highland Area Manager, Scott Hay. DB will also contact the Cromarty Medical Practise and Highlife Highland. Nigel will send information to DB. Following an application, The Cromarty Care project has been awarded £9000 by the SHEPD Resilient Communities Fund (Minutes 27.7.2105, 11a) to meet the costs of making the Victoria Hall an Emergency Centre. Duncan Bowers has been approached to assist with the drawing up of an Emergency Plan which is a condition of the grant. Agenda Item 10 - Victoria Hall Report

1. Continued strong bookings. Changeover to invoicing through the new Treasurer is going well. Pleased to announce that Eden Court has chosen the Victoria Hall to be a venue for performances of one of their productions, touring the Highlands. They are performing the play 'Not About Heroes' (based on the works and real-life relationship of Wilfred Owen and Siegfried Sassoon) on Friday 23rd October.

Youth Café Report - August 2015

Activities for April to August 2015

Junior Youth Café

Cromarty Junior Youth Café is very busy on a Monday night with up to 26 young people attending each week. Junior Youth Café has been very busy with a range of activities being provided, such as, Arts & Crafts, Multi sports, Dodgeball, Badminton, Football, Hockey, Circle Games, Ruby, Running races, Tennis, Mini Football, working on the Representing Cromarty project and Free Style Football

Rugby and football with Youth Coaches that are taking part in Saltire award. All the Juniors really enjoy working with Matty & Angus, the boys teach the Junior different skills for football and rugby.

Nerf Wars

There were over 30 young people taking part in this session with EQ sports in the Victoria Park. All of the young people that took part in this session had great fun.

Senior Youth Café

Each week the young people turn up to the Senior Youth Café and take part in a range of activities such as, PS4 or Xbox Night, Badminton, Football, Baking & Cooking.

Wanda's Diamond Divas

Around 10 young people have been attending weekly, taking part in learning new routines with Libby from Eden Court. All of the group are having great fun taking part in the class.

This project was able to still run as the group received funding from the Highland Youth Arts Hub. Dancing ended in June with Libby but dancing with Antonia is going to start after the Summer Holidays.

Cromarty Cookwell Project

Vicky is now running the cooking class for the Seniors on a Monday night. Eight seniors each week with a good mix of both boys and girls. Cookwell is about enabling young people to cook on a budget and make quick but healthy meals, each week they make 4 different courses, a Bread, Starter, Main Course & a Dessert. This class is to help increase confidence and social skills, learning the basics about cooking from what different measurements are, to cooking the food completely. The food that the group are producing is amazing. And being able to try different food and deciding as a group the menu for the following week.

The Cookwell class will provide the baking for the Representing Cromarty exhibition opening. In September the class is going to be providing the refreshments for the Royal Marine Band who are playing at the Remembering the Natal Commemoration.

Employability

Highland Council have been working with 2 young people from Cromarty, helping them to build CVs, apply for jobs and how to present themselves at interview. This has now ended as Gareth has moved onto another job.

Cromarty Chanter Class

All of the pipers are coming on really well. Father Mel is really impressed with the group and how well they are all coming on.

Kung Fu Class

In April and June there was a Kung Ku class provided for young people this class was to enable young people to learn about self-defence and discipline. All of the young people who attended the classes really enjoyed them.

Sailing

The sailing project with Simon has started again, sometimes we were not able to sail due to the weather but Simon would provide an alternative option either canoeing or Kayaking. All of the young people are really enjoying this opportunity.

Summer Programme

During the Summer holidays there was a range of activities provided for young people:

Tennis Coaching

In April, May & June on a Saturday there was tennis coaching provided from a Coaching from the Inverness Tennis club.

Each week the young people were improving their tennis skills and were really enjoying the session. There is going to be more coaching starting again in September.

Tennis Camp & Tournament

For one week in July there was a tennis camp provided for young people. All of the young people really enjoyed this experience and on the final day there was Tournament for all the young people to take part in.

Special thanks go to Vicky Benjamin for organising this week and Jana Brady for providing the coaching.

Dancing with Antonia Dicarlo

Over 30 young people took part in a Break Dancing class with Antonia. Antonia was amazed at the talent in Cromarty.

Representing Cromarty Project

This project is about connecting Cromarty with other rural communities over the UK.

In May Issie the project coordination worked with the Youth Café.

All of the young people are able to draw what their views on Cromarty were and then were filmed describing their pictures. They were also shown how to work video cameras.

All of this work went into an exhibition in Cromarty and all of the work from the young people was absolutely fantastic.
