Draft minutes of ordinary general meeting of the Parish Council held on Wednesday August 6th, 2025, in the Playing Field Pavilion at 7.30p.m.

Present: Councillors Bailey (RB), Harpham (NH), Peel (AP), Alex Taylor (AT), Fiona Taylor (FT), Rachel Williams (RlW) and Richard Williams (RdW). Councillor Christine Ware (CW, WNC). Jonathan Ward-Langman (Clerk, JBW-L).

25.08.01 - Apologies: there were none.

25.08.02 - the minutes of the Ordinary General Meeting of the Council held on Wednesday June 4^{th} , 2025, were approved as a true record (*Proposed AT*, seconded *RIW*)

25.08.03 - Matters arising: the Clerk reported that there is a water meter for the cemetery that should be regularly read. RB offered to do this. *Action RB*.

25.08.04 - Open forum: no members of the public present.

- CW reported on the 'DOGE' initiative to find savings being implemented by new WNC administration and the current budget position.
- CW confirmed that the decision of the new WNC administration to scrap local Net Zero targets had been 'called in' for review.
- CW reported that the 59/60 bus service is now running on Saturdays as well as Tuesdays and Fridays.
