**23.6.1 - Apologies:** Cllr Harpham – Family commitment – unanimously approved.

**Damaged drain:** Bridle Way – Highways have confirmed ownership and scheduled repair within 26weeks. The Clerk has advised Cllr Kevin Parker of the Open gardens event which uses this access for parking, Cllr Parker is liaising with Highways.

**Bus Shelter:** Access is required through a residents property to assess the damage, **the Chairman** will liaise with the resident regarding access.

**Cemetery Wall:** Damage to the top of the Cemetery wall was reported to the chairman approx. 8am 17<sup>th</sup> May 2023 along with a report of a loud noise believed to be the impact. CCTV has been provided by two residents of a farm vehicle passing through the village at that time. **The clerk has** shared the CCTV images to locate the owner of the vehicle, discussions ongoing.
