10/038f Proposals for the Budget and Precept for 2011/12

Following the last Finance meeting and proposed budget, which had been circulated with the minutes, it was resolved to amend the budget to increase the income by £2,500 for the cleaning costs, paid for by the Community Centre (this expenditure had been included in the Community Centre's budget).
