10/1143 Defibrillator and Equipment for Brixworth First Responder Group

The Clerk reported that she had met with the paramedic who is leading the Brixworth First Response Group (BFRG) and he has asked for the Parish Council to purchase the defibrillator and associated equipment on their behalf. The BFRG currently has seven trained members, with six more volunteers waiting to be trained. The group is hoping to provide assistance to red light emergency calls, within the parish, 7 days a week from 7am - 10pm

It was resolved to purchase the equipment at a cost of £1,482.56 (including VAT), under the Local Government Act 1972 S137. The equipment is to be donated to the group; any future maintenance and insurance will be the group's responsibility.

It was agreed for the First Responder Group to use the Community Centre for the training courses free of charge. It was suggested that the group and donation of the equipment by the Council is included in the next newsletter.

10/1145 External Auditor's Report Year End 31 March 2010

The Clerk reported that she had received the notification of the conclusion of the Audit for the year ending 31 March 2010, from BDO Stoy Hayward the External Auditors. There were no matters arising from the Annual Return. However there was one issue raised which needs to be addressed, which was once again the current level of the Council's Fidelity Guarantee Insurance. It was noted that the Council had increased the Fidelity Guarantee Insurance level to £150,000 this year. This level will be reviewed at the next Finance Committee Meeting.

The Council approved and accepted the Annual Return. The Notice of Conclusion of Audit is to be displayed for fourteen days on the notice board.

The Council thanked and congratulated the Clerk for her work throughout the year, which has resulted in the auditors having no matters arising in the annual return.

10/1146 Training Courses

It was retrospectively approved for Cllr Lacey to attend the Negotiation Training course on the 21 September 2010 and resolved for the Clerk to attend the Archiving Course on the 18 December 2010.

10/1147 District Council

Cllr F Wiig reported that cuts to services are to be discussed at the spending review meeting in October. Back office services will be looked at before front line services.

Recreation and Amenities Development

10/1148 To Accept Minutes of Meeting 21 September 2010

The Minutes of the Committee Meeting held on the 21 September 2010 having been previously distributed were accepted.

10/1149 Pytchley Close Gate on Spratton Road Recreation Ground

The Recreation Committee recommended the removal of the gate on the recreation ground to Pytchley Close, following the annual and quarterly inspection, which stated that there is a risk of a finger entrapment. The Council had received two emails from residents in the Close who requested that the gate remained in situ and outlined their reasons why. It was noted that the Council has had no reported accidents involving this gate. Following a discussion it was resolved that the gate is to remain and this matter to be referred back to the committee to determine whether it could be modified to mitigate the risk.

10/1150 Dog Fouling

The Council had received details, from the Brixworth Youth Foundation, about their Awards for All big Lottery Fund Environmental Project, which is to look at the subject of dog fouling. The young people wish to present their findings to the Council and have a display in the Brixworth Library/Community Centre foyer, Moulton School, Guildhall and Northampton Library. The Council congratulated the young people and look forward to receiving the presentation.

Following a discussion it was agreed to include this matter in the next Newsletter. It was noted that the DDC information centre, would no longer be providing free dogfouling bags to residents. It was therefore agreed for the Highways Committee to

consider the Parish Council purchasing dog fouling bags, for the DDC office to distribute.

10/1151 Annual Maintenance of Gang Mowers

It was resolved for Mower Repair Shop to carry out the Annual Maintenance of the Gang Mowers at a cost of £479.25 plus delivery and spares as required.

Highways and Environment

10/1152 Repairs to Pound Stonewall and Market Cross

It was resolved for J Marks to carry out the repairs to the Pound stonewall and the Market Cross at a cost of £350.00. English Heritage is to approve the work to the Market Cross, which is a listed monument, before work commences.

Correspondence for discussion

10/1153 Letter - Merry Tom Folk Festival 2011

Members of the Merry Tom Folk Festival were present at the meeting to inform the Council of their plans, for the Merry Tom Folk Festival, which is to be held at Brixworth Country Park in July 2011. It is a new venture and any profits will be ploughed back into future events as well as donating to local communities. The group is initially looking for funding from various sources, including the Parish Council. The Chairman explained the Council's Grant Application process. There is a preliminary meeting at the Country Park on 2 October 2010.

10/1154 DDC Affordable Housing Training Session 1 October 2010

Cllr Bament and Cllr Pointer are to attend this training session.

10/1155 DDC - Parish Council Representative on Standards Committee

It was noted that there is a vacancy for a Parish Council Representative on the District Council's Standards Committee.

10/1156 NCC - Consultation on Concessionary Travel

A letter had been received from the County Council (copy circulated to members), consulting Local Council's on the proposed changes to concessionary travel throughout the County. Following a discussion and vote it was resolved for the Parish Council to reply in support of the recommendations in general, however is concerned that it discriminates the rural community. Many villages only have a very limited bus service and therefore an eligible person is not always able to take advantage of this service due to the timetabling.

10/1157 NCC – Emergency Planning Conference 7 October 2010

Cllr Bament agreed to attend the County Council's Emergency Planning Conference in Thrapston on 7 October 2010.

10/1158 CWU – Impact on Community under Plans to Privatise Royal Mail

An email had been received from the Communications Workers Union, concerned about the impact on communities if the Royal Mail was privatised. This was noted.

10/1159 Remembrance Parade

The Chairman agreed to attend the Remembrance Parade to place the Council's wreath. Following a lengthy discussion it was agreed for the Clerk to contact the Vicar to discuss the arrangements for the Youth Groups.

10/1160 Correspondence for information only

The Chairman reported that the correspondence file was available for circulation.

10/1161 Date of Next Meetings

The next Full Council Meeting is to be held on 19 October 2010 in the Community Hall, Library/Community Centre. The November meeting will be held on 23 November 2010. Both of these dates have been brought forward from the scheduled date.

The Chairman reported that he had received an email from a resident concerned about the new opening times of the recycling centre. In addition he had been told that he would be limited to two loads of DIY waste every two months.
