10/1214 Brixworth Youth Club presentation on Dog Fouling

Mr Kitchener, a Youth Worker gave an introduction to the project. The Youth Club has received £10,000 from the Big Lottery to fund a project relating to dog fouling and the problems it causes when dog owners do not clear up after their pet. They implemented a questionnaire on peoples encounters with dog faeces, researched facts relating to ownership and diseases and visited Salcey Forest, Brixworth Country Park, Crowfields Common and Sywell Country Park to carry out there research. The Young People had produced a display of their work, which will be on display in the Brixworth Library foyer, Moulton Secondary School, Northampton Library and Guildhall. The group will now make a short documentary on dangers of dog faeces and provide DVDs for schools PHSE lessons.

Mr Knight suggested that the Parish Council might wish to consider a Dog Control Order, which covers areas such as fouling, dogs on leads, dangerous dogs and areas of land which dogs are banned (ie play areas). Mr Knight will contact the Clerk with the details.

10/1215 Parish Councillor Resignation

10/1230 To Accept Minutes of Meeting 16 November 2010

10/1231 Entrance - The Ashway/Eastfield Road Footpath

Cllr Pointer suggested that the Parish Council should look at the two informal entrances to the Ashway Playing Field and make one formal and close the other one off. It was agreed for members to look at both of these entrances and for the Clerk to obtain quotes in order for the Council to make an informed decision.

10/1232 New Fencing around Cricket Square on St David's Recreation Ground Following a discussion it was resolved to allow the cricket club to replace the post and rope fence around the cricket square, with a green mesh type fence, to prevent people from damaging the ground. The fence is to be reviewed by the Parish Council after a six-month trial period. The Cricket Club would be responsible for the installation and maintenance of the fence.
