11/1259 Signing of the Minutes of the Last Meeting 24 May 2011

The minutes of the last meeting held on 24 May 2011 was signed by the Chairman as a true and correct record of this meeting.

11/1260 Public Open Forum

Mrs Ames, Chairman of the Brixworth Youth Foundation referred to their grant application, which the Council was to consider later on in the evening. Their landlord had agreed to reduce the rent for the Youth Clubs premises, which meant that the Youth Club might be able to continue. The Chairman brought this item forward for consideration.

Mrs Barber, Brixworth Library Supervisor referred to the Library Review consultation document, which the Council was to consider later. This item was also brought forward.

11/1261 Grant Application from Brixworth Youth Foundation £5,000

A grant application had been received from the Brixworth Youth Foundation for £5000. It was noted that there is £5,000 in the budget for the Brixworth Youth Foundation. Members read the application and following a vote it was resolved to provide a grant of £2,500 now under S19 of the Local Government (Miscellaneous Provisions) Act 1976 and for the situation is to be reviewed later on in the year. It was suggested that the group applies for a further £2,500 at the November Grants meeting.

11/1262 NCC Library Review Stakeholder Consultation

Mrs Barber gave a brief introduction to the consultation document. The Library Service does not wish to close libraries, but is looking at ways libraries can earn extract income. By 2015 libraries will need to find 50% of its funding from the community. In addition each library has a Friends group who need to raise money (total £40,000 over 36 libraries). The proposed

plan for Brixworth is to utilise the upper level above the library, by finding a business or enterprise partner.

It was agreed for members to have a look at the consultation and to defer this to the next Full Council meeting.

Unfortunately Cathrine Russell and Beth Milne were unable to attend the meeting.

10/1264 Co-option of Parish Councillors

The Council had two applicants applying for the Parish Councillor vacancies. Unfortunately only one applicant was present at the meeting.

Both applicants had sent details to the Council (a copy of which had been previously circulated to all members), giving brief information about themselves and why they would like to be a Parish Councillor. Mr Kevin Parker briefly introduced himself. It was resolved for Mr Parker to be co-opted to the Parish Council.
