In the absence of the Chairman and Vice Chair, Cllr Barratt was duly elected to Chair the meeting.

11/1292 Apologies for absence

Apologies were accepted from Cllr M Lacey, Cllr R Monk and Cllr K Parker.

Apologies had been received from Sgt Grady and PCSO Hillery.

11/1293 Declaration of Interest on Agenda Items

Cllr E Wiig declared a personal interest – Member of another Local Authority and Member of the District Council Planning Committee

11/1294 Signing of the Minutes of the Last Meeting 28 June 2011

The minutes of the last meeting held on 28 June 2011 was signed by the Chairman as a true and correct record of this meeting.

11/1295 Public Open Forum

A resident raised his concerns with regards to the shopkeepers, in Hunters Way, increasing use of providing shoppers with plastic bags. It was agreed to write to the shopkeepers to encourage the practice of having a 'plastic bag free Brixworth'.

Mr Chattaway, Chairman of BRANE reported that the District Council had received the planning application for the 150 houses off Northampton Road, but it had not yet been registered. So far BRANE has 2,750 signatories on the petition, which is opposed to development outside the village boundary. A planning application for 14 houses off Eaglehurst, on Ilmor's Car Park, had been submitted and registered. Barratts are interested in developing the land between the David Wilson homes and the allotments off Northampton Road.
