11/1450 Apologies for absence

11/1454 Public Open Forum

11/1455 Police Representative Report

The Clerk read out the latest crimes reported, which she had received from PCSO J Hillery: -

The precept request for 2011/12 (current year) is £97,710. This proposal for 2012/13 (next year) of £97,005 is a decrease of 0.72%. This means that the Council Tax Band "D" equivalent would be £48.50 based on 2011/12 Tax Band of £52.58, however this figure is likely to be slightly more due to the Tax Base decreasing. (Tax Base 2011/12 1,858.41).
