A safe route to the Country Park imminent?

When the bypass was opened it provided much needed relief to Brixworth, it also cut the village off from the Country Park. Ever since then there have been calls for a footbridge over it to provide a safe route from Brixworth to the Country Park.

At last Northamptonshire County Council are moving towards starting its construction. Richard Hall, Principal Officer, said "MGWSP are carrying out the initial studies, including preliminary design, at the moment. I expect an update soon with some costs. At the moment it is still on track for construction in the next financial year, subject to it not costing too much."

The Parish Council has been instrumental in moving this project forward by organising a count of people using this route.

We understand that consultation on the designs will take place over this winter.

The Parish Council's role in the planning process explained

The Parish Council (PC) is consulted by Daventry District Council (DDC) whenever a planning application is submitted within Brixworth and, often, on significant developments in nearby villages. However, DDC is the decision making authority.

Commercial developers are encouraged by the planners to consult the community before submitting an application. DDC Planning Officers are obliged to post notices on or close to any site giving details of an application and the duration of the consultation period. Normally they also notify immediate neighbours by letter.

The PC posts statutory notices of all its meetings, including Committee meetings three clear days beforehand on the notice boards in the entrance to the Library and in the shoppers car park in Spratton Road. Applicants are invited to attend PC Planning Committee meetings to answer any questions that Councillors may wish to ask. Members of the public are always welcome to attend and may be invited to speak. should they wish to do so. The PC cannot undertake to notify people individually who have views on an application, this is the duty of DDC. However, if you write to DDC to object or support, an application please send a copy of your letter to the Clerk of the PC who will advise you if the PC is still to consider its own response.

Help stop doorstep crime
