10/052p DA/2010/0276 Mr Oliver, Rumwood, Hall Park, Brixworth demolition of existing dwelling & erection of two new dwellings:

Following a site meeting on 21 April attended by Cllrs C Bament, I Barratt, B Chattaway, Mrs A Gunnett, M Lacey & S Pointer it was decided to object to this application on the following grounds:

The Parish Council objects to this application because:

- Planning advice given on the government's direct.gov.uk website also states: 'Your council has the power to require a very high standard of design which is sympathetic to the existing environment. New development must make a positive contribution to the character of the area. In view of this, your council can require additional information in support of any planning application showing how the proposal will relate to the conservation area.' The only case for the demolition of the bungalow and its replacement by two houses seems to be an assertion that a precedent has been set by the Inspectors decision to allow a new house to built in the grounds of the property on the opposite side of the road (which is not in the Conservation area).

- The existing property is well screened by trees and hedges which are well established and which, regardless of type, enhance the street scene and the setting of the Conservation Area. Again DDC's advice quoted above refers to this and the government's direct.gov.uk (Home & Community) website states 'Their surroundings and general environment are often of equal importance and conservation areas are intended to protect that environment. We have a responsibility to ensure that the character of these areas is not diminished in our lifetime....
- The Village Design Statement refers to the 'richly wooded gardens of houses built in the grounds of the Hall Park' and in the opinion of the Parish Council such screens should be preserved or replaced with suitable trees which will continue to give this effect immediately after any removal.
- It appears from drawing no 4128/SK23 A that the rooflines of the houses proposed will be approx. 5 metres higher than the existing bungalow and 3 metres higher than neighbouring bungalow, The Sycamores. The new houses will be no more than 3 metres apart. Quoting advice from the direct.gov.uk website again 'It is important that all new development should be sympathetic to the special architectural and aesthetic qualities of the area, particularly in terms of scale, design, materials and space between buildings.' This advice has clearly not been heeded.
