The committee endorsed the previous comments made, and would like to refer to the Saved Policies from the Daventry District Local Plan [June 1997] Saved 28th September 2007 Reference Policy EM17 5.48 Which apply to a site less than one mile from the Old Station Yard site, ;- the three roads leading to the site are Class C Minor roads, two of which pass through the

Conservation areas of Creaton and Brixworth, and are unsuitable for heavy traffic. House No 9 is sited behind and overlooks the gardens of the existing houses reducing their privacy.
