82 Chairman's Address

The Chair welcomed the councillors and the public. The schedule of the meeting has been slightly changed, bringing the Planning Report higher up the Agenda, before the Public Participation.

83. The Minutes of the HPC Meeting dated 1st September 2016, having been previously distributed, were passed by the council. Proposed by Jean Peacock and Seconded by Graham Wylie.

84. Matters Arising

No items arising, all items will be covered in the reports.

85. Highways Report

Highways Report for September 2016

 Brenda Bowles (Highways Engineer for DBC) has confirmed the Spar parking spaces will not proceed due to the scheme being unenforceable and residents' concerns.

- **30mph repeater signs** not permitted by DBC. Would support variable message signs.
- Another school keep clear marking will go on Roundhill Road next batch of works are due.
- **Highways Inspector** performed site visit to house on Roundhill Road undergoing significant works near school crossing to advise contractors.
- If funding becomes available, **Safer Routes for Schools** will be a priority outside the Primary School.
- **Arboricultural Officer** has received details of trees shrouding lights in the village. Work actioned.
- **Arriva** Parishioners sent footage of bus mounting the pavement at speed when a young person was on that pavement. John Rochford from Arriva has dealt with this matter and intends addressing HPC to reassure our residents.
- Ron Hogg messages left at Country Fair re Speeding. Still awaiting contact.
- Taxis on Westfield Drive another complaint has been made by The Priory School to a Middleborough company whose taxi mounted both pavements either side whilst doing a three-point-turn on 4:10:16
- **Priory Staff now operate a car share scheme** to help reduce congestion on Westfield Drive.

The following matters have not yet been resolved and require follow up with DBC.

- The sign at the top of the bank coming from Croft, just past the bridge is non-existent and looks like a national speed sign. This needs a 30mph sign, or taken down.
- The path wasn't re-surfaced for all of Strait Lane. The residents would like to know why in front of the terraced houses to the Otter and Fish this area has not been re-surfaced?

There has been no response to the wheelie-bin letters, and it was concluded that there were no objections.

Graham Wylie presented the traffic details for the month of September, viz:-

86. Planning Report

The Chair stated that it is important for the council to make a decision on whether or not to raise a formal objection for the Application to build up to 100 houses on Roundhill Road. The recent drop-in session and resident sentiment have highlighted a number of significant objections and concerns.

A motion was tabled by Wilma Campbell and Seconded by Paul Walters that a formal objection should be submitted, the content of which will be determined at the Special Meeting scheduled for 11th October. A vote was taken and the motion carried by 10 votes in favour, and one abstention.

The Chair confirmed that a Special Meeting has been convened, at which the public can attend, but open forum will be limited to thirty minutes and in accordance with the council's standard procedures.

The council expressed disappointment that there has been no response from David Coates DBC Head of Planning on several pressing topics. It was agreed that a meeting with him should be arranged. **Action Clerk to arrange.**

87. Public Participation

A resident asked for an update on the Super Broadband status for Hurworth. Cllr Joe Kelley responded that he is stringently following this up, but no real progress or commitments have been made. It appears that although there is a pledge for 95 percent of the country to get the service, Hurworth appears to not be specifically included. Parts of Hurworth have the service, while others do not, which appears to be an enigma. Cllr Kelley stated that further funding for rural areas will be coming, although the dates are not yet stipulated.

89. Financial Report to 31st August 2016

The Financial report having been previously distributed to all councillors was presented at the meeting. There being no questions, the Report was accepted by the council.

- The external audit for 2015-16 has been completed, and the final documents received, and hence their account will be paid now.
- The Litter Picker Refund claim has been accepted and the refund received.

90. Matters of Interest

a. Dog Fouling Competition

Carol Paylor reported that 'Little Acorns' nursery, Hurworth Primary School and the Priory School all submitted entries. Posters were of a very high standard. Five winners were selected. Their posters are to be displayed around the village.

Action: Obtain quotations for the sticker posters.

Mrs Madison, Head of School from Hurworth Primary, has requested an article for the school newsletter; an article has been submitted to the Parish Newsletter too.

b. Equality

Elaine Hedley requested that the council adhere to the request from CDLAC that support be given to a motion which will be tabled at the CDLAC AGM on 22nd October, the following motion was tabled:-

We are proud to live in a diverse and tolerant society, Racism, xenphobia, homophobia, religion intolerance and hate crimes have no place in our country. County Durham Association of Local Councils condemns all such intolerance and hate crimes unequivocally.

We will not allow hate to become acceptable and will work with the Police and Crime Commissioner and others to fight prejudice and hate crimes.

We reassure all people living in the area that they are valued members of our communities

The meeting voted unanimously to support this undertaking, and will vote at the AGM accordingly.

c. Web Drop Box

David Wood reported that the trial month has attracted a number of messages, the contents and supervision of the comments is being made, to ensure no unacceptable messages are put into the public domain.

The concept is proving to be successful, and could become a good addition to the transparency and interaction policies of the council.

d. Drop-in afternoon.

The public invitation to meet councillors and obtain information about the application to build up to 100 houses on Roundhill Road was well supported with about forty residents taking the opportunity to talk to councillors in an informal afternoon session.

- e. The Chair read out a letter informing the council that the memorial at All Saints Church is now a Grade 2 structure under the Historic Heritage organisation.
- f. An anonymous letter has been received highlighting the number of caravans and dormobiles which are permanently parked in residents driveways. These block out light and are often not welcomed by their neighbours, Can the council do anything to improve this situation? The council agreed to check into a property deed in one to the streets named. However, this is a personal matter rather than a council affair.

g. Priory Hurworth House School

Carol Paylor gave a report about the latest meeting with Priory School, for which we have now received the Minutes.

The school is continuing to co-operate with the council in addressing parking and behavioural concerns. The new junior section which started in September will have up to 12 students, and will operate in the main building at the front facing the Green. Taxi sharing for some areas is now in place, and this has reduced the traffic flow. Supervision of students at the gates during period breaks is now operational, and this will improve neighbour interactions.

The school reiterated their keenness to work with the parish council on joint community projects, and to try to further integrate with the community. They will

be offering IT classes at the school, using the school's equipment, and encourage residents to attend.

Priory has stated that they have no plans for selling their playing field and acknowledge that HPC has the first option should this position change. They will be pleased to pursue ideas to use the field for allotments, a wild flower meadow, or other community activities.

The school will be holding a Coffee Morning on 11th November, and all are invited. The staff will be holding a party near Christmas at the Mustard Tree and residents are welcome to join in.

The school would welcome any volunteers, who have a skill in any topic, to participate in mentoring sessions with students at the school.

The chair asked if Carol would become the Priory School liaison representative, and she agreed to take on this important role.

91. Planning Development Working Group Report

David Wood reported that the Group would be meeting in October, and that volunteers to join the Neighbourhood Planning team are being sought and encouraged.

92. Tree Report

Peter Foster reported that the tree survey for the trees on the Village Green area has now been completed and the report is in the Parish Office. We underlined the importance of the surveys, as ensured planned maintenance and should avoid emergency actions and danger to the public.

The designated work on the Green, to trim the growth at ground level and to heighten the canopies to allow vehicles to pass unhindered has been completed. Some residents have thanked the council for the work that has been carried out.

The very large tree in Goblin Wood is still a danger, which is being watched carefully. Cllr Foster recommends that the tree is reduced by removing one huge branch, which constitutes about half of the tree. This will be an expensive operation, as the road will need to be closed while the work takes place and the branches removed. Action HPC to discuss this with DBC to see what assistance DBC will give.

The two dead trees at Manorfield still remain, and DBC has not responded to our requests.

All the other trees appear to be in sound condition.

92. Parish Pathways

Richard Lawley reported that a meeting has taken place with Malcolm

Thompson (DBC Countryside) to discuss the condition of the defined paths. This had been productive, and Mr Thompson has undertaken a number of actions, which include:-

• Stiles are the responsibility of the landowners, and Malcolm agreed to talk to the landowners where repairs or replacement to the stiles is required.

- The walk around Geneva Woods has been reported as blocked, and Malcolm will investigate and apply action to re-open it.
- The stile at the Christadelphian Church will be replaced. This has already been done recently
- The stile on the path which exits near Eurojag is too near the main road and needs to be moved back.

Malcolm informed the council that DBC are offering grants for the installation of Kissing Gates, and he encourages us to take advantage of this. He has suggested a kissing gate at the rear of Hurworth Grange.

93. Open Spaces report

Wilma Campbell gave her monthly report:-

Open Spaces

Centenary Field

A meeting with Jamie Leeson, Development Officer for Fields in Trust, was due to take place on Tuesday 3rd October, but unfortunately his plans changed. We are waiting for him to send us his availability to reschedule.

Open Spaces

Open spaces audit is ongoing.

Hedges have been trimmed around Westfield Drive.

Overhanging branches have been cut back and undergrowth sprayed with herbicide on the public footpath at Minster Walk.

Strait Lane allotment grass has been cut.

Bulb planting around the village should start within the next few weeks. Suggestions from residents for possible planting sites and help with actual planting would be welcomed and appreciated.

Mr Peter Richardson, from the public gallery expressed his thanks to

David Parker, for his work in Hurworth parish.

94. Project Reports

a. Notice Boards

Paul Walters reported that the final price for the three notice boards has been negotiated; the units will be imported from France.

We are still waiting for a response from DBC regarding planning permission requirements. In order to expedite this, we intend to arrange a meeting with Dave Coates, **Head of DBC Planning Dept.**

b. Margaret Williams reported that work has started on broadening the Grange entrance, and the project should be finished by this month end.

95. Allotments Report

Richard Lawley reported as follows:-

There are seven people on the Strait Lane Waiting List, dating back to June 2016, and seven people on the Grange Waiting List, dating back to 2013.

No problems reported from either site.

The water will be turned off at both sites on 30th October.

A skip has been ordered for Strait Lane on Friday, 28th October.

The AGM will be arranged for a date in November.

96. Association Reports

Peter Foster reported that when he attended the CDALC Executive Meeting last month, Hurworth Parish Council was praised for achieving the Gold Award. Three other local councils have now achieved Foundation Level.
