26.00/09: Matters of Information

26.01/09: Cllr. P.Allen gave an upto date report in respect of the Parish Plan. He advised that he along with Mr. J.Buxton had met with the owners of the Rockliffe Hall project and had a very fruitful meeting. The owners had agreed to approach colleagues to underwrite the full costs of the Parish Plan. He also advised they had kindly agreed to undertake the drainage of the land adjacent to The Grange, and this had started on the 12th February.

26.03/09 Response from Darlington Borough Council in regards to Councils query on the erection of stones on the village green to prevent parking. The Council that as long as it was seen as better enjoyment or protection of the village green then Council can do it. Letter received.

29.00/09 Presentation by Mr. J.Buxton on behalf of Nature Reserve

Mr. John Buxton on behalf of the Friends of the Community gave an upto date presentation on the nature reserve (copy of written report attached). He advised the total project costs will be £30,000 and they are confident the funding can be obtained. Insurance for the project has been arranged via the Parish Council, and paid for by the project. Cllr. K.Pattison advised the meeting a written report will be shortly distributed around the Parish beginning everyone upto speed with the project.

On behalf of the Council the Chairman thanked Mr. Buxton for his report and wished everyone involved well for the future.

The Council discussed a letter from Hurworth Community Association in regards to insurance and seeking reassurance that the nature project was covered. Agreed Clerk write back and advise the Community Association accordingly.

30.04/09 Croft House wall. A member of the public expressed concern at the safety aspect of the wall adjoining the public footpath. Agreed Clerk write to Yuill's and report the matter as dangerous and requesting urgent attention.
