2.00/10 Chairman's Remarks

The Chairman Cllr. I.Holme wished to place on record his thanks to all members, clerk and especially his Vice Chair Cllr Hepplewhite for all their support and assistance during his year. There had been many highlights over the year but perhaps the visit of HMS Hurworth and the Remembrance Day Service stood out.

3.00/10 Election of Chairman

Cllr. G.Hepplewhite was the only candidate nominated for the position of Chairman

Resolved: - To elect Cllr. G.Hepplewhite, as Chairman of Hurworth Parish Council for the 2009/10 municipal year.

Cllr. Hepplewhite then signed the declaration of acceptance of office. Cllr. Hepplewhite also at this point presented Cllr. I.Holme with a small gift of appreciation on behalf of the members of the Council.

4.00/10 Election of Vice Chairman

Cllr. C.Pratt was the only candidate nominated for the position of Vice Chairman

Resolved: - To elect Cllr. C.Pratt as Vice Chairman Hurworth Parish Council for the 2009/10 municipal year.

5.00/10 Police Report

PCSO J.Angus was welcomed to the meeting by the Chairman. He advised members of the following incidents that had taken place over the previous two months across the parish

- 1 incident of violence on the 1st May
- 4 Criminal damages, including damage to personal garages
- 3 burglaries of garages
- 6 incidents of Anti Social Behaviour
- 1 stolen vehicle
- 5 thefts in general.

He also responded to individual members concerns/queries, which included the following:-

- 1) Horses running loose on the highway. He advised that there had recently bee 6 calls to respond to such incidents. The difficulty had been identifying the owners. He also advised the RSPCA are involved.
- 2) In response to questions from members PCSO Angus advised he no longer had the use of a car and relied upon spare vehicles in the police compound, public transport and lifts. Several members expressed serious concern at this and the potential problems this situation can create.

Resolved: -

- 1) The Clerk to write to the Chief Constable and Chair of the Police Authority expressing grave concern in regards to the lack of transport for PCSO Angus
- 2) To write to the RSPCA and seek advise from them in regards to the Horse issue.

6.00/10 Civil Contingency Unit

The Chairman welcomed Clare Balmont and Graham Lane from the above unit who gave a presentation to the meeting on their plans for any future flooding incidents. The Unit are looking for volunteers to both act as local contact points for information distribution and to also assist them when any flooding takes place. Members suggested a future meting consider establishing a Flood Committee.

9.00/10 Matters of Information

9.01/10 Bus service: - Members expressed disappointment at the lack of response form Darlington Borough Council. It was agreed to write to Cllr. Lyonette and request a meeting with him as the relevant Cabinet member

9.02/10 The Chairman advised members of an e-mail received by both her and the Clerk in regards to the 2 houses at the entrance to Rockliffe Hall. The company have advised they will be used as training venues and office accommodation. The company advised parking should be resolved shortly. Cllr A. Gibson expressed his disappointment that this was not made clear at the planning application process as he had firmly believed they would be retained as residential accommodation.

9.03/10 The Clerk advised Officers from Darlington Borough Council are looking into the Parking issue and he suggested the matter be added to the proposed meeting with Cllr. Lyonette

9.04/10 Avon Court, the Clerk advised Officers from DBC had contacted him asking for exactly which streets on this estate/area did the Council wish to see drooped kerbs. It was the consensus of the meeting that all the streets in the vicinity needed dropped kerbs establishing.

9.05/10 Roundhill Road/Neasham entrance. Several members requested the Clerk write to the Borough Council and in particular to Cllr. Dunstone thank them for the excellent work that has been undertaken in regards to clearing up rubbish, debris and the improved brass cutting in these areas.

9.06/10 Lytch gates, Cllr. G.Lawman advised the gates have been repaired independent of intervention from Darlington Borough Council

9.07/10 Emerson Arms, Cllr Lawman tabled a letter he had received from Enterprise Inns and also a response from Darlington Borough Council advising on their policy in regards to cigarette related litter. Both items were received.

The Clerk advised the meeting that he had been approached by members asking for clarification on who was undertaking the collation of the results. Darlington Borough Council was approached at the start of the project and they agreed to undertake the task free of charge. Cllr. P.Allan confirmed the Clerks report. It was also noted that once the Parish Plan is finished it will need to be adopted by the Parish Council and a formal Committee to implement it established. It was agreed to elect this Committee in July.

He advised members to defer any decision on this and the Gypsy site meeting, which also only arrived that morning to a special meeting.
