27.00/10 Chairman's Remarks

The Chairman referred to the following matters:-

- a) A situation has occurred recently involving 2 members of the Council and the exchange of a series of e-mails. The clerk has tried to resolve the situation through mediation and offered to set up a meeting between all interested parties, but this has failed. Cllr. K.Pattison one of the members involved is unable to attend the meeting due to holidays has authorised the Chairman on his behalf to offer an apology to Cllr. I. White for any upset his e-mails have caused. The Chairman advised the meeting that in the circumstances it is her opinion that the Council has gone as far as it can with this matter and as far as the Council are concerned the matter should be closed. The members present agreed with this.
- b) The Chairman and Cllr. V.Hughes attended the recent PACT meeting and had found it both enjoyable and informative. She hoped that future meetings would rotate around the area and that Hurworth would host a meeting shortly.
- c) A number of members have asked her to list the issues she wishes to deal with during her term of office, which she gave to the meeting, emphasising they were not in priority order or exclusive. The issues included Parish Plan implementation, improving and enhancing the Village green, repairing and maintaining village seats, improving the office of the clerk and improving the visual impact and entrances to the villages.
