Mr. S.Holme wished to thank the Council for all the support given to HCA and The Grange over the past year.

A resident of Manor Field expressed concern over dog fowling in the area and also requesting a specific area of the green for children's play. The Chairman advised this will be taken into account at the play builder meeting.

Mr Dewkes expressed concern in regards to the state of the Church yard and cemetery. He produced photographs for Council to consider. The Chairman requested Cllr. K.Pattison and Cllr D.Parr raise issues directly affecting the church with the PCC. The Clerk to take up urgently with DBC the state of the grounds and wall. A meeting with DBC Street Scene to be arranged.

Cllr. P.Allan requested permission to retain the photographs personally, Mr. Dewkes agreed.

Mrs. Dell asked it be minuted the thanks of residents for the Council objecting to the Croft House Planning Application. She also gave a brief report on the current situation. It was agreed the Clerk write to Phil Wilson MP and apprise him of the Councils objection.
