This strategy is based on four areas of work:

- **Pursue**
To stop terrorist attacks
- **Prevent**
To stop people becoming terrorists or supporting terrorism
- **Protect**
To strengthen our protection against a terrorist attack
- **Prepare**
To mitigate the impact of a terrorist attack

AIMS

At Guilden Morden we follow the principles outlined in the DCSF toolkit <http://www.communitycohesionncc.org.uk/docs/280.pdf> which seeks to:

- **Raise awareness** within school of the threat from violent extremist groups and the risks for young people.
- Provide **information** about what can cause violent extremism, about preventative actions taking place locally and nationally and where we can get additional information and advice.
- Help schools understand the **positive contribution** they can make to empower young people to create communities that are more resilient to extremism and **protecting the wellbeing** of particular pupils or groups who may be vulnerable to being drawn into violent extremist activity.
- Provide advice on **managing risks** and responding to incidents locally, nationally or internationally that might have an impact on the school community.

Guilden Morden Primary will use these principles to guide our work in all areas including building on our work in:

1. Promoting good outcomes for all pupils including their spiritual, moral, social and cultural development
2. Promoting pupil happiness, wellbeing, sense of security, equalities and community cohesion
3. Building the resilience of the school, working with partners, to prevent pupils becoming the victims or causes of harm
4. Working with other agencies including the education child protection service, social care, the police, parents, and community and religious leaders to build community links and enhance positive networks

TRAINING

Kristy Carter/ Helen Smith are the designated personnel for PREVENT and undertook training in 2018/2019.

School staff have been briefed on the PREVENT Duty as have the Governing Body and a copy of this policy is displayed on the school website.

All staff have access to the Prevent Action Plan (on school website)

RISK ASSESSING

Guiden Morden Primary is committed to safeguarding, is compliant with its duties including 'Prevent', positively promotes the well-being of all its pupils and expects all staff and volunteers to share in this commitment.

Guiden Morden Primary is a happy school with an open door policy and good methods of communication. The School has good relations with parents and the community. The school risk assesses for a number of purposes including staff recruitment and would be as vigilant as possible to any pupil at risk to grooming or extremism.

USE OF ONLINE TECHNOLOGY AND SOCIAL MEDIA

Guiden Morden Primary is aware of the risk of use of social media for online radicalisation

Guiden Morden Primary promotes a positive and protective school ethos. The Headteacher is the designated lead for Child Protection and Safeguarding. All staff receive Child Protection training.

The school has an Acceptable Use of IT Policy and during the school day restricts access to external sites that may be unsafe or unsuitable. The school uses STARZ to enable pupils to interact with each other using a safe moderated platform. Twice a year pupils receive an update on how to keep themselves safe on line (once during Positive Friendship Week/Anti-Bullying Week in November and in Internet Safety Week in February). Pupils are reminded of the importance of speaking to a trusted adult either in school or at home if they feel vulnerable or unsafe. This would include any concerns they have about images, messages or contacts online. Pupils are also taught to speak to the school's ICT co-ordinator or to use the CEOPS button if they feel they are at risk.

PARTNERSHIPS

Guiden Morden Primary recognises that any attempt to counter extremism and prevent radicalisation can not be achieved by one organization alone but relies on the sharing of information and productive partnership working. In upholding the Prevent duty Guiden Morden works with a number of partners, including

- The Education Child Protection Service
- The Police and PCSOs
- The Locality Team
- Social Care

- Community and religious leaders
- Parents and the wider community
- Other Educational Organizations

BUILDING RESILIENCE

Guilden Morden Primary develops pupils’ resilience in a number of different ways across the curriculum including through the PHSE programme of study, whole School and class assemblies, educational visits, drama workshops, debating, philosophy, and citizenship activities such as school council.

RAISING A CONCERN

If a member of the school community, a child or a member of staff raises a concern that relates to the Prevent Duty e.g. a child at risk of radicalisation, or exhibiting extremist views the school will take this matter seriously and will follow Child Protection procedures.

Whilst Guilden Morden Primary is fully compliant in the Prevent duty, and recognises the important role it has to play in this respect, the school will be thoughtful and proportionate in its response to ensure that no individual or group feels needlessly disenfranchised or unfairly discriminated.

Paramount to Guilden Morden's vision is to promote a positive, warm, inclusive, compassionate, optimistic and harmonious school culture, where every child and adult feels safe, happy, valued as a unique and precious individual, and realises personal achievement and experiences rewarding success.

Teaching British Values

The DfE have recently reinforced the need 'to create and enforce a clear and rigorous expectation on all schools to promote the fundamental British values of democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs.' The Government set out its definition of British values in the 2011 Prevent strategy, and these values have been reiterated in 2014. At Guilden Morden Primary these values are reinforced regularly and in the following ways.

Democracy

Children are listened to and are taught to listen carefully to others. Children are taught to respect the right of individuals to have their voices and opinions heard. They are taught to discuss issues in a balanced and calm way. Each year the children review their class rules and our citizenship expectations to ensure that they are still relevant. The school council meets regularly and discusses issues raised in class or as a whole school. Each council member is voted for by their own class. Visits from local MPs and councillors have been arranged.

The rule of law

The importance of laws, whether they be those that govern the class, the school or the country are consistently reinforced at Guilden Morden Primary. Pupils are taught from an early age the value of our rules. Children are taught the value and the reason behind the rules and the laws, that they govern and protect us, the responsibility this involves and the consequences when laws are broken. Visits from authorities such as local councillors, Police and the fire service help to reinforce this message.

Individual liberty

At Guilden Morden Primary, children are actively encouraged to make the right choices, knowing they are in a safe and supportive environment. Children are expected to take responsibility for their own actions and to understand the consequence their actions might have. We educate and provide boundaries for children to enable them to make informed choices, through a safe and supportive environment. The understanding of rights and responsibilities is promoted through acts of collective worship, e-safety, PSHE.

Mutual respect

Mutual respect is a core value at Guilden Morden Primary. Children learn that their behaviours have an effect on their own rights and those of others. All members of the school community are encouraged to treat each other with respect.

Tolerance of those of different faiths and beliefs

Guilden Morden Primary school is situated in an area that is not greatly, culturally diverse. The school recognises its role in preparing children for life in modern Britain. We actively promote celebrations of different faiths and cultures. The religious education syllabus is the agreed Cambridgeshire syllabus. Through RE and personal and social education we reinforce messages of tolerance and respect.

The curriculum

Staff regularly review the curriculum to ensure that it promotes the areas above. It also ensures that pupils are taught about key events and figures in history. Events during the year celebrate culturally diverse occasions and memorable events taking place in the country.

At Guilden Morden Primary we will actively challenge children, staff or parents who express opinions that are contrary to fundamental British values including extremist views.
