

# This is Peters Hill's Publication Scheme on information available under the Freedom of Information Act 2000

The governing body is responsible for maintenance of this scheme.

## 1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred as FOIA in the rest of the document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this, we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish
- The manner in which the information will be published and
- Whether the information is available free of charge or on payment

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

#### 2. Aims and Objectives

The school aims to:

- Provide outstanding learning and life chances in our community.
- Become the country's foremost international teaching, learning and research centre through excellence, innovation and collaboration.
- Develop and increase the ability of all staff to contribute to inspiring learning experiences that help children succeed.

#### 3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into three broad topic areas:

- Governors' Documents information from some governing body documents.
- Pupils & Curriculum information about policies that relate to pupils and the school curriculum.
- School Policies and other information related to the school information about policies that relate to the school in general.

Financial information relating to projected and actual income and expenditure, procurement and contracts.

#### 6.3 What our priorities are and how we are doing

Strategy and performance information, inspections and reviews.

#### 6.4 How we make decisions

Decision making processes and records of decisions.

#### 6.5 Our policies and procedures

Current written protocols, policies and procedures for delivering our services and responsibilities.

## 6.6 Lists and registers

Currently maintained registers relating to functions of the authority and any registers required by law.

## 6.7 The services we offer

Information about the services we offer, including leaflets, guidance and newsletters.
