


Mobile phone policy



Adopted May 2023 Review May 2025

1. Introduction and aims

At Harbury C of E Primary School we recognise that mobile phones, including smart phones, are an important part of everyday life for our pupils, parents and staff, as well as the wider school community.

Our policy aims to:

- > Promote, and set an example for, safe and responsible phone use
- > Set clear guidelines for the use of mobile phones for pupils, staff, parents and volunteers
- > Support the school's other policies, especially those related to child protection and behaviour

This policy also aims to address some of the challenges posed by mobile phones in school, such as:

- > Risks to child protection
- Data protection issues
- > Potential for lesson disruption
- > Risk of theft, loss, or damage
- > Appropriate use of technology in the classroom

2. Roles and responsibilities

2.1 Staff

All staff (including teachers, support staff, and supply staff) are responsible for enforcing this policy.

Volunteers, or anyone else otherwise engaged by the school, must alert a member of staff if they witness, or are aware of, a breach of this policy.

The Headteacher is responsible for monitoring the policy every two years, reviewing it, and holdingstaff and pupils accountable for its implementation.

3. Use of mobile phones by staff

3.1 Personal mobile phones

Staff (including volunteers, contractors and anyone else otherwise engaged by the school) are not permitted to make or receive calls, send texts or access their mobile phone during contact time. Use of personal mobile phones must be restricted to non-contact time, and to areas of the school where pupils are not present (such as the staff room or offices).

There may be circumstances in which it's appropriate for a member of staff to have use of their phone during contact time. For instance:

- > For emergency contact by their child, or their child's school
- > In the case of acutely ill dependents or family members

The headteacher will decide on a case-by-basis whether to allow for special arrangements.

If special arrangements are not deemed necessary, school staff can use the school office number as a point of emergency contact.

3.2 Data protection

Staff must not use their personal mobile phones to process personal data. The school's data protection policy can be found on the school's website.

3.3 Safeguarding

Staff must refrain from giving their personal contact details to parents or pupils, including connecting through social media and messaging apps.

Staff must avoid publicising their contact details on any social media platform or website, to avoid unwanted contact by parents or pupils.

Staff must not use their mobile phones to take photographs or recordings of pupils, their work, or anything else which could identify a pupil. If it's necessary to take photos or recordings as part of a lesson/school trip/activity, this must be done using school equipment.

3.4 Using personal mobiles for work purposes

In some circumstances, it may be appropriate for staff to use personal mobile phones for work. Such circumstances may include, but aren't limited to:

- > Emergency evacuations
- > Supervising off-site trips
- > Supervising residential visits

Please see Educational Visits Policy

In these circumstances, staff will:

- > Use their mobile phones in an appropriate and professional manner, in line with our staff code of conduct
- > Not use their phones to take photographs or recordings of pupils, their work, or anything else which could identify a pupil
- Refrain from using their phones to contact parents. If necessary, contact must be made via the school office

3.5 Work phones

Members of staff may be provided with a mobile phone by the school for work purposes.

Only authorised staff are permitted to use school phones, and access to the phone must not be provided to anyone without authorisation.

Staff must:

- > Only use phone functions for work purposes, including making/receiving calls, sending/receiving emails or other communications, or using the internet
- > Ensure that communication or conduct linked to the device is appropriate and professional at all times, in line with our staff code of conduct.

3.6 Sanctions

Staff that fail to adhere to this policy may face disciplinary action.

4. Use of mobile phones by pupils

The schools recognises that parents use mobile phones to communicate with children who travel to school by themselves. Children in years R to 4 are expected to be collected from school by a responsible adult. Children in year 5 and 6 can walk home and the school should be notified of this arrangement. As a result, the school

does not deem it necessary for children to bring mobile phones into school. Where parents would like their child to have a mobile phone due to reasons stated above, these phones must be handed into the school office where they will be stored until the end of the school day. Mobile phones are not to be taken on educational visits including residential trips.

4.1 Sanctions

If pupils breach this policy then the mobile phone will be confiscated and stored in the main office until the end of the school day. Parents will be informed and a discussion will be had to determine if the mobile phone is needed. Should it be agreed a phone is required, this must be handed into the office at the start of each school day as stated above.

School staff have the power to search pupils' phones, as set out in the <u>DfE's guidance on searching</u>, <u>screening and confiscation</u>. The DfE guidance allows the school to search a pupil's phone if we have reason to believe the phone contains pornographic images, or if it is being/has been used to commit an offence or cause personal injury.

5. Use of mobile phones by parents, volunteers and visitors

Parents, visitors and volunteers (including governors and contractors) must adhere to this policy as it relates to staff if they are on the school site during the school day.

This means:

- > Not taking pictures or recordings of pupils, unless it's a public event (such as a school fair), or of their own child
- > Using any photographs or recordings for personal use only, and not posting on social media without consent
- > Not using phones in lessons, or when working with pupils

Parents, visitors and volunteers will be informed of the rules for mobile phone use when they sign in at reception or attend a public event at school.

Parents or volunteers supervising school trips or residential visits must not:

- > Use their phone to make contact with parents of children on the school trip
- > Take photos or recordings of pupils, their work, or anything else which could identify a pupil

Parents or volunteers supervising trips are also responsible for enforcing the school's policy for pupils using their phones, as set out in section 3 above.

Parents must use the school office as the first point of contact if they need to get in touch with their child during the school day. They must not try to contact their child on his/her personal mobile during the school day.

6. Loss, theft or damage

Pupils bringing phones to school must ensure that phones are appropriately labelled, and handed into the office.

Pupils must secure their phones as much as possible, including using passwords or pin codes to protect access to the phone's functions. Staff must also secure their personal phones, as well as any work phone provided to them. Failure by staff to do so could result in data breaches.

The school accepts no responsibility for mobile phones that are lost, damaged or stolen on school premises or transport, during school visits or trips, or while pupils are travelling to and from school.

Confiscated phones will be stored in the school office and are the responsibility of the admin staff.

Lost phones should be returned to the main office. The school will then attempt to contact the owner.

7. Monitoring and review

The school is committed to ensuring that this policy has a positive impact of pupils' education, behaviour and welfare. When reviewing the policy, the school will take into account:

- > Feedback from parents and pupils
- > Feedback from teachers
- > Records of behaviour and safeguarding incidents
- > Relevant advice from the Department for Education, the local authority or other relevant organisations
