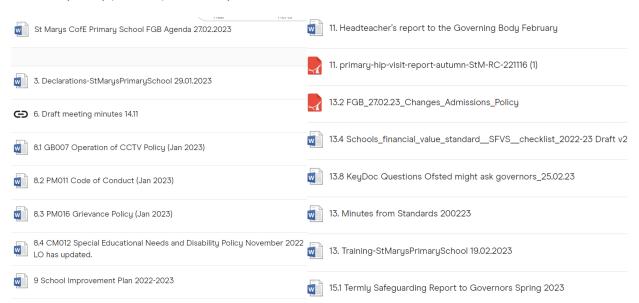

SG introduced her presentation which was recorded for the benefit of colleagues

1. Question - Is assessment being used across all subjects to ensure that the curriculum is adapted to meet the needs of all learners, particularly those who are disadvantaged and those who have SEN/D? Yes. Tracking is on Arbor

EW arrived at 19.17

- 2. The impact of the investment in staff training with the OTI was evidenced in the outcomes across the school engagement, challenge, assessment and feedback
- 3. Assurance was provided that planning and adaptation allows for all children to be stretched and fully engaged. The adults know the children well particularly those who work 1-1 with a child and ensure that interventions have a start and end point to determine progress
- 4. Question Do the children understand if it is a summative assessment? Yes, in the appropriate language for the cohort. The detail in the reports is not for foundation subjects. The curriculum letter and progression maps on the website outlines key points for parents. The core subjects have a detailed report. Parents are advised twice a year at parent consultation meetings and in the end of the year report. If there are concerns the teachers would make contact with parents
- 5. Question How consistent is it across the school and how it is monitored? The subject leaders review the summative grids and review the rag rated grids to determine progress. The monitoring of books is used to triangulate the evidence
- 6. Question Are formative assessments looking at the class as a whole? Yes, for the class and individuals. Quality first teaching ensures all children are addressed so that prior learning is built upon. The whole class feedback policy supports delivery of interventions
- 7. Question How do these assessments compare with other schools? This practice is used by many schools according to the context of the school. The OTI course which was explained has influenced our practice. Subject leaders attend cluster sessions to share good practice. This is becoming embedded across the school and consistency has been a recent focus. Open classrooms are opportunities for parents to see books during the year
- 8. Question Is this in every subject? Yes, it is adapted accordingly
- 9. Governors extended their thanks for the informative presentation to support their monitoring activities and understanding the impact on learning

10 Exploration of Academisation:

- 1. This continues to be investigated and will be discussed further at the Away Day
- 2. Governors have attended training and wider discussion groups. The school is in E Herts area

11 To receive and ask questions of the HT report:

The HT introduced the documentation circulated in advance of the meeting. Further questions and discussion included:

- 1. Question What was the rationale behind putting them in Year 6? Had completed ECT in Year 5 and then Year 6 and there are no concerns
- 2. Question Do governors have the opportunity to sit in on exit interviews should a member of staff wish to have one? Yes
- 3. Question What percentage of absences were Code U? 1 Sept 22 and 31 Jan, 0.1% of absences were Code U. Late after the register is closed after 09.15
- 4. Question What is a soft start? This is flexible start to the day from 08.40 to commence learning and works well. The gates shut at 08.50
- 5. Question Family Support Worker referrals that are closed. Is there anything further we can do or are doing to support the two families who have not engaged. Both families have positive relationships with school (in particular SENDCo, class teacher and office team). We check in with them at least weekly, offer support and signpost to services on offer. We can re refer and may suggest this in future. However, need to be mindful of the fact that these are unknown 'authority figures' coming into families' homes
- 6. Question How does the school monitor the impact of PPG spending on children Can you give examples of the difference this has made? All teaching staff and support staff are aware of who the PPG children are in their class and their needs planned for. We aim to spend 50% of PPG funding per child on enhancements as necessary and to ensure these children have the same opportunities as their peers. Examples here include: music lessons, clothing, trips, breakfast and after school clubs. This sense of well-being is hard to quantify. Targeted teaching and teaching assistant support is easier to evidence. For example, child in Year 1 has now moved through two colours in book bands, a child in Year 2 who was previously PRE in maths is now WTS. Many of these children will be making small steps as they also have identified SEND needs. PPG children and their progress is a standing item at all SLT meetings. There are currently 18 PPG on roll

Question On attendance, how does the attendance rate for children with SEND compare with the Attendance figures up to 31 January 2023 are: SEN: 91.66% attendance (7.14% authorised absence and 1.2% unauthorised). Non-SEN: 95.26% attendance (4.11% authorised absence and 0.64% unauthorised). Whole school: 94.83% attendance (4.47% authorised absence and 0.7% unauthorised). Of these children with identified SEN need (23 children) one has reduced timetable agreed which impacts on attendance figures doesn't attend two afternoons a week. One is mentioned in persistent absence figures (many health issues) these two have a big impact on the overall.
- 8. Question How is the reduced timetable being monitored? The arrangement has been agreed with the LA and is being used to support the pupil's needs. 3 external agencies are working with the child as the school works towards a full-time timetable
- 9. Question Are there any severely Absent 50%? No however where there is a concern, strategies are put in place to identify the barrier to learning and agencies are included as appropriate. Supporting parents is key and case studies are in place. Home learning is available for those requiring it
- 10. Question The number of children with EHCPs/on SEN support is rising nationally (and the school reflects this), so how does the school support teachers who work with pupils with SEND? 2 staff work together to identify both training needs and training available locally. For example, support staff have been/are going on training based on supporting/understanding pupils with ASD diagnoses. SENDCo works closely with teaching staff to identify need and suggest adaptations/signpost to resources. One staff meeting each half term is focused on SEN support in particular 'solution focused thinking'. The feedback from the parent coffee mornings reflects the confidence the parents have with the arrangements
- 11. Question What type of questions are asked and followed up at staff meetings, as well as ensuring all staff have attended safeguarding training, are there any follow up measure to ensure understanding, for example 'Example Scenarios'? Going forward, all governors are welcome to check this by looking at our Briefing Book, which shows the sorts of questions/activities used. Examples include: KCSIE updates e.g., checking that staff know the changes and new terminology (peer abuse to child on child), what is a concern and how to fill in a concern form, what would you do if scenarios, serious case review outcomes (e.g., what went wrong in the Arthur Labinjo Hughes case) and reaction to things that could be improved in school
- 12. Question Has additional funding been sourced for our Ukrainian children? Yes. The funding was additional to the PPG allocation

- 14. Question Is the school aware of any working poverty families? Yes, the families are known to the school and supported appropriately e.g., healthy cooking club. The Resources Committee will monitor this area as part of wider remit on PPG

- 4. Question Are out of year applications considered at Secondary School? It is a direct transfer
- 5. **Resources & Premises Committee** the Chair noted the minutes are available on GHUB. There are no H&S concerns to raise. The nursery roof and carpark potholes are being addressed. The classroom carpets are being replaced on a cycle. An asset register is being compiled to prioritise requirements. The Finance and budget update was provided and the energy efficiency grant has been allocated to installing double glazed windows in Year 5 and Year 6 if finances allow. P10 monitoring has been received and the school is judged as Amber with 6% carry forward. Governors noted the financial position of the school
- 6. The GB agreed **the SFVS** draft for submission before the end of March. **ACTION: Assurance** was provided that the skills audit will be updated to reflect the new governors new governors to let Steve know if they have financial experience specifically
