Rule 7	Children at least one of whose parent(s)/carer(s) has a regular worship commitment at another Anglican church or a church of any other Christian denomination verified by the relevant Church Minister on the school's Supplementary Information Form and who live In Area A or B on the Admissions Map.

A "**regular worship commitment**" means attendance at a public act of worship at least once a month for a period of at least one year immediately prior to the date of application.¹
