Beechwood School has adopted Slough Borough Council's Health & Safety code of practice for First Aid Sept 2015.

The following process should be applied for staff, students and visitors of Beechwood School.

1 - INTRODUCTION

- 1.1 An employer has a responsibility to provide first aid facilities for staff.
- 1.2 First Aid can be described as providing treatment for the purpose of preserving life and minimising the consequences of injury or illness until help arrives and the treatment of minor injuries that would otherwise receive no treatment.
- 1.3 First Aiders are not trained to diagnose illness or other medical conditions or to prescribe drugs of any description.
- 1.4 A First Aider must not put themselves at risk in order to treat a casualty.
- 1.5 Whilst the Health and Safety (First Aid) Regulations do not require that treatment is given to non-employees, it is considered that it would be impractical to refuse first aid treatment if an incident occurs on the school premises.

2 - TRAINING

- 2.1 There are three levels of training:
 - For Appointed Persons
 - For First Aiders
 - For Emergency First Aid at Work
- 2.2 An Appointed person is someone who has been nominated to take charge of first aid equipment and to manage accident emergencies. Training is usually conducted over one day. Appointed persons are not qualified to administer first aid treatment.
- 2.3 First Aiders who attend a three-day First Aid at Work course are trained to give treatment to an injured or ill person until that treatment is completed or their care is handed over to suitably qualified medical personnel. First Aid at work training has to be renewed every three years. A one day annual First Aid course can support this training.
- 2.4 Emergency First Aid at Work is a one-day course and subject to risk assessment will be sufficient to comply with the legal requirements to provide first aid cover.
- 2.5 Only courses that provide training to the standards contained in the Health and Safety (First Aid) Regulations should be used.
- 2.6 Where possible, First Aid training should cover any specific risk areas that may be experienced in the workplace.
- 2.7 Some training providers can deliver specific emergency first aid courses. These courses are designed to train individuals to provide limited emergency first aid until a qualified fist aider or medical practitioner becomes available.

3 - ADDITIONAL INFORMATION

- 3.1 Appointed Persons are not required when there are sufficient numbers of qualified First Aiders available.
- 3.2 The recommended numbers of First Aiders are as follows:

• Low Risk areas - Less than 25 - appointed person only

25 – 50 - 1 EFAW

50+ - 1 First Aider/100 staff

High Risk areas - Less than 5 - 1appointed person only

5 – 50 - 1 EFAW or First Aider dependant on

type of injury.

50+ - 1 First Aider/50 staff

When assessing first aid needs Beechwood has looked at the likely risks to pupils and visitors, as well as to staff.

Points considered are:

- The size of the school building.
- Numbers of Staff, Pupils and Visitors on site.
- The location of the school in relation to the emergency services.
- Any specific hazards or risks on site, e.g. hazardous substances, dangerous tools or machinery, or temporary hazards such as building and maintenance work.
- Any specific health needs or disabilities of pupils or staff and the age range of pupils.

Beechwood is considered as Low risk and provides for the following:

- Adequate provision for lunch times and breaks.
- Adequate provision for leave and in case of absences.
- First-aid provision for off-site activities.
- Adequate provision for practical areas such as science, technology, homeeconomics and physical-education departments.
- Provision for out-of-school-hours activities, e.g. sports and clubs, events.
- Agreements with PFI partners on joint first-aid provision for their employees.

In addition to the above, where access to first aiders may be limited (holiday periods) and the work activity is considered high risk, consideration should be given to ensuring that a member of that small team is to be trained.

All staff must be made aware of where to find first aid when needed. The school operates a dedicated first aid phone number (777) which diverts to all first aid locations.

Staff should be aware that they should report any incidents or work-related ill health. Where appropriate, staff are made aware of a pupils known medical condition.

Facilities:

Beechwood Schools has a dedicated first aid room located at student services reception. The Education (School Premises) Regulations 1999 apply.

3.3 In dealing with an incident, First Aiders are responsible for:

- Assessing the situation
- Identifying the condition or injuries of the casualty
- Giving immediate, appropriate and adequate treatment to each injury or condition, giving priority to those that present the most danger to the life of the casualty.
- Arranging, where necessary, for the removal of the casualty to hospital
- Offering advice, where necessary, that the casualty should seek medical attention.
- Advising the employee's manager that an incident has occurred and that accident reporting procedure should be followed.
- Parents are to be advised of any incident at the discretion of the first aider. (Many accidents at school are trivial and in these cases the pupil can inform parents on arriving home)

Administration of Medication

Pupils who have drugs or medical prescriptions should be asked to lodge them with Student Services who will issue them as prescribed. The administration of medication must only be carried out in strict accordance with the school policy. (See MEDICAL POLICY) Staff members do not issue any drugs - except in circumstances where there is a formal agreement between parents and school.

First aid equipment

First-aid equipment is clearly labelled and easily accessible. Fully stocked first-aid containers are provided at key locations and are marked with a white cross on a green background. These containers are sealed and maintained on a regular basis (DRA). The containers are restocked as soon as possible after use. Any items that have passed their expiry date are safely discarded.

Locations of first aid equipment

- Main Adult Reception + plasters
- First Aid Room (plus grab bag, plasters and ice packs)
- Student Services + plasters
- Science Labs and Prep room (plus plasters and eyewash facilities)
- PE Department
- Food Technology Room (plus blue plasters)
- Technology (plus plasters and eyewash facilities)
- Art (plus eyewash facilities)
- Swimming Pool (plus foil blankets)
- ICT Office (Crescent)
- Minibus x 2

Incident Reporting, recording and investigation

Beechwood School has adopted Slough Borough Council procedures for reporting of incidents; SLOUGH BOROUGH COUNCIL HEALTH AND SAFETY – CORPORATE CODE OF PRACTICE - ACCIDENT REPORTING

Reportable specified injuries are:

- 1. A fracture, other than to fingers, thumbs and toes;
- 2. amputation of an arm, hand, finger, thumb, leg, foot or toe;
- 3. permanent loss of sight or reduction of sight;
- 4. crush injuries leading to internal organ damage;
- 5. serious burns (covering more than 10% of the body, or damaging the eyes,
- 6. respiratory system or other vital organs);
- 7. scalping (separation of skin from the head) which require hospital treatment;
- 8. unconsciousness caused by head injury or asphyxia;
- 9. any other injury arising from working in an enclosed space, which leads to hypothermia, heat-induced illness or requires resuscitation or admittance to hospital for more than 24 hours

All accidents are recorded on the cloud based Medical Tracker Software. For all incidents the code of practice is followed and a Confidential Accident and Incident Report Form is completed and sent to the schools "responsible person" (School Business Manager or line manager) who will investigate and report incidents/accidents.

First Aid Code of Practice and Accident reporting are located on Google team drive First Aid.

<u>ALL</u> accidents and illnesses should be reported to the Line Manager/Supervisor as soon as possible.

If you need to send a student requiring attention to the Medical Room/ Student services Reception. Please send him/her with a note, indicating time of departure, nature of complaint and a staff signature. Students should normally be sent ON THEIR OWN.

Where it is appropriate, a student's known medical condition, which staff need to be aware of, is communicated in the Staff Briefing. This information is all available through Medical Tracker Software. On occasion, there may be a medical condition which the Director of Studies and Form Tutor/Teacher may be aware of but will not have an impact on other students or staff. This will be kept confidential.

Staff should also declare any medical conditions and where appropriate be communicated to a First Aider in case of emergency. These should also be recorded on Medical Tracker.

Many accidents at school are trivial and include bruises, minor sprains and scratches and, in these cases, the student can be instructed to inform parents on arriving home.

Serious accidents, however, require immediate medical attention and an ambulance should be called, particularly if the accident includes shock or loss of consciousness, however brief.

AMBULANCE POLICY

- If a student is unwell, follow normal first aid policy.
- If it is clear that a student needs urgent medical attention an adult should stay with the child and send a student for help to front Student Services.
- When a student is clearly in need of further medical attention an ambulance will be called.
- If an ambulance has been called Student Services will contact a member of SLT (Appointed Person) and inform them. Student Services will ensure a member of staff is in attendance.
- Ensure that an adult or a responsible student meets the ambulance and guides them to the student.
- Student Services will inform parents/carers.
- A member of staff will accompany the student to the hospital and liaise with the parents; they will not leave the student until their parents arrive.
- An appropriate member of staff will contact the parents to follow the student's progress.
- A member of SLT will ensure that any students or staff involved are debriefed and supported; they will complete the relevant paperwork and notify the LA.

The above procedures would also apply for staff and visitors on site.
