DIRECTORS' REPORT

FOR THE YEAR ENDED 31 AUGUST 2023

The directors present their annual report together with the accounts and auditor's report of the charitable company for the year 1 September 2022 to 31 August 2023. The annual report serves the purposes of both a trustees' report, and a directors' report and strategic report under company law.

Structure, governance and management

Constitution

The academy trust is a company limited by guarantee and an exempt charity. The charitable company's Trust deed is the primary governing documents of the academy trust.

The directors are the trustees of The Kingsdale Foundation and are also the directors of the charitable company for the purposes of company law. Details of the directors who served during the year, and to the date these accounts are approved, are included in the Reference and Administrative Details on page 1.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

Directors' indemnities

The Academy Trust (The Kingsdale Foundation) provides indemnity insurance to cover the liability of members/directors which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust. Provided that any such insurance shall not extend to any claim arising from any act or omission which the members/directors knew to be a breach of trust or breach of duty or which was committed by members/directors in reckless disregard of whether it was a breach of trust or breach of duty or not and provided also that any such insurance shall not extend to the costs of any unsuccessful defence to a criminal prosecution brought against the members/directors in their capacity as members/directors.

Method of recruitment and appointment or election of directors

The number of directors shall be not less than 3. The members may appoint up to 15 directors. There is provision for the appointment of 2 parent directors and 2 staff directors.

Directors are appointed, elected and/or ratified at a full directors' meeting on the basis of their eligibility, personal competence, specialist skills or particular capacity to support the Academy.

Policies and procedures adopted for the induction and training of directors

New directors are inducted into the workings of the Academy and also the requirements of the Academy being a company and exempt charity. Directors are informed by their terms of reference and code of conduct. A number of directors have attended professional training courses in the year to allow them to more efficiently fulfill their duties.

Organisational structure

The Academy ensured a management structure was in place to enable it to operate effectively throughout the year. The management structure consists of three main levels; the full Directors' Meetings, the Directors' Committees and the Senior Executive Team.

The Directors are responsible for setting the general policy, adopting an annual budget, monitoring the Academy by the evaluation of budgets and making major decisions about the direction of the Academy, capital expenditure and senior staff appointments.

The Core Senior Leadership Team is the Senior Executive Team which customarily consists of the Head Teacher, Deputy Head Teachers and designated Assistant Head Teachers/Senior Managers. They control the Academy at an executive level and implement the policies set by the Directors and report back to them.

Arrangements for setting pay and remuneration of key management personnel

For the purposes of informing decisions with respect to the salary of members of key management personnel (Senior Executive Team/School 'Directors') of the Academy, the Directors will be guided by relevant sections within the Academy's Pay & Appraisal Policy which makes reference to being informed but not bound by comparative information from the DfE/ESFA for Academy trusts on financial benchmarking on executive salaries; relevant information in the School Teachers' Pay & Conditions Document (STPCD); data available from local and national trusts on senior staff salaries and advice from independent persons appointed by the Directors for this purpose. The Directors shall also consider the views of other relevant parties on such matters including the Academy's financial advisors.

For the purposes of informing the decision with respect to the salary ranges of members of the leadership group of the Academy the Directors will also calculate the unit total of the Academy as determined by the STPCD. The Directors will assign the Academy to an appropriate Headteacher group (HTG) whenever a new Headteacher is to be appointed and on such occasions as the Directors see fit.

Salaries, salary ranges and salary progression for members of the leadership group must be linked to their substantial and sustained impact and performance at a leadership and management level both as individuals and as members of the leadership team.

Objects and aims

Objects:

The principal object as set out in the Memorandum and Articles of Association is the operation of Kingsdale Foundation School to advance for the public benefit education in the local area, establishing, maintaining, carrying on, managing and developing a partially selective school offering a broad and balanced curriculum with an emphasis on Mathematics and the Performing Arts.

Aims:

The Academy aims to offer an innovative and creative curriculum, reflected in its vision statement, which meets the needs of girls and boys in the 21st Century whilst becoming a community centre of learning excellence.

Objectives, strategies and activities

The main objectives for the year with the strategies for achieving them were specified in our School Development/Improvement Plan and/or other respective plans and included:

1. To remain the school of choice in the locality for prospective Year 7 parents and maintain Kingsdale's position as one of the most popular and oversubscribed schools in the country; in spite of the highly competitive secondary options in the vicinity and potential new choices that are likely to become available in the future.
2. To continue to develop and implement an Executive Headteacher Shadow Structure which is flexible enough to sustain current arrangements but with the capacity to accommodate a transition to a range of association or multi-Academy trust models.
3. To protect and minimise any potential risks to the quality of the Academy's discretionary educational and statutory provision such as our small class size policy, trips of a lifetime and scholarship programmes through continued excellent financial management, innovative approaches and creative curriculum planning.
4. To implement robust educational strategies which result in examination outcomes that are consistently above or well above national expectations, for progress as well as attainment, in all key areas including English and mathematics and significantly below them in none using respected and recognised methodology. To relentlessly and materially close achievement gaps, where they exist, between our highest performing subjects and groups including students eligible for the pupil premium.
5. To remain significantly oversubscribed for our post 16 academic courses by continuing to establish and actively promote our justifiable reputation for excellent provision for aspirational sixth form students who are able to secure places at the most prestigious universities and conservatoires.
6. To complete our Condition Improvement Fund (CIF) Sixth Form Library development project on schedule by the end of the Autumn term 2022. To self-finance further expansion of provision on and off the school site of the order of £1.5m to be completed by the end of the Summer term 2022. To seek to procure additional funding to continue to improve the quality of our built environment.
7. To retain the Academy's Outstanding Ofsted status despite the overwhelming majority of Outstanding Schools that were exempt from inspection being downgraded under the latest Ofsted Framework.

Public benefit

The Directors confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission in determining the activities undertaken by the charitable company.

Strategic report

Achievements and performance

The impact of coronavirus (COVID-19) control measures did not materially impact on most of the Academy's operations and activities during the academic year. Aims and objectives no longer needed to be modified to the same degree or at all. Contingency plans for a potential Covid resurgence or new waves did not have to be implemented.

A review of non-financial objectives and performance indicators included the following:

This was another progressive year of development for the Academy with all main objectives fully or partially achieved.

Objective 1: Fully achieved. In accordance with data received from Southwark Local Authority this objective has been fully realised once more. We have exceeded all expectations again. We have received an astonishing circa 2,900 applications for entry into Year 7 for 2023 (excluding late applicants). At present we are by some distance the school of choice in the locality and are likely to remain the most sought-after secondary school in South London over the next period.

Objective 2: Fully achieved. An Executive Headteacher Shadow Structure has operated highly effectively and continues to be developed and refined.

Objective 3: Achieved. The quality and scope of the Academy's discretionary educational and statutory provision such as our trips of a lifetime programme was restored post-pandemic and scholarship programmes have been maintained. However, in accordance with our financial risk management protocols moderate revisions to our class size policy were implemented.

Objective 4: Partially achieved. At Key Stage 4, students attained well above national expectations in most key areas and across foundation in addition to other option subjects more widely. However, whilst the provisional pupil premium gap did not mirror the increasing national reported widening trend neither did it materially close. Furthermore, whilst significant progress was made in improving progress in most subjects there remains work to be done in one or more key areas and optional subjects. At Key Stage 5, due to the pandemic, no comparative national progress data was available.

In line with expectations, attainment outcomes were high overall and favourable with respect to 2019 pre-pandemic levels of performance in externally assessed examinations.

Objective 5: Fully achieved. We received a record number of post-16 applications for September 2023 entry and were exceptionally oversubscribed once more with circa 1,200 applications processed to date. The number of our graduates who gained places at Oxbridge as well as other Russell Group and prestigious universities or conservatories was impressive.

Objective 6: Partially achieved. Programme of works completed as scheduled notwithstanding unpredictable delay, to one major project, arising from the adoption of an uncustomary local authority planning approval process.

Objective 7: Fully achieved. The Academy was subject to an Ofsted Inspection in March 2023. It was judged, once again, to be Outstanding in every area. This was deemed to be an even greater accolade than achieved previously, as the new inspection framework was regarded as being even more robust and demanding than former iterations and the inspection was conducted during the post-pandemic period under adverse circumstances for most schools.

Key performance indicators

The range of key performance indicators that Directors consider is constantly under review. Directors consider it essential that they utilise a range of key financial performance indicators as well as non-financial ones that are relevant and applicable to monitoring the performance of the Academy Trust. Please refer to the preceding and following sections for further details i.e. objectives, strategies and activities and review of activities for 2022-23.

A review of key financial performance indicators include:

The cost of staffing salaries as a proportion of the total expenditure (excluding capital works and depreciation) – is 70.7% in 2022/23 (2021/22: 72.1%).

The pupil teacher ratio remained low at 1:13.9 (2021/22 - 1:13.6).

Going concern

After making appropriate enquiries, the Directors have a reasonable expectation that the Academy Trust has adequate resources to continue in operational existence for the foreseeable future. We have prepared detailed budgets and cashflow forecasts which reflect reduced expected income from lettings and fundraising.

For this reason, we continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

Financial review

The Academy's income for the year amounted to £22,548k (2022: £22,043k) virtually all of which are restricted funds. Income consisted primarily of the General Annual Grant (GAG) of £19,163k (2022: £18,289k). Expenditure before defined benefit pension scheme actuarial costs were £20,544k (2022: £19,269k).

The Academy had unrestricted reserves of £101k (2022: £nil) and restricted General Annual Grant (GAG) reserves of £5,225k (2022: £3,419k) at the end of the period.

The financial and cash position of the Academy are monitored carefully and systematically at a senior level on a regular basis.

Major Infrastructure Developments

The Academy managed the completion of two major DfE funded Condition Improvement Fund (CIF) Projects during the year. The £2,690k Window Walling Replacement Curtain programme and £314k Teaching and Dining Block Refurbishment were delivered in a timely manner, within budgets and to the required specifications. This was despite the prevailing and challenging post-pandemic procurement circumstances that were applicable at the time. The key reasons for these successes included the following factors:

- Scope of works designed by the Academy and their employers' agents
- Tenders run and reviewed by independent agents
- Insurance from independent advisors
- Specialist Legal advice on contract and any matters arising during the project
- Budgets set, monthly cash flow forecasts made with formal monthly and on-going review
- Formal Variation orders had to be signed-off if there was to be any change to scope of works
- Payments made with certification of works

Reserves policy

The policy of the Board of Directors is to maintain a level of reserves that will be adequate to provide a stable base for the continuing operation of the Academy whilst ensuring that excessive funds are not accumulated. Directors have reviewed the level of reserves and any change to funds set aside for future commitments. Directors have determined that due to the in-built flexibilities within our financial planning and excellent contingencies within the Trust's risk management planning that the appropriate level of reserves should be £200,000 (2022: £200,000). In order to fulfil the Academy's self-financed further redevelopment works to enable the provision to offer new and a wider range of level 2 & 3 technical courses additional reserves have been retained for these purposes.

These reserves will provide a cushion to deal with unexpected emergencies such as urgent maintenance and small or moderate changes to Academy funding arrangements. As overall future pupil numbers are considered to be very robust, Directors are satisfied that these reserves will be sufficient for its current purposes.

The 2023/24 budget has been set so that necessary contingencies are contained within appropriate individual budget centres.

As at the 31 August 2023 the value of the Academy's reserves in total was £47,903k. This comprises restricted general funds of £5,228k, unrestricted general funds of £101k and fixed asset funds (net of loans) of £42,574k.

The Directors review the reserve levels of the Academy annually. This review encompasses the nature of income and expenditure streams, the need to match income with commitments and the nature of reserves.

The Trust Board will ensure that the levels of reserves that are carried forward at the end of the financial year will be in line with guidance received from the DfE on the treatment of GAG income and other grants.

The Academy has no pension liability in respect of the London Borough of Southwark Defined Benefits pension at 31 August 2023 and 31 August 2022. The Academy will continue to make pension contributions to the scheme.

Investment policy

The Kingsdale Foundation is at liberty to invest in a wide variety of vehicles in order to earn additional income from funds not yet spent. The Board of Directors have determined that the Academy should only invest surplus funds in bank deposits to maximise interest income whilst carrying no risk to capital.

The Academy currently holds no investments. A current and deposit account is held with the Co-operative Bank.

Principal risks and uncertainties

The Directors continuously evaluate principal risks and works with the Senior Executive Team to create a robust system to minimise the Academy's exposure to major risks through its detailed Risk Register and Management Plan which is reviewed annually and available on request. The purpose of the policy is to identify and manage potential risks and to put in place structures and processes to mitigate them.

Estates Management

The Academy employs a well-qualified and fit for purpose premises and site team, who receive regular and relevant training in relation to all key aspects of their roles. The team is overseen with respect to health and safety by the Key Health and Safety Officer and Deputy, who work with the Academy's Director of Operations to ensure that all relevant management and risk mitigations are in place. The Academy employs an external professional advisory company, Judicium Education Ltd. to support our work in this area (Judicium Education Ltd) who provide specialist advice.

The main estates management and risk mitigation actions include the following:

- Effective maintenance and management of the Academy's asbestos register with clear procedures in place for any authorised identification/removal/encapsulation works;
- Professional and ongoing engagement with the RAAC identification process, to establish at the earliest possible stage the non-existence of this material on the Academy site;
- Daily site surveys by qualified members of the estates team to identify and address any potential health and safety hazards;
- Highly effective site risk assessment systems for specific and generalised risk, including in subject specific areas such as Science;
- An effective framework of validated and relevant training for staff;
- A register of approved & authorised contractors to carry out necessary site works;
- An annual rolling programme of essential site inspections, e.g. water tank surveys, electrical testing, fire risk assessment etc.;
- Site emergency and continuity planning;
- Annual site health & safety inspections and audit undertaken by Judicium Education Ltd;
- Appropriate site insurance;
- Highly effective Governance and quality assurance oversight by the Trust Board

Outlined below is a description of the principal risk factors that may affect the Academy. However, not all factors are within the Academy's control and other factors besides those listed below may also adversely affect the Academy:

1. Significant reductions in funding from the ESFA, such as an adverse and major change in the Academy's Minimum Funding Guarantee (MFG) and/or the introduction of a highly detrimental financial National Funding Formula beyond the Academy's ability to adjust its cost base appropriately
2. Introduction of new education priorities by Government including school reorganisation resulting in unfavourable local outcomes impacting on our current Academy arrangements i.e. Regional adverse impact of expansion in Free School Programme
3. Operating below our optimal level of reserves providing minimal headroom for exceptional unforeseen events.
4. The ability to redevelop the site infrastructure to meet the demand to offer an even broader range of technical level 2 & 3 courses exacerbated by fluctuating rates of rising costs in this sector.

Financial and risk management objectives and policies

The Academy has considerable reliance on continued government funding through the Education and Skills Funding Agency (ESFA) and the Local Authority.

These risks have and will be mitigated in a number of ways:

1. Ensuring the Academy is focused on those priority sectors which will continue to benefit from public funding;
2. To continue to submit highly professionally informed Condition Improvement Fund (CIF) bids to the ESFA that have a high probability of success;
3. Contingency planning embedded into the Academy budget process;
4. Comparison of previous funding methodology and potential new funding processes were modelled in advance of budget setting; this being further informed by the benefits arising from the from the Head Teacher's role as a member of the local authority's schools' forum.

To actively participate in and stay abreast of Government initiatives to ensure the Academy is best placed to make proactive decisions for its strategic advantage.

Fundraising

The Academy through its House System, for example, promotes a number of official charities such as Cancer Research UK, The Sickle Cell Society, Barnardo's Children's Charity, The Honeypot Children's Charity and Young Minds Child & Adolescent Mental Health Charity i.e. we act by choice on behalf of other charities. We also support an annual food drive for local food banks. We operate on the principle that everything raised or donated is passed on at our cost to the published source which must be declared in advance. More often than not we operate on a quid pro quo basis i.e. we may grant a concession such as a 'Mufti Day' or run a raffle in exchange for a donation.

We also apply a 'no compulsion rule' and take every measure to ensure no potential donor feels obliged to make a donation. We do not 'cold-call' and collect money tactfully.

We do invite parents to make donations to support other parents and their children to access discretionary provision such as our heavily subsidised school transportation service or Trips of a Lifetime Programme. At present this only occurs once via general literature provided after students have secured a place at the Academy. Parents are occasionally invited to make nominal contributions via a discreet collection box in support of a school performance or a cake sale for a stipulated reason such as our International Family Culture Day which supports the charity 'Mind' or Red Nose Day.

All fundraising is carried out having regards to the highest ethical standards including transparency as to source of funds unless the donor wishes to remain anonymous to third parties including the public.

A measure of our sensitivity and diligence over fundraising activities is reflected by the fact that as an Academy we have never received a fundraising complaint. Parents/third parties are not persistently or unreasonably approached for donations.

All fundraising is carried out in accordance with the Charities Act of 2016.

We have reflected the reduced fundraising income, caused by the post COVID-19 pandemic period and cost of living challenges for many, experienced in 2022-23 in our 2023-24 budget.

Plans for future periods

The aims and objectives are detailed in our Development/Improvement Plan 2023-26 and/or each respective individual associated plan.

The Academy has the following significant future plans:

1. To remain the school of choice in the locality for prospective Year 7 parents and maintain Kingsdale's position as one of the most popular and oversubscribed schools in London; in spite of the highly competitive secondary options in the vicinity and potential new choices that may become available in the future.
2. To enhance Key Stage 3 curriculum development, enrichment and minimise pupil regression on transition from Key Stage 2 by implementing future feeder school arrangements, following a formal consultation exercise in accordance with the provisions within the School Admissions Code 2021.
3. To protect and minimise any potential risks to the quality of the Academy's discretionary educational and statutory provision such as our trips of a lifetime and scholarship programmes through continued excellent financial management, innovative approaches and creative curriculum planning;
4. To implement robust educational strategies which result in examination outcomes that are consistently above or well above national expectations, for attainment and progress, in all key areas including English and mathematics and significantly below them in none. To relentlessly and materially close achievement gaps, where they exist, between our highest and least well performing subjects and groups including students eligible for the pupil premium;
5. To remain significantly oversubscribed for our post-16 academic courses by continuing to establish and actively promote our justifiable reputation for excellent provision for aspirational sixth form students who are able to secure places at the most prestigious universities and conservatoires;
6. To continue the multi-million pound redevelopment of the Trust's estate to ensure it remains fit for purpose in meeting our expanding curriculum needs. This includes the introduction of more technical level 2 & 3 specialist provision, sixth form science laboratories and upgraded staff and student facilities.

Scope of responsibility

As directors, we acknowledge we have overall responsibility for ensuring that The Kingsdale Foundation has an effective and appropriate system of control, financial and otherwise. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

The board of directors has delegated the day-to-day responsibility to the Head Teacher, as accounting officer, for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the funding agreement between The Kingsdale Foundation and the Secretary of State for Education. The accounting officer is also responsible for reporting to the board of directors any material weaknesses or breakdowns in internal control.

The Board focused on the key areas of enhancing pupil outcomes, staff development, admissions, the Academy's salary structure, redeveloping the built environment and enriching the trust estate, preparation for the challenges of the new Ofsted framework, exploration of different leadership structures and potential options related to associations and MATs.

Following objective and well-informed comparative exercises including the use of DfE Benchmarking Report Cards and Self- Assessment Tools such as SRMSAT, the Board considered its work to be highly effective with numerous outstanding features. The Board has relied on high quality independent data to evaluate its performance such as audit outcomes, internal scrutiny, the Pearson Teaching Awards (where the Academy was deemed to be the 'Most Thanked School in the Country' for the third successive year), Local Authority admissions data and DfE data indicating Kingsdale was the 'Most Sought-After' secondary school in London.

Conflicts of interest

The Academy has developed a Conflicts of Interest Policy and maintains an up-to-date and complete Register of Business and Pecuniary Interests for Directors, Senior and Finance Staff. All other staff are also required to complete a declaration of financial and pecuniary interests form annually. Information declared is reviewed and shared with relevant individuals. Guidance is also provided as to how to operate when a conflict of interests arises.

At the start of every Directors/Governors' meeting a formal note is taken of responses to the following question: 'Governors are invited to declare any interest they might have in respect of any item to be considered at the meeting or any changes to interests declared previously.' With respect to the day-to-day management of potential conflicts of interest there is a termly refresher session during Staff Inset days on our Staff Code of Professional Conduct which addresses the issue of conflicts of interest. We have also adopted another relevant policy which provides guidance to staff on specific potential conflicts of interest and how to deal with it in our KFS Relationships at Work Policy.

Specific stipulations, guidance and prohibitions regarding outside interests are incorporated in staff contracts of employment with the Academy.

Governance reviews

Independent reviews of governance as well as the use of Pupil Premium funding were undertaken during the year with impressive outcomes. All recommendations were implemented. A further scheduled review of key aspects of the effectiveness of the Board of Directors was undertaken during the annual Summer term Directors' self-evaluation training day at the end of June 2023. Governors organised during the year presentations by independent consultants to the full Governing Body/Trust Board on the new Ofsted Framework and self-evaluation processes, the revised Keeping Children Safe in Education Framework, Governors' Responsibilities for the Effective Implementation of the SEN Code of Practice and Governors' role in holding the Senior Management Team to Account. Governors also undertook Safer Recruitment Training and Safeguarding Refresher Training as well as individual training sessions to meet their needs and interests on topics such as understanding and using school data. The Academy also voluntarily participated in an HMI led review of the effectiveness of the National Tutoring Programme.

Kingsdale Foundation School was subject to a full Section 5 Ofsted Inspection in March 2023. The judgement for Leadership and Management which included the prescribed evaluation of Governance was 'Outstanding'. On Governance of the Academy, Ofsted states "Governors know the school well. They visit the school often to speak to staff and pupils. Governors challenge leaders where necessary and offer support to implement the school improvement priorities". Visits to the Academy allow governors to fulfil their responsibilities in supporting pupils' welfare and seek opportunities to develop their skills. Governors, like leaders, do not shy away from challenges that may arise but seek to learn any lessons that contribute to the Academy's effectiveness."

The next scheduled Directors' self-evaluation day is in June 2024.

The Finance & Premises Committee is a sub committee of the main Governing Body. Its purpose is to assist the Governing Body in ensuring sound management of the Academy Trust's finances and resources including proper planning, probity and risk management. The Committee fulfils its monitoring and advisory role by a more detailed consideration of the Academy's financial health, financial exposure to risk, accounting compliance and financial aspects of its staff establishment and its property than is possible for the Full Governing Body. In particular, consideration of the Academy's budget and monitoring against plans has been important for an Academy where uncommitted resources remain very tight.

Membership of the Finance & Premises Committee includes Directors with high quality financial, business and professional skills. The Chair of the Finance and Premises Committee is a qualified accountant. The Committee will normally meet at least six times during the academic year but more frequently if deemed necessary.

Review of value for money

The accounting officer considers how the academy trust's use of its resources has provided good value for money during each academic year, and reports to the board of directors where value for money can be improved, including the use of benchmarking data or by using a framework where appropriate. The accounting officer for the academy trust has delivered improved value for money during the year by:

Staffing structure is reviewed annually, deployed to drive and support school improvement, individual needs and to maintain a smaller class size policy. This was exemplified by our ability to employ nearly 90 well-qualified English, Mathematics and Science specialist teaching staff establishing impressive teaching and learning environments in each of these core areas.

The Academy continues to enhance and operate one of the most extensive subsidised scholarship programmes in the country providing opportunities for hundreds of students who would otherwise be unable to afford such provision in music, sport, mathematics and art (including many eligible for the pupil premium). The average cost for each scholarship per student is in excess of £1,000 per annum. The impact and outcomes as a result of our scholarship programmes continues to be outstanding and can be exemplified by competitive sporting success at the highest level and musical and artistic progression to the most prestigious institutions.

Due to outstanding financial management the Academy continues to provide a diverse range of additional facilities and interventions to support individual students and those eligible for the Pupil Premium. This includes off site Annexe facilities, on-site Learning Support Unit, Ethnic Minority Achievement Department and a Conflict Resolution Centre.

We also operate:

- A comprehensive Gifted & Talented programme;
- One- to -one and one -to- many timetabled support lessons both pre and post 16;
- Saturday School for targeted students;
- Year 6 Summer School;
- Holiday Revision Classes;
- Educational and subsidised Trips of a Lifetime;
- School based mentoring and counselling service;
- A school transportation service

We have also employed a large number of additional Teaching Assistants to cater for specific learning needs including support for visually impaired students.

As a result of these interventions performance, attendance, engagement of many of our identified vulnerable groups often continues to match or surpass national expectations for these groups, sometimes significantly, as regularly reflected in measurable outcomes such as GCSE, A Level results, attendance and exceptionally low exclusion rates.

Estates Management

With respect to value for money in relation to estates management and safety, the Directors, in conjunction with the Academy, commissioned a full estate condition survey from our architects. The condition survey has formed the basis for a ten-year plan to maintain and improve the estate at a cost of over £7.5 million over the period. Our medium-term budget plan includes an annual expenditure of £1.0 million on such work for the foreseeable future. Cleaning, premises and maintenance contracts have also been under constant review and have been put out to tender to ensure best value moving forward.

In ensuring effective site management and risk mitigation, the Academy takes seriously the need to evidence good value for money. This is achieved in many principal ways including the following:

- Effective application of the Trust's financial purchasing procedures, e.g. preparing and obtaining sufficiently detailed specifications and quotes/tenders etc., for tradespersons employed on site;
- Judicious use of a qualified in-house maintenance team;
- Engagement of a multi-disciplinary professional health and safety advisory company, Judicium Education Ltd;
- Highly effective and targeted online training made accessible to all staff;
- Value for money contracted services for key areas, e.g., fire alarm, burglar alarms;
- Investing in supporting the ongoing training, development and expertise of an in-house Health & Safety Key Officers Team.

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an on-going process designed to identify and prioritise the risks to the achievement of academy trust policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in The Kingsdale Foundation for the period 1 September 2022 to 31 August 2023 and up to the date of approval of the annual report and accounts.

Capacity to handle risk

The board of directors has reviewed the key risks to which the academy trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The board of directors is of the view that there is a formal ongoing process for identifying, evaluating and managing the academy trust's significant risks that has been in place for the period 1 September 2022 to 31 August 2023 and up to the date of approval of the annual report and accounts. This process is regularly reviewed by the board of directors.

The risk and control framework

The Academy Trust's system of internal financial control is based on a framework of receiving regular management information and sound administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes responsibility for ensuring that the Academy:

Keeps proper accounting records during the year which will disclose, with reasonable accuracy and at anytime, the financial position of the Academy in accordance with relevant guidelines.

Maintains and operates an effective system of internal control to safeguard all the resources delegated, granted or otherwise entrusted to the Academy and ensure they are used cost effectively. The system of internal control is co-ordinated by the Head Teacher. It aims to provide as much assurance as is reasonably possible (not absolute assurance) that assets are safeguarded, transactions are properly authorised and recorded and that material errors or irregularities are either prevented or can be detected promptly.

Our review of the effectiveness of the systems of internal control is informed by:

- Our regular scrutiny of financial and other performance monitoring data;
- Regular reports from our Financial Consultants and the Head Teacher to the Board of Directors;
- Internal Scrutiny Reports;
- Our most recent self-evaluation of the internal controls undertaken;
- Comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the Board of Directors;
- Regular reviews by the Finance & Premises Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes;
- Monthly financial reviews by the Chair of the Trust Board and the Chair of the Finance & Premises Committee;
- Setting targets to measure financial and other performance;
- Clearly defined purchasing (asset purchase or capital investment) guidelines;
- Delegation of authority and segregation of duties;
- Identification and management of risks

The Board of Directors has considered the need for a specific internal audit function and outsourced our Internal Scrutiny function to Strictly Education. The scope of the completed reviews undertaken covered two major areas; Governance Structure & Process and Cyber Security. Two independent Internal Scrutiny Reports have been submitted to the Board of Directors. The work was delivered as planned. The overall summary and opinion was substantial assurance in both areas. Nevertheless, the Directors have retained Mrs P. Mazhude, a Co-Opted Governor, as Responsible Officer for Internal Scrutiny (RO) who is supported by a qualified accountant (Director). The internal RO's role includes giving advice on financial matters and ensuring outsourced services for Internal Scrutiny perform a range of checks on the Academy Trust's financial systems. The discharge of the Governing Body's financial responsibilities are considered by the Finance & Premises Committee and the Governing Body/ Audit Committee.

Review of effectiveness

As accounting officer, the Head Teacher has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

- the work of the [internal auditor/reviewer];
- the financial management and governance self-assessment process or the school resource management self-assessment tool;
- the work of the executive managers within the academy trust who have responsibility for the development and maintenance of the internal control framework;
- the work of the external auditor
- correspondence from ESFA, eg financial notice to improve/notice to improve (FNtI/NtI) and 'minded to' letters.

Opinion

Accordingly, we do not express a positive opinion.

Our engagement includes examination, on a test basis, of evidence relevant to the regularity and propriety of the academy trust's income and expenditure.

Our work included identification and assessment of the design and operational effectiveness of the controls, policies and procedures that have been implemented to ensure compliance with the framework of authorities including high level financial control areas and areas assessed of presenting a higher risk of impropriety. We undertook detailed testing, based on our assessment of risk of material irregularity, where such controls, policies and procedures apply to classes of transactions. This work was integrated with our audit on the financial statements to the extent evidence from the conduct of that audit supports the regularity conclusion as well as additional testing based on our assessment of risk of material irregularity.

1 Accounting policies

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgements and key sources of estimation uncertainty, is set out below.

1.1 Basis of preparation

The accounts of the academy trust, which is a public benefit entity under FRS 102, have been prepared under the historical cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2022 to 2023 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

1.2 Going concern

The directors assess whether the use of going concern is appropriate, ie whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the charitable company to continue as a going concern. The directors make this assessment in respect of a period of at least one year from the date of authorisation for issue of the accounts and have concluded that the academy trust has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the academy trust's ability to continue as a going concern. Thus they continue to adopt the going concern basis of accounting in preparing the accounts.

1.3 Income

All incoming resources are recognised when the academy trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

Grants

Grants are included in the statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the statement of financial activities in the period for which it is receivable, and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grants are reflected in the balance sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

Sponsorship income

Sponsorship income provided to the academy trust which amounts to a donation is recognised in the statement of financial activities in the period in which it is receivable (where there are no performance-related conditions), where the receipt is probable and it can be measured reliably.

Donations

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

Other income

Other income, including the hire of facilities, is recognised in the period it is receivable and to the extent the academy trust has provided the goods or services.

1 Accounting policies

(Continued)

Donated goods, facilities and services

Goods donated for resale are included at fair value, being the expected proceeds from sale less the expected costs of sale. If it is practical to assess the fair value at receipt, it is recognised in stock and 'Income from other trading activities'. Upon sale, the value of the stock is charged against 'Income from other trading activities' and the proceeds are recognised as 'Income from other trading activities'. Where it is impractical to fair value the items due to the volume of low value items they are not recognised in the accounts until they are sold. This income is recognised within 'Income from other trading activities'.

Donated fixed assets

Donated fixed assets are measured at fair value unless it is impractical to measure this reliably, in which case the cost of the item to the donor is used. The gain is recognised as income from donations and a corresponding amount is included in the appropriate fixed asset category and depreciated over the useful economic life in accordance with the academy trust's accounting policies.

1.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement, and the amount of the obligation can be measured reliably.

Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges are allocated on the portion of the asset's use.

All resources expended are inclusive of irrecoverable VAT.

Expenditure on raising funds

This includes all expenditure incurred by the academy trust to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Charitable activities

These are costs incurred on the academy trust's educational operations, including support costs and costs relating to the governance of the academy trust apportioned to charitable activities.

1.5 Tangible fixed assets and depreciation

Assets costing £1,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the balance sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding that require the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the statement of financial activities and carried forward in the balance sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the statement of financial activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

Depreciation is provided on all tangible fixed assets other than freehold land, at rates calculated to write off the cost of each asset on a [straight-line/reducing balance] basis over its expected useful life, as follows:

Freehold buildings	2%
Computer equipment	33%
Fixtures, fittings & equipment	20%
Motor vehicles	20%

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the statement of financial activities.

1.6 Liabilities

Liabilities are recognised when there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the academy trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

1.7 Leased assets

Rentals under operating leases are charged on a straight-line basis over the lease term.

1.8 Financial instruments

The academy trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the academy trust and their measurement basis are as follows.

Financial assets

Trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at face value.

Financial liabilities

Trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost. Taxation and social security are not included in the financial instruments disclosure definition.

Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument.

1.9 Stock

Stock is valued at the lower of cost and net realisable value. Net realisable value is based on estimated selling price less further costs to completion and disposal. Provision is made for obsolete and slow moving stock.

1.10 Taxation

The academy trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the academy trust is potentially exempt from taxation in respect of income or capital gains received within categories covered by chapter 3 part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

1.11 Pensions benefits

Retirement benefits to employees of the academy trust are provided by the Teachers' Pension Scheme ('TPS') and the Local Government Pension Scheme ('LGPS'). These are defined benefit schemes and the assets are held separately from those of the academy trust.

The TPS is an unfunded scheme and contributions are calculated to spread the cost of pensions over employees' working lives with the academy trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary based on quadrennial valuations using a prospective unit credit method. The TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions are recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the academy trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high-quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to net income or expenditure are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the statement of financial activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses. Actuarial gains and losses are recognised immediately in other recognised gains and losses.

1.12 Fund accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the academy trust at the discretion of the directors.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the [Department for Education Group].

2 Critical accounting estimates and areas of judgement

Accounting estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions

The academy trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

2 Critical accounting estimates and areas of judgement

(Continued)

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 20, will impact on the carrying amount of the pension liability. Furthermore, a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2023. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

The pension value also includes an asset ceiling adjustment and the assumptions used to calculate this are:

- The scheme is open to new entrants;
- There is a minimum funding requirement in relation to the LGPS;
- There is the ability to recover a surplus through the ability to reduce future contributions (not refund)
- In calculating the surplus, the present value of current and past service costs is offset against the future contributions over the future period;
- The present value in the above calculations are calculated using an annuity representing participation into perpetuity.

Critical areas of judgement

Useful economic lives of tangible assets

The annual depreciation charge for tangible assets is sensitive to changes in the estimated useful economic lives and residual values of the assets. The useful economic lives and residual values are reassessed annually. They are amended when necessary to reflect current estimates, based on technological advancement, future investments, economic utilisation and the physical condition of the assets. See note 12 for the carrying amount of the property plant and equipment, and note 1.5 for the useful economic lives for each class of assets.

Bad debts

Debtors are regularly reviewed for recoverability, any debts which in the opinion of management are not recoverable are provided for as a specific bad debt.

There are no key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

20 Pension and similar obligations

The academy trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by the London Borough of Southwark. Both are multi-employer defined benefit schemes.

The latest actuarial valuation of the TPS related to the period ended 31 March 2016, and that of the LGPS related to the period ended 31 March 2019.

Contributions amounting to £207k were payable to the schemes at 31 August 2023 (2022: £176k) and are included within creditors.

Teachers' Pension Scheme

Introduction

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for teachers in academy trusts. All teachers have the option to opt out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary. These contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

Valuation of the Teachers' Pension Scheme

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019.

The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% employer administration charge)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million, and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI. The assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2024.

The employer's pension costs paid to the TPS in the period amounted to £1,811k (2022: £1,794k).

A copy of the valuation report and supporting documentation is on the Teachers' Pensions website.

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The academy trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The academy trust has set out above the information available on the scheme.

Local Government Pension Scheme

The LGPS is a funded defined benefit pension scheme, with the assets held in separate trustee-administered funds. The total contributions are as noted below. The agreed contribution rates for future years are % for employers and % for employees.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013 and on 21 July 2022, the Department for Education reaffirmed its commitment to the guarantee, with a parliamentary minute published on GOV.UK.
