

WaterBear Pitch 2021 Terms and Conditions

1. The promoter is WaterBear, 105-107 Herengracht, Amsterdam, 1015 BE
2. The competition is open to anyone who is aged 18 years or over except employees of WaterBear or Sheffield Doc/Fest and their close relatives and anyone otherwise connected with the organisation or judging of the competition.
3. There is no entry fee and no purchase necessary to enter this competition.
4. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
5. Route to entry for the competition and details of how to enter are via the Sheffield Doc/Fest website.
6. Closing date for entries will be Friday 14 May 2021. After this date, no further entries to the competition will be permitted unless at the discretion of Sheffield Doc/Fest and WaterBear.
7. We do accept multiple entries.
8. No responsibility can be accepted for entries not received for whatever reason.

The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control. Any changes to the competition will be notified to entrants as soon as possible by the promoter.

17. The winner will be notified on the day of the Pitch.
18. The promoter will notify the winner when and where the prize can be delivered.
