- 4) Arrange for all players and team officials to register on https://brha.co.uk/register.

Applying for Disclosure and Barring Service (DBS) Enhanced Check

Who needs to apply?

All team officials over the age of 16 with under 18 players registered to their team of all age groups

When do I need to do it?

All registered team officials should apply without delay.

What happens if I do not hold a valid DBS Enhanced reference?

Without exception, all team officials must not enter changing rooms and other areas where safeguarding is put at risk until a valid DBS Enhance check is held.

Where do I record my DBS Enhanced reference number?

You can enter this in the DBS field when registering at https://brha.co.uk/register.

Can I use a DBS check from another organisation?

Yes, but it must be DBS Enhanced and so-called 'portable' so the BRHA can check the status via the Government's website. Anyone without a portable DBS Enhanced check must apply.

How much does it cost and how do I pay the fee?

As this is voluntary work, there is a nominal fee of £10. This is cost price and the BRHA does not make any money on this. The fee will be charged to your Sportily profile and you will receive an invoice BRHA National Executive Committee to pay via bank transfer (BACS) within 7 days of receiving the

What proof of identification can I use? Please be prepared to upload two forms of ID. For a full list of accepted documents, visit ID checking guidelines for standard/enhanced DBS check applica-

If you enter this incorrectly then we may still be charged, and this cost will be passed on to you as the applicant:
