For any Dispute that proceeds in court rather than through arbitration, such Dispute will be initiated or prosecuted in state and federal courts located in Minnesota. Parties hereby agree to and waive all defenses of lack of personal jurisdiction and forum non conveniens concerning venue and jurisdiction in these courts.

The Parties agree that the following are not covered under the aforementioned binding arbitration clause:

Disputes regarding intellectual property rights
Allegations of theft, piracy, invasion of privacy, or unauthorized use
Claims for injunctive relief
