# 6. Approval of the WBSC Europe Statutes and Code of Divisions

- The WBSC Europe Statutes amendments and the Code of Divisions which were sent to the MF's prior to the Congress are up for approval.
- The MF's were given a short summary of the current situation and discussions that were held with MF's on February 7.
- Decision by WBSCE EB after discussions and consultations propose to the Congress to Approve the proposed Statutes and Code of Divisions with the following changes:
  - Upon the recommendation and agreement of the WBSC, WBSCE Statutes
     Art. 14.1 will be based on the proposed WBSC draft Art 13.1 13.3, with the
     exception that there will be three members at large for Softball and Baseball
     respetively, which will ensure the legal formality for the formation of the
     Executive Board from 2021 and onwards.

The Statutes amendment and Code of Divisions are **approved by unanimous vote of the Congress Delegates.** 

The new version of the WBSC Europe Statutes and Code of Divisions are on the respective Baseball and Softball Europe websites.
