Kick-off Week Agreement

1. Purpose of the Kick-off Week Agreement

The purpose with this agreement is to clarify the purpose of EHVS Kick-off Week. The agreement shall provide guidance in the process of arranging EHVS Kick-off as well as concretize the responsibilities for the Kick-off committee, and kickers during, the Kick-off Week.

2. Guidelines for the Kick-off Week

2.1. The Kick-off Week

§ 1 The Kick-off Week shall be arranged in line with EHVS overall strategies as well as other policies, particularly the Alcohol and Drug Policy.

§ 2 The Kick-off Week is arranged for EHVS members only.

§ 3 No games or competitions arranged during the Kick-off Week shall conflict with existing laws, regulations or policies that EHVS operates under. All coercion, bullying, discrimination or violation of individual privacy is strictly prohibited. Games and competitions arranged by EHVS shall not force someone to do anything against their will.

§ 4 The Kick-off Week shall include at least one sober half day.

2.2. Kickers

§ 5 The Kickers are responsible for taking care of an assigned group of Nollor and ensure that all Nollor will receive a warm welcome and feel included during EHVS Kick-off Week.

§ 6 All Kickers shall be well informed and have a good understanding of the policies communicated by the Kick-off Committee.

§ 7 All Kickers must participate in the Fadder education held by Studenthälsan. If a Kicker doesn't attend the Fadder education, this Kicker becomes directly liable to pay any expenses which their absence may create. They must also read through and sign this agreement that includes further details and guidelines about the week. This in order to give the Kickers an understanding of the responsibilities it means to be a Kicker. This needs to be done prior to the week.

§ 8 The Kickers shall always be good representatives for EHVS during all the events during the Kick-off Week.

§ 9 The Kickers are responsible for the Nollor from the morning when the daily activities start until it's bedtime.

§ 10 There must be at least one sober Kicker in each Kicker group that abstains from alcohol each full day.

§ 11 The Kickers must not take advantage of their position or exploit their power. Nollefrid shall be maintained during the entire week.



§ 12 All bongar are forbidden to use during the whole Kick-off Week, even in cribs, and the Kick-off Committee and Kickers are responsible of enforcing this.

§ 13 Kickers shall, during the Kick-off Week, convey EHVS traditions of sittningar in a responsible and proper way to the Nollor.

§ 14 Kickers shall attend their assigned work shifts, not doing so violates this agreement.

§ 15 Should kickers cause damage on property, the kicker becomes directly liable to any expenses following this event.

§ 16 Under no circumstances is it allowed for a Kicker or Nolla to talk to media. No one other than President of EHVS and the Kick-off General is allowed to talk to media during the week.

§ 17 The Kickers must at all time provide water for their group.

§ 18 Kickers must all have a good attitude towards other Student Unions and towards all members of EHVS.

§ 19 No alcohol is allowed in Linnéuniversitetets buildings during work hours.

§ 20 According to Alkohollagen 3 kap, 9§ - *“Alkoholdrycker får inte lämnas som gåva eller lån till eller bjudas den som inte har fyllt 20 år. Det är dock tillåtet att bjuda den som inte har uppnått föreskriven ålder på en mindre mängd alkoholdryck under förutsättning att förtäring sker på platsen och under ordnade förhållanden samt det med hänsyn till den unges ålder och utveckling och omständigheterna i övrigt framstår som försvarligt.”*

§ 21 Drugs are strictly forbidden during the Kick-Off week. It is stated in Swedish law that all use, selling and other handling of drugs are illegal, and therefore all drug-related acts during the week will be reported.

§ 22 The Kicker must always comply with what is stated in this agreement and if instructed listen to The Kick-off Committee's instructions. If a Kicker violates this agreement the Kick-off Committee and the Board of EHVS, have the right to exclude the Kicker from the week.



EHVS reserves the rights to act in situations not included in this agreement.
