Each option can BENEFIT from archiving or decommissioning


### **Identify** the savings



### **ARCHIVING:-**

- 1/. Reduces Data Volume
  - a/. Saves on storage maintenance
  - b/. Saves on storage licensing
  - c/. Saves on storage administration
- 2/. Secures Data Integrity
  - a/. Logical file structure/naming convention
  - b/. Relevant data locked against time
- 3/. Enables Long-Term Retention
  - a/. Secure & Access-controlled
  - b/. Not readable, other than originating system






In 2015 TJC started the archiving of the ECC system as Carlsberg consolidated multiple systems across multiple countries into a Central single system:


- The archiving allowed large volumes of data to be migrated in to the new system
- The reduction of data volumes retained the performance for the company's salesforce to retain order processing
- The reduction of data ensured the in place infrastructure accommodated the migrated data volume





### From December 2015

### To August 2019






From Dec 2015 to Aug 2019 the volume saving is over 15TB.

- That's in the LIVE PROD DB
- Plus the same in DR site
- Plus the same in Pre-PROD
- Plus proportionally more in Quality & Development

In Excess of 50 TB volume saved






## Reduces Data Volume – 50TB in this case

a/. Saves on storage maintenance

b/. Saves on storage licensing

c/. Saves on storage administration

Usually these 3 are accumulatively counted at £50/GB = £2.5Million??






#### Plus

- a/. Savings on back-up times
- b/. Savings on restore times
- c/. Savings on storage energy

So how much more can be added to this £2.5Million???

Each Company has its own profile but it is significant

- 2/. Reduces Backup/Restore times
- 3/. Reduces Eco/Power/Air-Con costs
- 4/. Removes infrastructure/Operating System costs

### The BIG Comfort Factors



S4 can read all archive files from ECC

Data retention is secure and archive files are "unreadable".

GDPR retention/destruction can be improved by using archive files

Tax/Compliance/Regulation – easier - 100% of data available to respond
