Introduction from Indigo

Katy Raines Founder & CEO The results of this year's *Act Green* clearly show what audiences and visitors perceive the role of cultural organisations to be in tackling the climate emergency. They have high expectations for what organisations should be doing to reduce their own carbon emissions, and how they should be facilitating conversations and inspiring action in their communities.

There is a challenge for organisations to effectively communicate what they're doing and engage audiences to help them reach their sustainability goals through provision of information and infrastructure, as well as taking a creative role in imagining a different future for us all.

We are so grateful to the 86 cultural organisations who took part in Act Green 2023, and to research sponsors Supercool whose support meant we could offer the research free to the sector.

This was a collective effort, and we hope the results will benefit the whole sector.



Introduction from research sponsors Supercool



SUPERCOOL. Kate Mroczkowski Strategy Director Understanding what your audiences expect, and would like you to do, when it comes to the climate crisis helps cultural organisations join up sustainability goals with your audience engagement and development goals.

In the current climate it can be overwhelming. Where do you start? And how do you enact meaningful change when resources are limited and there are long to-do lists to get through? Last year's *Act Green* gave us all a starting point, a clear direction on what matters most to our audiences.

The data shows that audiences still feel cultural organisations have an important role to play in influencing society about climate change. And 52% of audiences would be willing to support fundraising activity focused on the climate crisis. But balancing audience perceptions with impact can be challenging. But once we know what audiences expect, we can educate and inform, reducing our impact on the planet whilst meeting audience expectations.

At Supercool, we take great care in treading lightly on the planet and help our clients to do the same. Supporting this research is a great opportunity for us to have a meaningful impact on the cultural sector. We hope everyone benefits from the findings and resources in the report.



Context

In May 2022, Indigo Ltd released the results of the first *Act Green* survey. Its aim was to understand more about what audiences expected from cultural organisations in tackling the climate emergency, and what part they were willing to play.

The results of the 2022 *Act Green* have been used widely by organisations to inform their communications strategies, by Theatre Green Book and to inform a new pilot project funded by Arts Council England exploring sustainable audience travel.

In running *Act Green* again, we aimed to generate responses from a wider range of cultural attenders and sought particularly to involve museums, galleries and cinemas in addition to performing arts organisations. We are pleased to have achieved that.

As audience specialists, we want to empower the whole sector with an understanding of audiences, helping to improve communications with audiences and increase audience engagement with and awareness of sustainability initiatives.

Methodology

Cultural organisations in the UK, including theatres, arts centres, festivals, touring companies, museums and galleries, were invited to participate in the Act Green research. The research was open to all cultural organisations in the UK, and it was free for organisations to take part.

Organisations were each provided with a unique link to send out to a recommended sample of around 3,000 - 5,000 of their previous attenders. They were provided with a link to see the results from their own organisation in real time, and the results from all organisations were then aggregated to form the baseline data set.

The survey ran throughout July 2023 and during that month, 17,479 complete responses were gathered through 86 cultural organisations.

Act Green 2023: Summary findings



Cultural audiences and visitors are <mark>concerned about the climate emergency</mark> and the majority have made changes to their lifestyle to help tackle it.

They think <mark>organisations are not doing enough</mark> or feel that they are not communicating what they are doing effectively.



Audiences and visitors want to play their part to help organisations fulfil their sustainability goals but need information and infrastructure to help them do that.



Audiences see cultural organisations having a role in leading the way and facilitating conversations about the climate emergency – but they don't want to feel they are being told off or 'preached at'.



Audiences recognise the unique power cultural organisations hold, both individually and collectively, to influence society at all levels.







Participating organisations: location and types






Types of participating organisation









Respondent profile: age, ethnicity, children under 16




Do you have children under 16 living with you?








Respondent profile: gender and disability



Do you identify as a D/deaf or D/disabled person, or have a long term health condition?






Respondents are frequent attenders who go to a wide range of types of cultural events

How frequently would you say you attend arts and cultural events or venues?




Which artform do you tend to go to most regularly?

Section 2

Cultural audiences and the climate emergency

How concerned are cultural audiences about the climate emergency?




Key findings:

- 88% of cultural audiences are worried about the impact of climate change, compared to 76% of the general population.
- Concern is high across all age groups, though there is slight variation by age – 92% of Under 35s are worried compared to 87% of over 55s are worried.
- **93%** of respondents have made changes to their lifestyle to tackle climate change.




Cultural audiences are more concerned about the impact of climate change than the general population and concern has grown slightly since the previous *Act Green* survey in 2022






Respondents aged under 35 are most worried – but there is not a huge variation by age, with 87% of over 55s somewhat or very worried




To what extent have you made changes to your lifestyle to help tackle climate change?

A small number are concerned that 'sustainable alternatives' are actually worse for the environment:

"Many of the supposed eco technologies are not actually eco-friendly and are not as energy efficient as existing technology."

"I believe some alternatives are more damaging."

Data note: These are responses to the 'Other' option of the previous question, which was only asked to those who are neutral or not worried about the impact of climate change

Others feel they cannot make changes as the infrastructure is not there to allow them:

"Living in a rural area, with little public transport, change is more difficult."

"It is just not practical (e.g. taking public transport to work), or it is unsafe (e.g. cycling)."

"I am a single house occupier on limited income – my old property is difficult to improve."



Section 3

The role of cultural organisations

What role do audiences expect the organisations they attend to play in tackling the climate crisis?




Key findings:

- 77% of cultural audiences think cultural organisations have a responsibility to influence society to make radical change to address the climate emergency – including 85% of under 35s.
- **Only 17%** think cultural organisations place great importance on playing an active role in tackling climate change.
- When asked to say how much importance the organisation who sent them the survey places on playing an active role in tackling climate change,
 25% said they don't know.

To what extent do you agree with the following statement? "Cultural organisations have a responsibility to influence society to make radical change to address the climate emergency"




To what extent do you agree with the following statement? **"Cultural organisations have a responsibility to influence society to make radical change to address the climate emergency"**


Thinking generally about the cultural organisations you visit, how much importance do you think they place on playing an active role in tackling climate change?


Thinking generally about the cultural organisations you visit, how much importance do you think they place on playing an active role in tackling climate change?





When asked about the specific organisation who sent them the survey, 25% of respondents said they don't know how much importance they place on tackling climate change


Thinking specifically about the organisation who sent you this survey, how much importance do you think they place on playing an active role in tackling climate change?

Section 4

Organisations and sustainability initiatives

What sustainability initiatives do audience members expect from cultural organisations and which do they think are the most important?



Key findings:

Respondents had high expectations in many areas – in particular:

- 94% expect organisations to be reducing and recycling waste.
- **93%** expect organisations to ensure they are as energy efficient as possible.
- **91%** expect them to ensure materials are reused after an event or exhibition.
- **90%** think organisations should avoid disposable packaging and single-use plastic.
- **89%** think they should minimise food waste.
- **88%** expect organisations to provide designated recycling bins.














































5,788 – **33%** of the total survey respondents – wrote a response to what role they thought cultural organisations had in tackling climate change. **6%** of these were from under 35s, **67%** from those aged over 55 and the remainder 35-54.

Many see the role of cultural organisations to lead, share best practice, provide information and facilitate conversations in this area:

"Cultural organisations are in a position to influence large numbers of people. They have a duty to maximise that position."

"Cultural organisations are trusted influencers in communities, they are well placed to increase awareness of the urgency and devastation of climate change and engage communities in ways they can make a difference. Crucial work."

"A cultural organisation should be the heart of the community and therefore has a duty to inform and support the community in tackling climate change."

"Conversation is key but also helping others in finding ways to be sustainable is also important."

Cultural organisations play a vital role in addressing climate change. They should influence public opinion through creative expressions, educate about climate issues, lead by example with sustainable practices, and foster collaborations across sectors."

Respondents highlighted the need for <mark>sustainability to go across all aspects</mark> of an organisation's work:

- l "It's eve
 - "It's important to embed good climate-friendly practice in every aspect of the working life of a cultural organisation."
- "Role must be naturally part of everyday running of the organisation not a "tacked on piece of marketing" to have maximum impact on audiences and contribute to tackling climate change."

And were glad it was being engaged with:

"I see it as really important that you have offered this survey."



But some want to know more about what is being done:

"I think some organisations have made some great progress in this space in recent years, but there is not enough explanation about why they're doing it."

"I want to see organisations signposting and celebrating the changes they make to ensure these are visible to audiences."

Another main theme that emerged was that, although people expected organisations to be taking action to tackle climate change, they didn't want to be lectured or preached to:

"I think that you should manage your business in a sustainable way, but it is not your role to preach a certain set of values to your audience, no matter how well meaning you may be."

"I would expect cultural organisations to run their own businesses as sustainably as possible as I've indicated. But I wouldn't want to be lectured every time I visit a cultural event."

There was a number of respondents who thought it was not the role of cultural organisations at all, and they should concentrate on their core mission, although they had different reasons for this response:



Stick to artistic work. Don't waste money on this subject."

"I feel it is important for visitors to enjoy cultural organisations without feeling pressure or guilt about tackling climate change."

A minority denied climate change exists, although interestingly, this minority was divided. There were many saying they didn't believe in climate change, but still expect organisations to take action to fight pollution, reduce waste or make energy savings – sustainable practices under a different banner:

"Apart from minimising waste, recycling and being as energy efficient as possible, I don't think cultural organisations should get involved in tackling climate change. It's just the latest fad!"

Concentrate on what you're there for - culture, not politics. Many of the actions described are good, but as responsible actions towards sustainability and recycling, etc, NOT climate change."

These responses show that choosing how and when to inform audiences about sustainable actions will be key, as will highlighting the co-benefits of particular actions, such as the amount of landfill saved from recycling, rather than overtly linking everything to the climate emergency.

Many respondents gave specific, practical suggestions which tied in with the other survey questions, often linking to their knowledge of particular venues or their own interests, for example installing solar panels or recycling sets or more plant-based menu options.



Ethical funding, suppliers, pensions and finances also appeared, although this was commented on predominantly by the over 55 age group:

"Be transparent about sources of funding - actively resisting unethical sources of funding."

"They should also take care to have ethical sponsorship."

Additionally, there were comments suggesting more digital performances, which have decreased since covid, to aid accessibility and reduce CO_2 travel impacts:

"Perhaps more rural towns could access live streaming of London shows. It brings the world nearer without the carbon footprint."

"Provide more digital performances such as were available during lockdown to minimise carbon footprint."

The theme of public transport was picked up by many respondents particularly thinking about start / end times of performances to correspond with local public transport provision and the possibility of discounts on either local transport or ticket discounts for using public transport:

"Offer discount if travelling by train, bus or tram."

"Events should be timed to fit in with public transport as much as possible."

"Where practicable having matinee performances which enable audience members to use public transport." Other responses illustrated the challenges faced by arts organisations particularly in communicating their environmentally sustainable activities. <u>Virtue signalling</u>, the attempt to demonstrate that you are virtuous to others by expressing opinions that appeal to them, is mentioned:

- "All organisations should be prepared to use common sense decisions to avoid waste, use less energy etc. However, they should avoid virtue signalling."
- "Although I think any organisation should be aiming to reduce carbon output I do worry about virtue signalling. So it's important to be rigorous about the value of specific initiatives."

As is the need for organisations to ensure their actions are not greenwashing:

"We all have a responsibility to become a 'greener' user of the earth and cultural organisations can also do this - but no greenwashing please!"

There are examples cited of specific organisations' actions or inaction which don't correspond with their claim to be acting sustainably:

"Why do you have an ad promoting a hired car below this questionnaire!"

"Stop using single use plastic cups!"



Other key themes appeared that weren't directly covered elsewhere in the survey.

This included the idea that arts organisations could use their influence to lobby local and national government and businesses about sustainable legislation and actions. There was a specific emphasis on lobbying or liaising to provide better public transport, which would help audiences to travel more sustainably to venues:

"Also lobby the government, as they will make the big changes with industry and manufactures."

"Work with other organisations to lobby government to improve public transport."

"I would also expect them to lobby local councils etc. to ensure that things like good public transport, particularly late at night, is available."

There were acknowledgments of the costs linked to certain sustainable plans with some responders suggesting there would be the need for specific funding to support these actions and others worrying that this may mean an increase in ticket prices or that it would make an organisation less financially robust.

"Arts organisations need support from stakeholders / funders / government to be able to do these things."

Like all organisations cultural organisations should consider how to be as sustainable and environmentally friendly as possible - but not to the detriment of their core business or viability of the operation. A balanced approach should be taken."

"I would not want hard pressed cultural organisations to take on policies that commercial organisations are not following if that increases costs that exclude those on lower incomes from accessing the arts."

There were references to collaboration with other arts organisations, local groups, businesses or universities to share best practice, learn new ways of working and tap into expertise.




"They should work together in their locality to share resources, information, funding options."

"I'd love to see cultural organisations engaging with other organisations locally to work together to improve sustainability in their community. For example, working with councils to improve active and public transport options, or with local schools to use the arts to engage young people with these issues."

Although digital programmes and tickets were seen as important, many comments acknowledged that some people did not have the equipment or know-how to access these, so moving solely to digital could be discriminatory:



"Please do not go cashless/digital completely-doing so excludes people who cannot access banks/smartphones."

Equally there was a call for organisations to take disabled patrons into consideration when making any changes:

"I would like you to consider accessibility when you look at transport. I am disabled and have little choice about driving to the venue."

"As a wheelchair user I feel that many of the initiatives leave disabled people out of this climate change agenda e.g. all transport options listed would not work for me."

Some respondents saw the need for staff training and Board level representation to ensure proactive buy-in and understanding of an organisation's environmental policy across the company:

"Appoint a trustee with responsibility for sustainability. Create a 'sustainability group' to help/inform the Board of Trustees of progress on initiatives/actions relating to sustainability."

"Cultural organisations need a programme to educate all staff and get them on board with 'why' take these measures." "Having sustainability staff who fully understand how to do this properly, and can innovate to make a difference, as well as not being afraid to shout about it to their supporters and customers."

And finally, the survey itself has made people think differently and respondents are grateful for organisations asking their opinion and acting:

"This is an excellent idea and has made me think about how I engage with the arts. Bravo!"

- "This is the first time I have thought about this and now realise our local cultural organisations certainly do have a role in tackling climate change."
- "This was an interesting survey as I had not previously thought about the potential or role of cultural organisations in tackling climate change. I think we all have a part to play, and as cultural organisations have the power to make us think and educate us through their productions/exhibitions, alongside the resources they use for these and for public consumption, I hope that they are all taking part."

Overall, it was clear that respondents want to come on the journey with the arts organisations they attend. Even those who are not as interested or were actively against the idea of climate change have certain expectations that environmentally sustainable practices are in place.



Section 5

Getting audiences involved

What part are audiences willing to play to support sustainability initiatives from the cultural organisations they visit?




Key findings:

- **51%** of audiences and visitors say they want to actively play their part in support a cultural organisations efforts to become more sustainable
- A further **29%** would make changes if it is easy and doesn't inconvenience them.
- When asked what they would do to support organisations, 91% would reduce their use of disposable packaging at the venue, 67% would choose more sustainable food options and 15% said they were quite likely to donate their time as a 'green volunteer'.



The majority of respondents said they were 'quite likely' to support the organisations they attend in a variety of ways


How likely is it that you would do any of the following to support cultural organisations to achieve their sustainability objectives? (% 'quite likely')

The free text responses were split into three groups: those already on board, those that needed specific reasons to motivate them and those who responded more negatively to the idea.

The first group felt they already acted sustainably and that everyone should be acting sustainably. They saw their motivation to be part of their way of living, not just linked to visiting cultural events:

"I try to act sustainably all the time, not just at events."

A small group of respondents highlighted future generations as their motivation to act sustainably:

"Thinking of future generation."

The second group all required a reason to motivate them. Many of these respondents specifically referenced public transport needing to change to enable them to act. This group included several responses from disabled visitors who felt their motivation to act sustainably was constrained by the options available to them:

"The availability of easy public transport would make a real difference"



Some of these options do not take into account people who have disabilities especially mobility issues."

Other respondents in this group either wanted to be shown or told why they should act sustainably to motivate them.

"Being shown by practical example how to reduce the impact I have on climate."

"I need more info around how to act sustainably."

And there was a further subsection who would only be motivated if cultural organisations were seen to be acting themselves.

"I can be active if I can see the organisation doing the same."


"Organisations need to show they are genuine for change."

The negative response group, which was in the minority, included those who thought it was not the organisation's role or that it was someone else's role or only the organisation's role to change, climate change deniers and those who thought it was too late.

26% of respondents gave comments in response to this question. **6%** of those who provided a comment were Under 35, **66%** were 55+ and the remainder 35-54.

The key themes that came out reflected the responses within the rest of the survey, although there seemed more support for some actions than other survey responses may have suggested.

The most common was to offer incentives in some way, especially discounts on tickets if a visitor had used public transport. Drinks discounts for reusable cups and free or discounts on digital programme also featured:

"Cheaper ticket prices for customers using public transport."

"Offer a discount for using own cups on drinks."

A sub-section within this group reiterated the suggestion of working with public transport providers to offer discounted travel on provision of a venue's ticket:

"Discounts with local bus/train companies as part of the ticket offer."

"Partnering with train companies to ensure that train timetables coincide with performance times, discounted or combined theatre and train tickets."

And others suggested playing with pricing to incentivise the sustainable options:

"Make less sustainable options more expensive."

Charge less for sustainable options."

The general provision of information, for example via websites, emails, around the venue and short films, was a popular response, with some people highlighting they didn't know what they could or should do:

"...it would be helpful for cultural organisations to provide inspiring materials regarding sustainability to visitors in an easily-digestible and easily-understood format."

"Provide active suggestions to audiences on how they can play their part. Don't assume people know, make sure you tell them."

In a similar vein, other respondents were more specific about wanting organisations to show what they were doing to support their environmental objectives so that they learnt more about what they could do this way:

"To openly share what they are doing, explaining why, and what visitors can do - and to be honest where they are failing or can do better (so that their messaging is believed)."

"The commitment needs to be visible, as does the request for help, so that audiences can unite in support. Share the success stories too."

"Being transparent about the work that the organising is doing too so that the responsibility isn't just being placed on audiences."

Communicate well and be transparent on what they're doing, what's working, what's not working and needs more focus, and what positive difference the actions can make."

Public transport or supporting active travel was another popular theme with both lobbying or liaising with public transport providers for better timings or transport provision and venues scheduling performances which fit better with public transport timings regularly cited again.

Plus providing information either on transport options or end times of performances to aid decision making:

"Programme around transport times or set up regional hubs with bus and train companies to ensure better travel."

C "De-emphasise car travel to venues and facilitate active travel with good facilities."

Work with local councils and transport companies to ensure public transport is always available to get people home after shows."

Lobby councils to improve evening / late night public transport."

Other respondents suggested making it easy or simple for audiences to be sustainable, with some people flipping this and suggesting organisations took away the unsustainable options, therefore making it easy by default:

"Sustainability needs to be easy, like only providing recyclable products / packaging."

"Make it easy. Where choices are removed, have somewhere or someone there to explain why."

"Don't give people options to do anything [other than the sustainable option] and make it easier for lower income people to be included / supported."

Linked to this, another theme was provision of facilities to enable patrons to be sustainable.

"More availability of recycling facilities."

- **6** "More plant-based options."
 - "Provide more charging points for electric cars."

"Provision of cycle racks."

Respondents also suggested <mark>engaging with or asking audiences</mark> what they thought:

Solicit ideas and participation from audiences. Let people contribute opinions and ideas (ideally in real life forums and situations rather than just online)."

"Ask for their views & communicate regularly on what is planned & how things are going."

Inclusion of climate change content within cultural programmes (although this seems more popular within exhibitions or visual arts); digital programmes and ticketing and using data to illustrate an organisations environmental impact were seen as important to some respondents:

- "More shows that explicitly address climate change as a topic."
- "Workshops, plays , which have the climate crisis as a core basis."
- "Regularly release reports on the results of its sustainability efforts in quantifiable presentations that are easy for the general public to understand."

The use of humour or introducing fun into engaging with the audiences was referenced too:

"Make it fun and stress the positives of a cleaner, carbon free future."

"Make it easy, make it fun."
