LOCATION





The property is situated at the overlap of the retail, office, leisure and newly defined 'Innovation District' in Leeds City Centre.

Town Centre House fronts several major bus routes and the main arterial road of Woodhouse Lane (to North Leeds), Great George St and Merrion St are also close, as well as Albion Street. It is just a 10 minute walk to Leeds Railway Station.

In addition to motorcycle parking and bicycle storage, there are 950 public car parking spaces in the CitiPark Merrion Centre car park which also offers plenty of spaces for the charging of electronic vehicles through CitiCharge.

This is located close to the Inner Ring Road for fast access to the rest of the city, M621 and the national motorway network beyond.

The location has benefited from significant investment in recent years with the £60 million development of the First Direct Arena which holds 13,500 people. This has acted as the catalyst for subsequent development projects with many new developments nearby including residential, university facilities, hotels, offices and the Arena Quarter

Town Centre House Innovative design and technology have been used throughout the construction of Town Centre House to achieve the highest environmental performance and standards including the award of an excellent BREEAM rating by the Building Research Establishment.

- The building has been stripped back to its frame and re-clad with locally sourced Yorkshire sandstone a material that achieves the highest possible rating for construction materials in the BRE's Green Guide to Specification.
- Low energy design significantly exceeds current requirements for energy performance of new buildings.
- Predicted CO2 emissions are 74% lower than a typical office development of the same scale.
- State of the art VRF cooling and heating system incorporates a heat recovery stage, reducing carbon emissions, and in use costs, still further.
- New cladding, increased levels of insulation and reduced air leakage all help to reduce heat loss and minimise operating costs.
- Passive infra-red (PIR) lighting system automatically switches off lights where no movement is detected. Lights also adjust to the level of natural light entering the building.
- A bio-diverse roof accounts for 72m2 of roof space.
- Over 453m3 of waste was removed from site during the refurbishment, 70% of which has been recycled.


