TERMS FOR RENTAL OF HIKING EQUIPMENT

- Pickup and delivery**
Pickup and delivery of equipment happens on monday between kl. 12-20 or thursday between kl. 12-19 at DNT Ringerikes office in Osloveien 10.
- Rental period**
The rental period applies per time, per weekend or by appointment. The rental period can not exceed one week.
- Payment**
Payment must be completed before you pickup the equipment at DNT Ringerikes office. We accept the use of Vipps or online banking.
- Cancellation**
Cancellation must be done 48 hours before agreed rental date for 100% refund of rental payment. For cancellations done less than 48 hours before will only 50% of rental payment be refunded.
- Extension of rental period**
If you wish to extend the rental period for the equipment, please take contact with us so we can check if the equipment is available for rental. On extension of rental period will follow the ordinary prices.
- Responsibility and risk**
Rental and all use of our rental equipment is on the customers own responsibility and risk. The customer carries the responsibility for loss or damage on the equipment which is rented under the whole rental period. The customer is personally responsible for insuring of the equipment or check if existing insurance covers loss, theft, fire or other types of unforeseen damage. DNT Ringerike is not responsible for the equipment or costs tied to loss or damage on individuals, property and similar which occurs by the use of our equipment.
- Self-check**
Upon receipt the rental equipment the customer is encouraged to take a thorough inspection of the equipment and check for eventual damages and functions before use. If there are any problems with the equipment, the customer must immediately report this to DNT Ringerike by e-mail. Complaints must be written within 24 hours after receipt of the rental equipment, or else it is assumed that the tenant finds the equipment to be OK.
- Use, storage and transport**
Relative to use, storage and transport of rental equipment the customer commits to:
 - take into consideration eventual guidelines from the producer delivered with the equipment.
 - not make changes, improvements or hire the equipment forward to others.
 - prevent that equipment is exposed to external factors which can affect the functionality or quality considerably, or expose it to such a considerable wear beyond what can be expected by normal use.
- Damage and compensation**
In case of damage to returned equipment that occur, DNT Ringerike must have carried out repairs in an expert manner. Costs for repair, including any postage and costs to and from the workshop are charged the customer. If repair is not possible or exceeds the value of the equipment itself, the customer is charged for the purchase of corresponding new equipment.
