3.1.1.1 NATURAL HAZARDS OVERVIEW

INTRODUCTION

Natural hazards pose major risks to people and property. They happen when a natural event such as a volcanic eruption affects people and their activities. It may lead to a natural disaster.

Types of natural hazards

Types of natural hazards include:

- Tectonic hazards volcanic eruptions, earthquakes and tsunami
- Weather hazards storms, droughts, flash floods

These hazards may in turn lead to further hazards such as landslides and flooding.

Hazard risk

The chance that a place will be affected by a natural event is known as the hazard risk. Sometimes this risk is closely related to natural factors such as a location being coastal, in the tropics or on a plate boundary. However, there are several human factors which can increase the hazard risk in a place:

- Poverty poor people may have to live in more risky places as land is cheaper.
- Urbanisation as people move into cities the pressure on land increases and people may be forced to live in areas which were previously thought to be too risky, such as steep slopes and floodplains.
- Farming farmers may choose to live on floodplains to benefit from the fertile soils, but this can also put them
- Climate change as global temperatures increase many places are seeing more extreme weather, including droughts, floods and intense storms. Also, the geographic patterns for climate hazards changes. This increases the hazard risk.

3.1.1.4 CLIMATE CHANGE

What you need to know

Climate change is the result of natural and human factors, and has a range of effects

Managing climate change involves both mitigation (reducing causes) and adaptation (responding to change)

INTRODUCTION

The climate of locations on the Earth is dependent on conditions in the atmosphere and the input of energy from the sun. The atmosphere is a mixture of gasses. Some of these gasses absorb heat and re-emit it in different directions – these are the greenhouse gasses. The most important greenhouse gasses are water vapour and carbon dioxide. The climate depends on the concentration of greenhouse gasses in the atmosphere and energy from the sun.

Climate change is the result of natural and human factors:

Evidence for climate change (Quaternary to present)

The quaternary geological period started 2.6 million years ago. Temperatures have fluctuated over this period, but the overall trend is that temperatures have cooled. However, during the last century there is evidence that temperatures have risen, with the global average temperature rising by 0.85°C since 1990.

Evidence for this climate change includes:

- Ice cores scientists drill into the Antarctic ice to remove cores of ice. They study the gasses trapped in these cores to calculate the temperature at the time the ice formed. Ice cores can be used to reconstruct temperatures going back 400 000 years.
- Pollen analysis scientists drill into deep soils and study the different types of pollen in the soil at different depths. This gives them information about the climate through time and also about how land was used.
- Thermometer readings reliable weather records began in the UK in 1910, so we can plot temperature patterns for the last 100 years.
- Glaciers & sea ice measurements such as the length of glaciers and the extent of sea ice provide evidence of the effect climate change is having. Arctic sea ice has thinned by 65% since 1975.
- Sea level the Intergovernmental Panel on Climate Change (IPCC) says that the average global sea level has risen 10-20cm in the past 100 years.

Natural causes of climate change

Natural causes of climate change include:

- Orbital changes: These are influenced by changes in the Earth's tilt, changes in the shape of the Earth's orbit (eccentricity) and the Earth's 'wobble' (precession). Changes in these factors are known as Milankovitch cycles after the scientist who plotted them. When these factors bring the Earth closer to the sun, there will be a period of warming and when the Earth is further from the sun there will be cooling.
- Solar output: A cycle of sunspot activity has also been identified by scientists. When there is more sunspot activity, the sun gives off more heat which leads to the Earth being warmer.

 Volcanic activity: When volcanos erupt ash into the atmosphere it can block out the sun, leading to a period of cooling. Volcanic eruptions release large amounts of carbon dioxide, increasing the level of greenhouse gasses in the atmosphere in the longer term.

Human causes of climate change

Since the industrial revolution in the 18th century, people have been burning fossil fuels for power. This releases carbon which was stored deep underground into the atmosphere in the form of carbon dioxide. There is over 99% agreement between scientists that these emissions have created an enhanced greenhouse effect and caused global

The main greenhouse gasses being added to the atmosphere due to human activity are:

Carbon dioxide: 64% of the enhanced greenhouse effect; produced by burning fossil fuels, deforestation and iron and steel production.

Methane: 18% of the enhanced greenhouse effect; produced by rotting vegetation in landfill sites, rice farming and livestock farming. Methane is a powerful greenhouse gas but only stays in the atmosphere for 12 years.

Nitrous oxides: 6% of the enhanced greenhouse effect; produced by fertilizer production and use, sewage treatment and various industrial processes. 300 times more effective in trapping heat than carbon dioxide.

Fluorinated Gases: Found in small concentrations in atmosphere, but 23 000 times more effective at trapping heat that carbon dioxide and stay in the atmosphere for up to 50 000 years. Produced by refrigerants, insulating gases and electronic cleaning.

Climate change has a range of effects

Effects of climate change which have already been observed include:

- Surface temperatures: Each of the last three decades has been warmer than any time since 1850. The warming is most noticeable in the northern polar region.
- Precipitation: Eastern North and South America, Northern Europe and Northern and Central Asia have got wetter. The Sahel, Southern Africa, the Mediterranean and Southern Asia have become drier. There has been a widespread increase in heavy precipitation events.
- Oceans: As they have absorbed carbon dioxide from the atmosphere oceans have become more acidic as well as becoming warmer due to global warming. There is more water in the oceans as glaciers and ice caps have melted and the ocean water takes up more space due to thermal expansion.

Effects on people

Climate change will bring both challenges and opportunities for people:

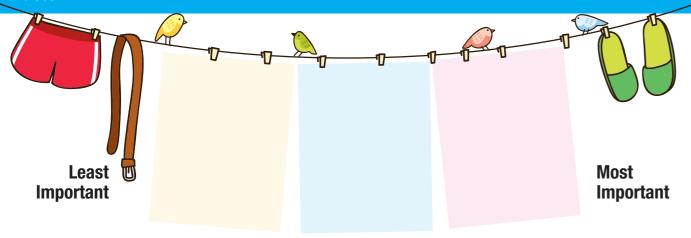
- Opportunities: As there is less sea ice in the Arctic, it is easier to transport goods from Asia to the USA via ships. Areas previously covered in ice will become available for farming.
- Challenges: Crop productivity will decrease in the tropics, leading to hunger. Changes in precipitation will mean some areas suffer floods whilst others face droughts. Desertification will accelerate in the Sahel. Diseases such as malaria and dengue fever will affect areas which were previously too cool and areas suffering floods will see more cases of diarrhoea. Low lying coastal areas will be at increased risk from flooding. People living on small islands find their water supplies contaminated with salt and are at increased risk from storm surges.

Example: Impact of climate change in Africa: Most areas are seeing less rain meaning that by 2020, 75-250 million people will be exposed to water stress. The crop yields in areas depending on rain for farming could decrease by 50%. Sea level rise will affect cities such as Alexandria, Cairo, Lomé and Lagos.

Kilim Karst Geoforest Park is an example of an ecotourist destination in Malaysia, where tourists can take a boat trip along the river to see wildlife ranging from macaque monkeys and eagles.

National parks such as Taman Negara in Malaysia educate local people and visitors about the value of the rainforest and the importance of using it

A technique introduced in Malaysia in 1977 which involves only cutting down some of the trees and planting saplings in places where trees are cut down.

Some countries have agreed to reduce debts owed to them by other countries if they agree to protect their rainforests. This is known as a debt-for-nature swap and was first used by Bolivia.

The Forest Stewardship Council (FSC) promotes sustainable forestry. If wood has a FSC label, buyers know it has come from sustainably managed forests.

3.1.3 PHYSICAL LANDSCAPES IN THE UK

3.1.3.1 UK PHYSICAL LANDSCAPES

What you need to know

The UK has a range of diverse landscapes

INTRODUCTION

The UK has many different landscapes, including upland and lowland areas. River systems play an important role in the UK landscape. The distribution of uplands and lowlands is largely influenced by geology, by volcanic history and by glacial processes that saw much of the UK covered in ice during the last Ice Age. Weathering over the ages produces distinct landscapes, and the UK's climate and soils vary to influence land use, ecosystems and the biosphere.

If you were to imagine drawing a line from the River Tees to the River Exe, then areas northwest of this line are generally considered to be uplands while the areas to the southeast are typically lowlands. This does not mean there is no high ground at all, just that it is not so high as true uplands. There is a general correlation between the highlands of the UK and post-glacial areas – by this it means that the true uplands were generally once covered by glacial ice as it moved south, shaping the mountains on the way.

Scotland has the tallest mountains in the UK, and the largest upland areas with the North West Highlands, Grampian Mountains, Cairngorms, Trossachs, etc. The mountains are divided up by lowland areas with lochs (lakes) and they are all shaped by glacial processes, leaving many glacial features such as steep-sided valleys, deep lakes and coastal fjords. Ben Nevis is the tallest mountain in the UK, at 1345m high. Many of the Scottish uplands are used for skiing and winter sports during the season; they have alpine species and a cold climate. Ninety-seven of the top 100 tallest mountains of the UK are found within Scotland, many with ancient extinct volcanic history. The River Clyde has its source there.

Mountain Snowdon is the seventy-sixth tallest mountain in the UK at 1085m; it is found within Wales in the uplands of Snowdonia that are part of the Cambrian Mountains. Again, this is a post-glacial area with many features of arêtes, pyramidal peaks, valleys, etc. The mighty rivers of the Severn and Wye have their sources in these highland areas. To the south are the Brecon Beacons mountains.

In Northern Ireland, the Antrim Mountains are the highest ground and are found in the northeast. There are many unique landforms in the basalt here, like the infamous Giant's Causeway – the result of an ancient, basaltic lava fissure eruption.

England's high ground is found predominantly in the Cumbrian Mountains and Pennines running from the River Tyne in the north, and the River Trent to the south. Scafell Pike is the highest peak in England at 978m, found in the Lake District within the Cumbrian mountains – an area of high ground formed from ancient lava beds and ash fields. The south-west peninsula has other upland areas such as Dartmoor and Exmoor, although these are much lower in height than the major highlands.

Lowland areas include the Somerset Levels, which are prone to flooding, and the Norfolk Broads and Fens. Much of the marshy Fens were once below sea level and have been reclaimed from the sea.

Major rivers of the UK include the Thames, the Clyde, the Trent, the Wye, the Tees and the Tyne. The River Severn is the longest river in the UK, beating the River Thames by nine kilometres. Many of these rivers have some form of management to control their flow and reduce flood risk. There is a huge variety of river landforms along their courses, including waterfalls, gorges, meanders and valleys.
