In this Agreement unless the context otherwise requires:

"Distributor"	Means, "The Wise Hippo Limited"		
"The Wise Hippo Birthing Programme"	Means, Any educational material produced by the "Distributor"		
"Instructor"	Means the party defined in point (2) above who is intending to teach "The Wise Hippo Birthing Programme"		
"Licence Fee"	Means the annual amount of money payable by the "Instructor" in order to use "The Wise Hippo Birthing Programme"		
"Hypnosis for Birth Teachers"	Means, those that have been recognised by a certified body to teach an hypnosis for childbirth programme		
"Agreement Fee"	Means, One Hundred and Fifty Five Pounds Stirling, unless subject to special offers as defined by the "Distributor"		
"Expectant Client"	Means, an individual or couple that have purchased "The Wise Hippo Birthing Programme"

2. GRANT OF RIGHT

- 2.1. "Distributor" grants the "Instructor", and the "Instructor" accepts from "Distributor" subject to the terms and conditions below, the non-exclusive, limited agreement under copyright (hereinafter referred to as the "Agreement") to possess, promote, and teach "The Wise Hippo Birthing Programme" as set out in this agreement, for educational use within an educational context.
- 2.2. The "Instructor" is responsible for ensuring that they only provide services to clients solely in those areas in which they are competent.
- 2.3. The "Instructor" is responsible for ensuring that they have the appropriate valid insurance for the purposes in which they teach.

3. PAYMENT

- 3.1. The "Instructor" shall pay the "Distributor" a non-refundable fee (the "Agreement Fee") at the time of execution of the "Agreement", payable in Sterling (GBP) to the sum of £155.00 or agreed special offer price as applicable. - 3.2. Any bank charges incurred by parties other than the "Distributor" shall be met by the "Instructor".

4. DELIVERY

- 4.3. The DVD contained within this programme shall be in standard definition NTSC or PAL format as specified on the order form. Delivery shall be made to "Instructor's" address as set forth below unless "Instructor" otherwise notifies "Distributor" in writing.
- 4.4. The "Instructor's" session planner will be available as a downloadable document in PowerPoint and PDF formats, available on the Instructor area of www.thewisehippo.com
- 4.5. The background music and birth affirmations will be available as downloadable digital format for, example mp3, available on the Instructor area of www.thewisehippo.com
