- All of our LLB Law programmes cover the foundations of legal knowledge required by the legal professional bodies in England and Wales. This will enable you to progress onto a professional course.
- You will experience a 'flipped classroom' learning and teaching model, which includes; online lectures, weekly two-hour seminars incorporating substantive law and legal skills and large group student support sessions. The course also offers open surgery/drop in sessions for one-to-one help and guidance.
- Alongside your degree, you will have the opportunity to partake in co-curricular activities to enhance your legal and employability profile. These include mooting, trial advocacy, debating, mediation and participation in the wide array of practical legal activities offered by our Law Clinic.
- You will become part of a vibrant School community, linking and studying with both Law and Criminal Justice and Criminology students.

Academic Year

Academic Year 2019 - 2020

The University's academic year is made up of 3 Semesters. For Semester B entrant undergraduate students the first academic year is split into two Semesters (B & C). Each of these is made up of teaching weeks followed by exams.

Each subsequent academic year is split into two Semesters (A & B), with a re-sit period within Semester C.

- Semester A runs from Monday 23 September 2019 to Friday 17 January 2020
- Semester B runs from Monday 20 January 2020 to Friday 22 May 2020
- Semester C runs from Monday 25 May 2020 to Friday 18 September 2020
