A. Programme Rationale

MSc Management is designed to meet the growing demands of business for graduates who possess rigorously developed personal as well as business skills. The programme is open to graduates of any discipline wishing to obtain a management qualification, to non- graduates with appropriate work experience and to those with an appropriate professional qualification.

The programme offers an attractive study and learning opportunity for both full-time and part-time students who want a sound generalist business master's degree designed to build on each individual's employment skills. It is available as an MSc, a Postgraduate Certificate and Postgraduate Diploma.

The programme's overriding objective is to develop individuals for employment in a management role and thus recognising and reinforcing the importance of a sound research education and training because of its growing importance in the global knowledge economy.

B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in [UPR TL03](#).

Additionally this programme aims to:

- Provide students with an intellectually challenging programme of study leading to a breadth of knowledge, understanding and skills which are greater than the sum of the individual modules.
- Give students a programme of study which develops and enhances their academic and practical skills, and generates a capacity for independent, conceptual and creative thinking, appropriate to the study of management at masters level;
- Develop in students the analytical and problem solving skills which will enable them to engage with, and apply, what is taught either to their workplace problems and issues or to a range of desk based real life scenarios;
- Develop students conceptual understanding of the issues and complexities of management in an international and global context so they may better apply and communicate management solutions to a range of business issues, problems and events;

- Give students the opportunity to evaluate relevant management theory and practice across a range of real life scenarios.

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas. D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full time mode (1 year), part time mode (usually 2 years) and a more flexible mode of study, over 5 years, if this fits better with students' work commitments.

The programme leads to the award of PG Certificate in Management, PG Diploma in Management and an MSc Management depending on students' choice. Entry is normally with a good first degree, but it is also possible for those without a first degree, but who have appropriate management work experience to join the programme. Those who hold a Diploma in Management Studies or equivalent from a UK (or equivalent) University may also be given direct entry with advanced standing.

Research Methods Support

This programme includes a credit-bearing, taught Research Methods module for students as preparation for independent research. This is especially tailored for students on this programme of study, and engagement in it is essential and compulsory.

As an additional resource, students may also wish to draw on the School's general, online Postgraduate Online Research Methods course, non-assessed, available to further support their understanding.

- A Programme (or Student) Handbook;
- A Definitive Module Document (DMD) for each constituent module;
- A Module Guide for each constituent module.

The [Ask Herts](#) website provides information on a wide range of resources and services available at the University of Hertfordshire including academic support, accommodation, fees, funding, visas, wellbeing services and student societies.

As a condition of registration, all students of the University of Hertfordshire are required to comply with the University's rules, regulations and procedures. Furthermore, the OfS has judged that the University of Hertfordshire delivers consistently outstanding teaching, learning and outcomes for its students. It is of the highest quality found in the UK. Consequently, the University received a Gold award in the 2018 Teaching Excellence and Student Outcomes (TEF) exercise. This award was made in June 2018 and is valid for up to 3 years. G. Entry requirements

The normal entry requirements for the programme are:

- An honours degree from a UK university of at least 2:2 classification from any discipline or;
- The equivalent of the above from a recognised University overseas or;
- A degree equivalent professional qualification or;
- Equivalent qualifications to be assessed by the Programme Leader and Admissions Tutor
- Non-graduates with a minimum of 5 years of appropriate Management experience, able to provide evidence of training and development as part of their work based progress to date..

English Language entry requirements

In addition all students for whom English is not their first language must produce evidence of their English Language proficiency. The standard required is an IELTS score of 6.5 (with no less than 5.5 in each band), or an equivalent score on a test recognised by the University of Hertfordshire.

[Pre-sessional English language courses are available at the University of Hertfordshire for students who have an IELTS score of 6.0]

This requirement will be waived if the student has successfully completed an undergraduate degree at a university in the United Kingdom, or another country acceptable to the University of Hertfordshire, where study was in English and the student was based in that university's home country during study.

The programme is subject to the University's Principles, Policies and Regulations for the Admission of Students to Undergraduate and Taught Postgraduate Programmes (in [UPR SA03](#)), along with associated procedures. These will take account of University policy and guidelines for assessing accredited prior certificated learning (APCL) and accredited prior experiential learning (APEL).
