Language of Delivery English

A. Programme Rationale

A joint or minor in English Literature will develop your understanding of Anglophone (English-language) literary history, and enhance your ability to analyse and think critically about literary texts. You will be able to choose either 30 or 60 credits of study in English Literature at each level (i.e. two or four modules). Depending on your module choices, you may study literary works in a range of forms, including the novel, the short story, poetry, drama, autobiography, and the essay; and you will often be encouraged to understand these texts in relation to non-literary cultural artefacts such as films, paintings, and sculpture.

These works may be drawn from historical periods from the Renaissance to the present day, including many texts by authors from beyond the British Isles (the USA and Canada, Australia, the Caribbean, Africa and India, for example). You will also be introduced to a range of theoretical approaches to the study of literature which will equip you with the skills needed to become sophisticated literary critics in your own right, and to understand contemporary debates which influence and shape the discipline. You will encounter many works from within the traditional literary canon, and many unusual works from outside it. You will develop subject knowledge and a range of important transferable skills which are assessed in a wide variety of ways. In summary, our degree is intended to help you develop into critically-informed and articulate scholars of English Literature, with an ability to situate texts in their broader intellectual and cultural contexts.

The curriculum is designed to ensure that you will study a balanced programme, in line with the recommendations of the QAA Benchmark Statement for English (2015), but often approached in a fresh and innovative way which encourages you to reflect on the relevance and importance of the study of English to our contemporary world.

B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in <u>UPR TL03</u>.

Additionally this programme aims to:

- Contribute the national provision of English Literature by providing for students (including those who
 are new to the subject) the opportunity to study a stimulating, challenging and enjoyable, but also
 balanced, range of topics and materials from different parts of the world and from different literary
 periods, together with a variety of approaches to reading Literature;
- Equip students with a range of intellectual and subject-specific skills;
- Equip students with a range of transferable skills.

Additionally, the aims of a minor in English Literature are to:

 Develop students' focused knowledge and understanding of a concise number of literary topics and critical approaches, and develop relevant skills through the study of a small selection of optional English Literature modules.

The aims of a Joint in English Literature are, in addition to the above:

 Develop students' knowledge and understanding of a range of literary topics and critical approaches, related to a selection of texts (pre and post 1800), and develop relevant skills through the study of a moderate number of English Literature modules.

C. Intended Learning Outcomes

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas. The programme outcomes are referenced to the QAA benchmark statements for English and the Frameworks for Higher Education Qualifications of UK



Degree-Awarding Bodies (2014) and relate to the typical student. Additionally, the SEEC Credit Level Descriptors for Further and Higher Education (2016) have been used as a guiding framework for curriculum design.

Knowledge and Understanding

Teaching and learning methods

Acquisition of knowledge and understanding is through a combination of lectures, seminars, tutorials and guided learning (A1, A2, A3, A4, A5, A6, A7, A8, A9, A10, A11). Students are also encouraged to contribute to and initiate online StudyNet discussions thus extending engagement with their peers outside timetabled sessions.

Acquisition of A11 also takes place via independent study.

Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject.

Assessment strategy

Knowledge and understanding are assessed through a combination of in-course assessments in the form of essay assignments, creative writing, critical reviews and unseen examinations (A1, A2, A3).

Level 5: Testing of knowledge and understanding of A4, A5, A6, and A7 is through a combination of formative and summative assessment including unseen 2-hour examinations and a range of coursework in the form of essay assignments, closereading exercises, in-class tests, collaborative editing projects, oral presentations and student-led seminars.

Level 6: Testing of knowledge and understanding of A8, A9 and A10 is through a combination of formative and summative assessment including unseen examinations and a range of coursework in the form of essay assignments, closereading exercises, critical reviews, in-class tests, independent project work, online discussion forums. A11 is assessed via all Level 6 modules in a range of coursework assignments.

Teaching and learning methods

Intellectual skills are developed through the methods and strategies outlined in section A. Throughout, the learner is encouraged to develop intellectual skills further by independent study.

Assessment strategy

Level 4: Intellectual skills B1, B2, B3 and B4 are assessed (formatively and summatively) by a combination of unseen 2-hour examinations and incourse assessments in the form of essay assignments, close-reading exercises, class-tests.

Level 5: Intellectual skills B5, B6, B7 and B8 are assessed by a combination of formative and summative assessments including 2-hour unseen examinations and a range of coursework in the form of essay assignments, close-reading exercises, in-class tests, bibliographies, portfolio work, collaborative written projects, oral presentations, reflective reports.

Level 6: Intellectual skills B9, B10, B11 and B12 are assessed by a combination of formative and summative assessments including 2-hour examinations and a range of coursework in the form of essay assignments, closereading exercises, reviews, inclass tests, independent project work (e.g. poster presentations; web-site design); creative writing; logbook, on-line discussion forums, oral presentations. Skill B12 is assessed primarily via the Literature Project module but also via other forms of assessment on Level

Teaching and learning methods

Skill C1 is begun at Level 4 when students are inducted into the facilities of the Learning Resources Centre (use of e-mail, Internet, CD-ROMs) and is continued through the programme.

Skills C2 and C3 are developed in the written work, which all modules require and refined via the Literature Project work at Level 6 if chosen by the student.

Assessment strategy

Skill C1 is built into the programme. All modules require students to access the relevant StudyNet sites for module information and seminar tasks; several modules including core modules at Level 4, expect student participation in on-line discussion and this is assessed in some instances. It is expected that all written assignments will be word-processed.

Skills C2 and C3 are developed in the written and seminar work, which all modules require. For coursework, students are assessed on their ability to go beyond the information given in lectures and seminars and also on their ability to communicate their findings effectively

Skill D1 is not formally assessed but it is expected that students will have to demonstrate this skill in order to pass through the programme and meet module deadlines. Work submitted after the module deadline may be penalised.

D5 is developed via different types of coursework e.g. planning student-led seminar, researching a presentation, completing written coursework.

D6 and D7 are developed via different types of seminar and workshop and via coursework

Skills D2 and D5 are developed in the written work, which all modules require. For coursework, students are assessed not only on their knowledge and understanding but also on their ability to communicate their ideas effectively, to engage with different viewpoints, to reference appropriately and to present work using recognised scholarly conventions.

Skills D3, D4 are formally assessed on a number of individual modules and in a number of different ways e.g. presentations, student ledseminars, and seminar contribution.

Skill D5 is assessed via different assessment tasks contained in the programme.

Skill D6 is developed in written work, which all modules require.

Skill D7 is developed in seminar work and in assessment tasks.

D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full- time (normally 3 years), sandwich (normally 4 years) and part- time (normally 5 years) modes, and leads to the award BA Degree with Honours with the appropriate title from those listed in Section 1.

Entry is normally at Level 4 (with suitable A level or equivalent qualifications) but is possible at Level 5 and Level 6 with suitable accredited prior learning. Intake is normally in Semester A.

Work-Based Learning, including Sandwich Programmes

An award in the sandwich mode requires the successful completion of at least **360 hours** placement activity from a maximum of two separate placements in addition to the period of academic study required for the full-time award. This optional placement year is undertaken after Level 5 and before Level 6 and meets the SEEC criteria for Level 6.

Erasmus Exchange programme

Erasmus students are permitted to study modules at all levels.

Programme Structure

The programme structure and progression information below (Table 1a and 1b) is provided for the Honours



award. Any interim awards are identified in Table 1b. The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed. In addition, on the Major-Minor pathways the Major Subject/Programme Learning Outcomes and on the Joint pathways the Joint Subject/Programme Learning Outcomes are developed and assessed through the constituent modules, as identified within the relevant Subject /Programme Specification.

Students on a full-time mode of study must normally take the equivalent of eight 15 credit modules per year with the equivalent of four 15 credit modules undertaken per semester.

In addition, at level 5 students must normally study the module 5HUM1064 Graduate Skills, unless they take 5HUM1175 Employability Skills. Failure in this module will not prevent progression, provided the normal progression rules had been met.

Mode of study Part-time

Students on a part-time mode of study are allowed to take up to five 15 credit modules per year and most normally choose to study between 2 and 5 modules per year, with modules being taken in each semester. Varying rates of study are possible: students can increase or decrease their rate of study year by year or semester by semester in response to their changing circumstances. Students are entitled to take a break from study for a semester or even a year if their circumstances require it.

Students can apply to transfer to a full-time rate of study; this should be arranged before the beginning of the academic year.

Sandwich Year and Year Abroad

Students on all pathways may optionally undertake a placement year or a year abroad studying at a foreign University after successfully completing their level 5 studies at honours level. The placement year and year abroad offer an additional optional year (0 credited) which increases the length of the Honours degree award to a four year full-time degree. Successful completion of the placement year or year abroad is reflected in the degree title.

Sandwich Year

The placement year comprises an agreed period of 36 weeks (including employers' and statutory holidays) of work based learning a maximum of two institutions or companies which has agreed to those terms and conditions regarded as essential by the University of Hertfordshire. Students will be supervised according to university regulations. The learning experience will be assessed with assessments set by the Employability Tutor to enable students to demonstrate both their knowledge of the industry, their skills development and their professional attributes.



Placements are advertised through the Career and Placements Office and have included areas such as marketing, journalism, PR, management and Policy Units. Students may also source their own placement, but it must be subsequently approved by the School in terms of health and safety, equality legislation and supervisory guidelines before a student can take it up.

All students are eligible to proceed to a placement year provided they have achieved 120 credits at Level 4 and at least 90 credits at Level 5 and have completed the appropriate placement induction and documentation. Success in the placement will be recognised in the title of the award but does not carry additional credit towards the Honours programme.

Year Abroad

The year abroad comprises an agreed programme of study in the third year of a partner institution in Europe (other than the UK), North or South America, Australia or Singapore with which the University of Hertfordshire has an institutional agreement.

A student's programme of study will be negotiated and approved by the Dean of School (or nominee) in consultation with appropriate others and the host University. The programme provided by the host institution may comprise taught modules, a research project, field studies, or a mixture of these components. The programme of study will require a minimum of 25% of studies to be undertaken in aspects of culture of the placement country. Prior to the commencement of the year abroad, the student and Study Abroad Tutors from UH and the host institution will agree a learning contract. The learning contract will specify the assessment requirements to be met for successful completion of the programme of study. A Module Board of Examiners will consider the results for the year abroad during the first semester of the following academic year. All assessments must be completed by the end of the year abroad, and no subsequent referrals will be permitted. Students who have varied their programme of study without agreement from UH or have failed to meet the requirements of the learning contract will not have their year abroad studies included in the degree title.

A student must confirm the intention to study abroad during the first ten weeks of study at Level 5. This will enable a place to be negotiated at a host institution and the Study Programme and learning contract to be arranged and agreed. Only a limited number of places exist. These will be awarded on the basis of the suitability of students and guided by choice on the most appropriate programme and host institution.

To be eligible to proceed to a year abroad, a student must, by the time of the Semester B Module Boards of Examiners, have achieved at least 210 credits overall, including at least 90 credits at Level 5. Success in the year abroad will be recognised in the title of the award but does not carry additional credit towards the Honours programme.

For the year abroad in Europe where study will be undertaken in a foreign language students must meet the host University's language requirements.

Combined Placement and Study Abroad Year

Students who are eligible for the Year Abroad or Placement Year will also be eligible for the combined Placement and Study Abroad Year. This will involve a semester spent in a partner university abroad that is willing to provide a study abroad semester, combined with an appropriate placement of a minimum of 12 weeks which can be taken either abroad or in the UK.



Language of Delivery English

A. Programme Rationale

A joint or minor in English Literature will develop your understanding of Anglophone (English-language) literary history, and enhance your ability to analyse and think critically about literary texts. You will be able to choose either 30 or 60 credits of study in English Literature at each level (i.e. two or four modules). Depending on your module choices, you may study literary works in a range of forms, including the novel, the short story, poetry, drama, autobiography, and the essay; and you will often be encouraged to understand these texts in relation to non-literary cultural artefacts such as films, paintings, and sculpture.

These works may be drawn from historical periods from the Renaissance to the present day, including many texts by authors from beyond the British Isles (the USA and Canada, Australia, the Caribbean, Africa and India, for example). You will also be introduced to a range of theoretical approaches to the study of literature which will equip you with the skills needed to become sophisticated literary critics in your own right, and to understand contemporary debates which influence and shape the discipline. You will encounter many works from within the traditional literary canon, and many unusual works from outside it. You will develop subject knowledge and a range of important transferable skills which are assessed in a wide variety of ways. In summary, our degree is intended to help you develop into critically-informed and articulate scholars of English Literature, with an ability to situate texts in their broader intellectual and cultural contexts.

The curriculum is designed to ensure that you will study a balanced programme, in line with the recommendations of the QAA Benchmark Statement for English (2015), but often approached in a fresh and innovative way which encourages you to reflect on the relevance and importance of the study of English to our contemporary world.

B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in <u>UPR TL03</u>.

Additionally this programme aims to:

- Contribute the national provision of English Literature by providing for students (including those who
 are new to the subject) the opportunity to study a stimulating, challenging and enjoyable, but also
 balanced, range of topics and materials from different parts of the world and from different literary
 periods, together with a variety of approaches to reading Literature;
- Equip students with a range of intellectual and subject-specific skills;
- Equip students with a range of transferable skills.

Additionally, the aims of a minor in English Literature are to:

 Develop students' focused knowledge and understanding of a concise number of literary topics and critical approaches, and develop relevant skills through the study of a small selection of optional English Literature modules.

The aims of a Joint in English Literature are, in addition to the above:

 Develop students' knowledge and understanding of a range of literary topics and critical approaches, related to a selection of texts (pre and post 1800), and develop relevant skills through the study of a moderate number of English Literature modules.

C. Intended Learning Outcomes

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas. The programme outcomes are referenced to the QAA benchmark statements for English and the Frameworks for Higher Education Qualifications of UK



Degree-Awarding Bodies (2014) and relate to the typical student. Additionally, the SEEC Credit Level Descriptors for Further and Higher Education (2016) have been used as a guiding framework for curriculum design.

Knowledge and Understanding

At Level 4, show an understanding of: A1 Some of the specific genres with which the modules deal and their different characteristics e.g. the novel, the short story; examples of poetry and drama; A2. Teaching and learning methods

Acquisition of knowledge and understanding is through a combination of lectures, seminars, tutorials and guided learning (A1, A2, A3, A4, A5, A6, A7, A8, A9, A10, A11). Students are also encouraged to contribute to and initiate online StudyNet discussions thus extending engagement with their peers outside timetabled sessions.

Acquisition of A11 also takes place via independent study.

Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject.

Assessment strategy

Knowledge and understanding are assessed through a combination of in-course assessments in the form of essay assignments, creative writing, critical reviews and unseen examinations (A1, A2, A3).

Level 5: Testing of knowledge and understanding of A4, A5, A6, and A7 is through a combination of formative and summative assessment including unseen 2-hour examinations and a range of coursework in the form of essay assignments, closereading exercises, in-class tests, collaborative editing projects, oral presentations and student-led seminars.

Level 6: Testing of knowledge and understanding of A8, A9 and A10 is through a combination of formative and summative assessment including unseen examinations and a range of coursework in the form of essay assignments, closereading exercises, critical reviews, in-class tests, independent project work, online discussion forums. A11 is assessed via all Level 6 modules in a range of coursework assignments.

Teaching and learning methods

Intellectual skills are developed through the methods and strategies outlined in section A. Throughout, the learner is encouraged to develop intellectual skills further by independent study.

Assessment strategy

Level 4: Intellectual skills B1, B2, B3 and B4 are assessed (formatively and summatively) by a combination of unseen 2-hour examinations and incourse assessments in the form of essay assignments, close-reading exercises, class-tests.

Level 5: Intellectual skills B5, B6, B7 and B8 are assessed by a combination of formative and summative assessments including 2-hour unseen examinations and a range of coursework in the form of essay assignments, close-reading exercises, in-class tests, bibliographies, portfolio work, collaborative written projects, oral presentations, reflective reports.

Level 6: Intellectual skills B9, B10, B11 and B12 are assessed by a combination of formative and summative assessments including 2-hour examinations and a range of coursework in the form of essay assignments, closereading exercises, reviews, inclass tests, independent project work (e.g. poster presentations; web-site design); creative writing; logbook, on-line discussion forums, oral presentations. Skill B12 is assessed primarily via the Literature Project module but also via other forms of assessment on Level

Teaching and learning methods

Skill C1 is begun at Level 4 when students are inducted into the facilities of the Learning Resources Centre (use of e-mail, Internet, CD-ROMs) and is continued through the programme.

Skills C2 and C3 are developed in the written work, which all modules require and refined via the Literature Project work at Level 6 if chosen by the student.

Assessment strategy

Skill C1 is built into the programme. All modules require students to access the relevant StudyNet sites for module information and seminar tasks; several modules including core modules at Level 4, expect student participation in on-line discussion and this is assessed in some instances. It is expected that all written assignments will be word-processed.

Skills C2 and C3 are developed in the written and seminar work, which all modules require. For coursework, students are assessed on their ability to go beyond the information given in lectures and seminars and also on their ability to communicate their findings effectively

D6 and D7 are developed via different types of seminar and workshop and via coursework

Skills D2 and D5 are developed in the written work, which all modules require. For coursework, students are assessed not only on their knowledge and understanding but also on their ability to communicate their ideas effectively, to engage with different viewpoints, to reference appropriately and to present work using recognised scholarly conventions.

Skills D3, D4 are formally assessed on a number of individual modules and in a number of different ways e.g. presentations, student ledseminars, and seminar contribution.

Skill D5 is assessed via different assessment tasks contained in the programme.

Skill D6 is developed in written work, which all modules require.

Skill D7 is developed in seminar work and in assessment tasks.

D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full- time (normally 3 years), sandwich (normally 4 years) and part- time (normally 5 years) modes, and leads to the award BA Degree with Honours with the appropriate title from those listed in Section 1.

Entry is normally at Level 4 (with suitable A level or equivalent qualifications) but is possible at Level 5 and Level 6 with suitable accredited prior learning. Intake is normally in Semester A.

Professional and Statutory Regulatory Bodies N/A

Work-Based Learning, including Sandwich Programmes

An award in the sandwich mode requires the successful completion of at least **360 hours** placement activity from a maximum of two separate placements in addition to the period of academic study required for the full-time award. This optional placement year is undertaken after Level 5 and before Level 6 and meets the SEEC criteria for Level 6.

Erasmus Exchange programme

Erasmus students are permitted to study modules at all levels.

Programme Structure

The programme structure and progression information below (Table 1a and 1b) is provided for the Honours



award. Any interim awards are identified in Table 1b. The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed. In addition, on the Major-Minor pathways the Major Subject/Programme Learning Outcomes and on the Joint pathways the Joint Subject/Programme Learning Outcomes are developed and assessed through the constituent modules, as identified within the relevant Subject /Programme Specification.

Students on a full-time mode of study must normally take the equivalent of eight 15 credit modules per year with the equivalent of four 15 credit modules undertaken per semester.

Mode of study Part-time

Students on a part-time mode of study are allowed to take up to five 15 credit modules per year and most normally choose to study between 2 and 5 modules per year, with modules being taken in each semester. Varying rates of study are possible: students can increase or decrease their rate of study year by year or semester by semester in response to their changing circumstances. Students are entitled to take a break from study for a semester or even a year if their circumstances require it.

Students can apply to transfer to a full-time rate of study; this should be arranged before the beginning of the academic year.

Sandwich Year and Year Abroad

Students on all pathways may optionally undertake a placement year or a year abroad studying at a foreign University after successfully completing their level 5 studies at honours level. The placement year and year abroad offer an additional optional year (0 credited) which increases the length of the Honours degree award to a four year full-time degree. Successful completion of the placement year or year abroad is reflected in the degree title.

Sandwich Year

The placement year comprises an agreed period of 36 weeks (including employers' and statutory holidays) of work based learning a maximum of two institutions or companies which has agreed to those terms and conditions regarded as essential by the University of Hertfordshire. Students will be supervised according to university regulations. The learning experience will be assessed with assessments set by the Employability Tutor to enable students to demonstrate both their knowledge of the industry, their skills development and their professional attributes.



Placements are advertised through the Career and Placements Office and have included areas such as marketing, journalism, PR, management and Policy Units. Students may also source their own placement, but it must be subsequently approved by the School in terms of health and safety, equality legislation and supervisory guidelines before a student can take it up.

All students are eligible to proceed to a placement year provided they have achieved 120 credits at Level 4 and at least 90 credits at Level 5 and have completed the appropriate placement induction and documentation. Success in the placement will be recognised in the title of the award but does not carry additional credit towards the Honours programme.

Year Abroad

The year abroad comprises an agreed programme of study in the third year of a partner institution in Europe (other than the UK), North or South America, Australia or Singapore with which the University of Hertfordshire has an institutional agreement.

A student's programme of study will be negotiated and approved by the Dean of School (or nominee) in consultation with appropriate others and the host University. The programme provided by the host institution may comprise taught modules, a research project, field studies, or a mixture of these components. The programme of study will require a minimum of 25% of studies to be undertaken in aspects of culture of the placement country. Prior to the commencement of the year abroad, the student and Study Abroad Tutors from UH and the host institution will agree a learning contract. The learning contract will specify the assessment requirements to be met for successful completion of the programme of study. A Module Board of Examiners will consider the results for the year abroad during the first semester of the following academic year. All assessments must be completed by the end of the year abroad, and no subsequent referrals will be permitted. Students who have varied their programme of study without agreement from UH or have failed to meet the requirements of the learning contract will not have their year abroad studies included in the degree title.

A student must confirm the intention to study abroad during the first ten weeks of study at Level 5. This will enable a place to be negotiated at a host institution and the Study Programme and learning contract to be arranged and agreed. Only a limited number of places exist. These will be awarded on the basis of the suitability of students and guided by choice on the most appropriate programme and host institution.

To be eligible to proceed to a year abroad, a student must, by the time of the Semester B Module Boards of Examiners, have achieved at least 210 credits overall, including at least 90 credits at Level 5. Success in the year abroad will be recognised in the title of the award but does not carry additional credit towards the Honours programme.

For the year abroad in Europe where study will be undertaken in a foreign language students must meet the host University's language requirements.

Combined Placement and Study Abroad Year

Students who are eligible for the Year Abroad or Placement Year will also be eligible for the combined Placement and Study Abroad Year. This will involve a semester spent in a partner university abroad that is willing to provide a study abroad semester, combined with an appropriate placement of a minimum of 12 weeks which can be taken either abroad or in the UK.

Further programme-specific regulations (requiring School-level approval) are given below:

- At Levels 4 and 5 students may opt to replace 30 credits of optional modules (where available) of a joint
 or major subject with 30 credits (15 per semester) of modules in any of the subjects offered in the
 School of Humanities, not part of their degree title (subject to meeting any pre-requisite requirements).
- Progression from one Level to the next depends on meeting the pre-requisite requirements: students
 must normally have 30 credits in a subject area at the lower Level before progressing to study of that



subject at the higher Level;

Students may exercise a change of pathway at the beginning of Level 5 and Level 6 from taking English
Literature as a minor to taking it as a joint subject, by increasing study of English Literature by 30 credits,
or from taking English Literature as a joint to taking it as a minor, by decreasing study of English
Literature by 30 credits. In the first case this necessitates decreasing study of the other subject by 30
credits and in the second case this necessitates increasing study of the other subject by 30 credits.


