Section	Amendment
D. Programme Structures, Features, Levels, Modules, and Credits	Unseen written examinations will not be returning for the semester A which typically runs from September to January each academic year. Use of alternative methods such as Online Timed Assessments and quizzes that incorporate several features to create valid assessments. There will be practice quizzes through the module prior to any assessment using the Canvas quiz.
	The School has revised the assessment structure where unseen examinations and practical sessions were key sections of the assessment. The practical sessions will still take place but not be mandatory in the assessment for the final grade in order to protect any student as a result of national Covid guidelines e.g. lockdown and self-isolation. The modules show AW which means there has been a change to Assessment Weighting where weighting is the percentage amount of the assessment, whether coursework or exam or practical, contributes to the overall grade of the module.  CS means there has been a Change to the Semester the module is being taught on due to other issues.

## A. Programme Rationale

A degree apprenticeship enables an apprentice to gain a degree alongside gaining valuable work experience. Throughout the apprenticeship apprentices will be in full employment with their academic fees paid by the employer usually using apprenticeship levy funding. Being able to apply their studies in an industrial environment not only enhances the learning experience for the apprentices but helps employers further their employees' careers.

This particular programme will enable apprentices to study the BEng Honours in Electrical and Electronic Engineering at the University of Hertfordshire alongside developing their professional behavioural skills and knowledge to satisfy the requirements for the Embedded Electronic Systems Design and Development Engineer Degree Apprenticeship Standard. This will be achieved through a combination of industrial experience opportunities provided by the employer and academic studies led by UH staff with a wealth of industrial and research experience.

Throughout the apprenticeship, apprentices will be employed by a company who will provide an Individual Learning Plan that includes both time to study as well as work experiences to enable them to apply the skills and knowledge gained through the degree course within the work place.

The Apprenticeship is normally spread over 4 years with apprentices studying three taught modules per semester during Semesters A and B. Two of the modules will be delivered on a one day per week release basis to attend classes at UH. A third module will be delivered to apprentices through two whole weeks (4 days) using blended learning methods (i.e. a combination of face-to-face and on-line learning). These module intensive weeks will typically be delivered a number of weeks apart



to allow apprentices to complete assignments and independent study. There may also be some online preparation work to be completed before the first intensive week and a final assignment/assessment after the second intensive week. During Semester C and when the apprentice is not at UH they are expected to be based in industry either completing work set by UH or working for their employer.

In addition to the academic modules studied at UH, apprentices will complete a Professional Practice module each year. This involves recording their work experience and developing a portfolio of evidence as part of their Individual Learning Plan (ILP). The ILP is an essential tool to help the apprentice prepare for the end point assessment by identifying which tasks contribute to meeting each of the Knowledge, Skills and Behavioural requirements listed in the apprenticeship standard. Professional Practice modules are zero credit modules that are used to monitor progress of the portfolio and preparation for the EPA and are not used as a pass/fail element to progress to the next level.

## B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in <u>UPR TL03</u>.

#### Additionally this programme aims to:

- · provide high quality education in electrical and electronic engineering;
- provide an education for the individual which enhances his/her prospects of professional employment in engineering and business both in national and international industries;
- provide studies which are accredited by the Institution of Engineering and Technology;
- provide studies which develop an awareness of, and underpinning knowledge and understanding of a broad range of Electrical and Electronic Engineering areas of expertise.

## C. Intended Learning Outcomes

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas. The programme outcomes are defined by the Engineering Council and recommended in the QAA benchmark statements for Engineering (2019) and the Frameworks for Higher Education Qualifications of UK Degree-Awarding Bodies (2019). The outcomes relate to the typical student. In addition, the SEEC Credit Level Descriptors for Higher Education (2016) have been used to provide guidance for curriculum design at each level of the programme to reflect student development. The curriculum design has also taken into account UH Graduate Attributes.

## Teaching and learning methods

Acquisition of knowledge and understanding is through the following approaches:
Acquisition of A1 and A2 is through a combination of lectures, small group tutorials, coursework and laboratory work at levels 4 and 5 of the programme.
Additional support is provided through the Mathematics Drop-in Centre. Specialist aspects of A2

are further developed at level 6.

#### Assessment strategy

Knowledge and understanding are assessed through a combination of unseen examinations (A1, A2, A3 and A5) and in-course assessments (A1-A6) in the form of laboratory reports, essays and phase tests. Some aspects of A3 and A4 are assessed by design exercises and project reports and presentations. At level 6 some



considerations of the business of engineering. A5-Professional engineering practice.

Acquisition of A3, A4, and A5 is through a combination of lectures, projects and coursework throughout the programme. Staff deploy a range of teaching and learning strategies in the most appropriate way for each individual module. This will vary depending on the subject nature of a particular module and the level of study. A more didactic approach will tend to be adopted at lower levels, in particular for A1 and A2. An increasingly self-directed and interactive approach will be adopted at higher levels, particularly for A3, A4 and A5. Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject.

## D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in three optional modes of delivery as described in Section A, and leads to the award of a BEng Degree with Honours in Electrical and Electronic Engineering.

Entry is normally in Semester A at level 4 (with A-Level, or equivalent qualifications) but is possible at level 5 with suitable qualifications (e.g. an Edexcel HND in Engineering with appropriate subjects studied).

#### Professional and Statutory Regulatory Bodies

The BEng(Hons) Electrical and Electronic Engineering degree is accredited as meeting the academic requirement, in part, for Chartered Engineering registration for the cohorts from 2017 intake up to, and including, 2021 intake by the Institution of Engineering and Technology

#### Work-Based Learning

As part of a degree apprenticeship apprentices are expected to apply the skills and knowledge they have learnt in the work place. To aid this each apprentice will be allocated an Industrial Mentor by the employer and an Employer Liaison Tutor (ELT) by the School. The Industrial Mentor will be responsible for developing a Schedule of Work in consultation with the Employer Liaison Tutor (ELT) that provides the opportunity to develop the knowledge, skills and behaviours required by the apprenticeship standard. The Industrial Mentor and Employer Liaison Tutor will monitor progress through the Individual Learning Plan. In addition the apprentice shall maintain an e-portfolio of documentary evidence of achievement that is required for the end point assessment. The Industrial Mentor, Apprentice and Employer Liaison Tutor shall meet on a quarterly basis to review progress and make adjustments to the Schedule of Work as appropriate. Records from these meetings shall be included in the e-portfolio.

Apprentices are encouraged to use their experience and their reports as a basis for a presentation to the local Professional Institution Branch, Region or Division possibly through student papers or poster competitions.

#### **End Point Assessment**

On completion of the BEng Honours in Electrical and Electronic Engineering apprentices are required to take the end point assessment to complete their apprenticeship. (See the Product Design and Development Engineer Degree Apprenticeship Assessment Plan for details).

## Programme-specific assessment regulations

The programme complies with the University's academic regulations (in particular, <u>UPR AS11</u>, <u>UPR AS12/UPR AS13</u> and <u>UPR AS14</u>) with the exception of those listed below, which have been approved by the University:

For non-honours awards, the standard University regulations on progression and compensation shall apply, and the Programme Board of Examiners shall have discretion to transfer a student onto a non-honours award where it is to the advantage of the student to do so (for example, where the criteria for progression on an accredited award have not been met).

As specified by the accrediting bodies, a compensated pass cannot be awarded for the Individual Project, which must be included in the calculation of degree classification. Students who do not succeed in the Individual Project may be eligible to repeat, and will be allocated an entirely different project.

To comply with IET accreditation regulations students entering the first year in 2018-2019 must achieve in all 15 credit point modules, after all available attempts under the University regulations, a minimum of 30% (in any allowable attempt) at levels 4, 5 and 6, before the board of examiners will be able to



consider compensation for an accredited honours degree. A maximum of 30 credit points can be compensated across the programme, in line with University regulations. Compensation is not permitted for individual modules worth 30 or more credit points at level 4, 5 and 6.

For non-accredited awards, the standard University regulations on progression and compensation shall apply, and the Programme Board of Examiners shall have discretion to transfer a student onto a non-accredited award where it is to the advantage of the student to do so (for example, where the criteria for progression on an accredited award have not been met).

## G. Entry requirements

Applicants must be working in the engineering sector in a role which provides sufficient work-based learning scope to acquire the knowledge, skills and behaviour expected by the Apprenticeship Standard. They must be supported by their employer to engage in the expected off the job learning, through to End-Point Assessment and satisfy the <a href="EFSA eligibility criteria">EFSA eligibility criteria</a> - "Who can be funded" (starts on page 18 at P77).

The normal entry requirements for the programme are:

Normal entry requirements at level 4 are:

- GCSE Maths at grade 4, English Language at grade 4 and Science at grade 4 or above or the equivalent;
- 104 UCAS points



- BCC or equivalent. Minimum of 2 A levels.
- A levels to include Maths and either Physics or Technology or engineering based subjects excluding General Studies and Critical Thinking.

Applications are also welcomed from those holding other equivalent qualifications including, but not limited to:

- Engineering BTEC Extended Diploma with a Distinction in the Further Maths unit or equivalent, with Distinction, Merit, Merit overall.
- Engineering Advanced Diploma to include A level Maths as ASL component.
- Access to Engineering Diploma with 45 Level 3 credits at Merit to include Maths and Science or Principles units. Any additional L3 credits must be at Merit.
- Those holding equivalent qualifications will be required to discuss their individual circumstances with the appropriate Admissions Tutor.

Applicants who do not meet these normal entry requirements may be eligible for entry to an appropriate HND or Foundation Degree elsewhere, and then subsequent admission to this programme at level 5 (see below).

#### Direct Entry at year 2

It is possible for apprentices to enter the programme at year 2 if they have prior certified learning. In all instances, applicants will be required to discuss their individual circumstances with the appropriate Admissions Tutor. ESFA funding rules do not allow any repeated learning and all applicants will undergo an initial needs assessment to ensure that the planned programme only includes new learning.

Apprentices applying for direct entry into level 5 are required to have an HND or Foundation Degree, or equivalent, in an appropriate discipline with merits and distinctions in appropriate subjects which must include Mathematics plus technical or physical sciences.

## **English Language Requirements**

Addition to the requirements stated above, students entering the programme and whose first language is not English will be required to demonstrate a proficiency in English to TOEFL 550/IELTS 6.0 or an equivalent recognised qualification

The programme is subject to the University's Principles, Policies and Regulations for the Admission of Students to Undergraduate and Taught Postgraduate Programmes (in <u>UPR SA03</u>), along with associated procedures. These will take account of University policy and guidelines for assessing accredited prior certificated learning (APCL) and accredited prior experiential learning (APEL).

## Appendix 5 - UH Graduate Attributes

This programme embodies the University of Hertfordshire graduate attributes extensively – indeed these attributes align very well with the requirements of UK-SPEC which these programmes fulfil in order to be accredited. The following paragraphs indicate how this is achieved.

## Professionalism, employability and enterprise

Being a vocational programme apprentices will have many opportunities to develop communication skills, work independently and in teams both in industry and at UH, building confidence at problem solving and developing creativity and self-management skills in the context of the Electronics industry. Team work is fostered through group work in various modules in each year as well as working alongside practicing engineers in industry. Apprentices have contact with practicing engineers not just through their own companies but also through guest lecturers on various academic modules. Apprentices are encouraged to seek recognition of their industrial experience by gaining EngTech or ICTTech, registration with the IET.

## Learning and research skills

The apprenticeship programme provides opportunities to develop effective learning skills. As part of the induction process apprentices will be introduced to the learning and research resources available within the University and on line through UH's Virtual Learning Environment, Studynet. In subsequent years, these skills are enhanced and supported by Helen Singer, the Schools' Information Manager. These skills are assessed through a number of modules and particularly in 6ENT1090 BEng Individual Project (Electrical).

## Intellectual depth, breadth and adaptability

The University encourages engagement in curricular, co-curricular and extra-curricular activities that deepen and broaden knowledge and develop powers of analysis, application, synthesis, evaluation and criticality. This occurs throughout the curriculum as the students/apprentices are exposed to Engineering Mathematics and Science, including technically deepening specialist topics appropriate to their discipline, providing a theoretical underpinning and practical work in laboratories which are then brought together in the Mini Projects at level 5 and the BEng Individual Project (Electrical) at level 6. Apprentices will be encouraged to adapt the technical skills they have learnt at UH in the work place. Apprentices will be expected to record these experiences as part of their Logbook which will be assessed during the end point assessment.

## Respect for others

The School of Physics, Engineering and Computer Science attract students from diverse backgrounds both geographically and culturally and strive to promote self-awareness, empathy, cultural awareness and mutual respect, all key ingredients for successful team working. Apprentices will be studying, and at times working, alongside these students in group activities such as laboratory experiments. In addition they will gain further experience of working in multidisciplinary teams within their companies. Apprentices will be expected to record these experiences as part of their Logbook which will be assessed during the end point assessment.

#### Social responsibility

The School, primarily through the use of project work, steers their graduates towards an understanding that the actions they take really can make a positive contribution to society. As Engineers and Technologists, students and apprentices are taught the importance of environmental, economical, ethical, regulatory and consumer requirements when designing new products. This is formally covered in Project Management & Product Development but expected to be applied during several modules and particularly of the BEng Individual Project (Electrical).

#### **Global Awareness**

Many employers of apprentices are international organisations and even those that are not will be importing materials/services and/or exporting products or services. As such apprentices will naturally gain a global awareness through the industrial experience with their employer.
