Please note that studying on the MSc Global Business Masters requires you to study both in the UK and at one of our partner institutions. This is a compulsory element of the course and it will be your responsibility to ensure you are able to acquire the necessary visas to successfully complete the course.

Students joining the programme in September study the first Semester at the University of Hertfordshire and take second and third Semester at one of our partner institutions, depending on their chosen specialization.

The entry requirement is standard for all of the IBSA partner universities, although students wishing to specialise in International Finance at UNCW may be asked to take a GMAT test, depending on their previous studies of finance.

If students wish to make changes to their specialisation after registration, there is a deadline to do so. Any requests to change after the deadline has passed will not be considered as this will impact upon the visa application and start date at the partner institution.

Academic Year

Academic Year 2021 – 2022

The University's academic year is made up of 3 Semesters. Normally most undergraduate programmes use Semesters A and B, additionally postgraduate programmes and specific undergraduate programmes use Semester C. Each of these is made up of teaching weeks followed by exams (the re-sit period falls within Semester C).

- Semester A runs from Monday 27 September 2021 to Friday 21 January 2022
- Semester B runs from Monday 24 January 2022 to Friday 13 May 2022
- Semester C runs from Monday 16 May 2022 to Friday 09 September 2022
