### A. Programme Rationale

BA (Hons) Fine Art at the University of Hertfordshire has a collaborative ethos and an innovative and transformative approach to learning, centred around an expanded relationship to materials, making and ideas through a dedicated studio/workshop-based programme supported by critical, theoretical and contextual studies. The atmosphere of the Fine Art programme is shaped by a sense of collective endeavour and experiential learning. Students have access to both traditional and cutting-edge workshop facilities, enabling students to specialise, and to generate a forward thinking and multi-disciplinary approach to artistic practice. Dialogue and self-reflection are focused on and students are encouraged to question value systems and motivations, whilst considering how they connect with wider cultural and historical contexts of fine art practice. The programme has a progressive outlook and global outreach, fostering openness to dynamic, emergent forms of fine art practice while giving students the perspective to place both themselves and their work in a broader context. Core to the programme is that teaching is actively led by practicing artists of national and international standing, which is informed by progressive research and exhibition profiles, with an aim of developing confidence and enthusiasm among the student cohort.

### B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in <u>UPR TL03</u>.

Additionally this programme aims to:



- Enable students to explore a wide variety of traditional and cutting-edge facilities, including
  printmaking, ceramics, welding, digital technologies, film, screen and sound, to generate a forward
  thinking and multi-disciplinary approach to artistic practice.
- Inspire self-motivation, intellectual curiosity, speculative enquiry, and imagination.
- Foster a progressive outlook and global outreach, encouraging openness to dynamic, emergent forms of fine art practice while giving students the perspective to place both themselves and their work in a broader contemporary art context.
- Establish, during the first year of study, a firm foundation of 'thinking through making', by exploring experimental projects, shared learning, and exchange of ideas in a supportive atmosphere.
- Through Critical and Cultural Studies modules, to focus on contemporary art and the practices, contexts and theories that inform it.
- Enhance student employability and preparedness for professional practice, with:
  - Strong industry links to institutions such as Henry Moore Foundation, Wysing Arts Centre
    and Camden Arts Centre students where students have the opportunity to experience and
    work in professional environments through 'action learning' workshops.
  - A relationship with the UH Arts and the UH galleries, where students will access a
    professional context allowing them to exhibit, work, collaborate and experience first-hand a
    creative work-related setting in conjunction with the UH Arts Team.
  - Exposure to the latest thinking from internationally renowned artists, writers, curators and philosophers, though regular Art Talks.
  - Professional practice sessions in the final year of study, to equip students for life after university by enabling entrepreneurial and transferable skills to be developed in tandem with practical creative knowledge and skills.

B1 to B5 are developed during the student's individual programme of study through group discussions, cross referencing of concepts and practice. Lectures, seminars, presentations, critiques and tutorials are key teaching and learning methods where issues of practice/context are addressed. Written assignments allow the further development of these learning outcomes.

Throughout, the learner is encouraged to develop intellectual skills further by independent study.

Practical skills are developed throughout the studio-based modules as part of an ongoing exploration and expansion of individual practice. Mandatory workshops are undertaken to attain an appropriate level of skills in particular media and processes.

C1 to C4 are developed through media support activities, demonstrations, seminars, workshops, tutorials, presentations and group discussions.

Throughout, the learner is expected to consolidate their development of practical skills by independently using the School and University's resources.

#### Assessment strategy

Practical skills (C1 - C4) are assessed through a combination of:

- -visual evidence of skills attained through media workshops, within a portfolio of practical work (C1)
- -experimental and developmental work, recorded in sketchbooks and other documentation of experiments and development processes (C1 C2)
- -a portfolio of resolved practical work, its selection and presentation (C3 C4)

Transferable skills are developed through all aspects of the programme, with active participation in seminars, tutorials and debates encouraged and expected. (D2 D3)

- Throughout, the learner is encouraged to develop transferable skills by maintaining a record of evidence and completing a personal development plan.

### D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full time (3 years), sandwich or with a year abroad (4 years), study abroad and with Employment Experience (4 years), sandwich and a year abroad (5 years) and part time (6 years) modes and leads to the following awards:

Entry is normally at level 4 with A-level or equivalent qualifications as detailed in section G but is possible at subsequent levels subject to appropriate qualifications and experience. Intake is normally Semester A (September).

Professional and Statutory Regulatory Bodies Not applicable.

Work-Based Learning (including Sandwich and Employment Experience) and Study Abroad (including Year Abroad) Programmes

Students wishing to study abroad at a host institution in another country, or to complete a work placement during their studies, may choose to undertake one of the following:

- Year Abroad (1 year)
- Study Abroad (1 semester)
- Sandwich (1 year)
- Employment experience (1 semester)



Students normally progress to the next level of study in the academic year following any of the above.

A designated Year Abroad programme leads to a University award in Study Abroad mode and the words "with a year abroad" appear on the award certificate. The Year Abroad will provide students with the opportunity to expand, develop and apply the knowledge and skills gained at the start of their course in the School of Creative Arts (UH), within a different organisational and cultural environment in a partner academic institution. The host institution will appoint a Programme Co-ordinator who will oversee the student's programme during the Year Abroad and will liaise with the appointed UH Supervisor.

Students undertaking a full Year Abroad may undertake a period of study at an approved partner institution as <u>an additional year either between Levels 4 and 5 (students must have passed 120 credits)</u> or <u>between Levels 5 and 6 (students must have passed 240 credits)</u>.

Alternatively, in exceptional cases where the curriculum provided at an approved franchise partner is aligned with that of their home programme and where this has been formally agreed by the Programme Leader, students may undertake this study period in place of Level 5 (Year 2) at the School of Creative Arts (UH). In this case, successful students will receive credit for 120 credits at Level 5 and their final degree classification will be calculated in line with those for a direct Level 6 entrant (i.e. Level 5 achievement/grades will not be taken in to account).

Students may opt to do a single semester of study abroad on, either in Semester A or Semester B, a designated Study Abroad programme leading to a University award with the words "with Study Abroad" included on the award certificate. Students choosing to study abroad for a single semester will be registered on the Study Abroad (Creative Arts) module (6CTA1166).

Students may undertake any previously deferred or referred <u>single-semester</u> modules during the same academic year of their study abroad, <u>but not during the same semester as Study Abroad</u>. Students who are undertaking single semester Study Abroad will not be permitted to undertake any further Level 5 modules during the same academic year as Study Abroad, including AB modules. <u>Students enrolled on Study Abroad will not be permitted to progress to Level 6 until the following academic year.</u>

A designated Sandwich programme leads to a University award in the sandwich mode, with the word "(Sandwich)" appearing on the final award certificate. In order for the programme to lead to an award in the sandwich mode, the student must undertake a period of approved work experience of not less than 36 weeks full-time equivalent with no possibility of exemption, usually between the end of Year 2 and the beginning of Year 4. This will usually be completed within the United Kingdom but, with prior approval, may be completed within other countries. Progress of the student's training and development is monitored through visits from University academic staff and/or through reports from the student. Students will be required to document this period of work in accordance with the guidelines produced by the School. Students on the Sandwich programme will be registered on the Sandwich Year Module (6CTA1008).

Students who have not achieved the minimum progression requirements at the end of Level 5 may be prevented from undertaking a sandwich placement. Students who are on the sandwich programme but have a 'Failed' grade in any Level 4 or Level 5 module will not normally be allowed to register to repeat this module until they return from placement.

Students undertaking a shorter period of work experience may be eligible for an award with Employment Experience. A designated Employment Experience programme leads to a University award with the words "with Employment Experience" appearing on the final award certificate. In order for the Employment Experience award to be achieved, the student must undertake a period of approved work experience of at least 12 weeks full-time equivalent from a maximum of two separate approved placements, neither of which



shall usually be less than 4 weeks in duration. Students on the Employment Experience programme will be registered on the Employment Experience (Creative Arts) module (6CTA1165).

Students may undertake any previously deferred or referred <u>single-semester</u> modules during the same academic year of Employment Experience, <u>but not during the same semester as Employment Experience</u>. Students who are undertaking single semester Employment Experience will not be permitted to undertake any further Level 5 modules during the same academic year as Employment Experience, including AB modules. <u>Students enrolled on Employment Experience will not be permitted to progress to Level 6 until the following academic year.</u>

Students may choose to combine study abroad and work experience awards, either by completing a full Year Abroad followed by a Sandwich, over 2 years, leading to the award of "(Sandwich) with a Year Abroad", or by completing Study Abroad and Employment Experience within a single year, leading to an award "with Study Abroad and with Employment Experience".

#### Other Work Experience (Short and Medium Term)

In addition to offering a full Sandwich year (as explained above and referred to in the School as a 'Long Term Work Experience'), we encourage students to participate in shorter work experiences / placements.

With agreement from the Programme Leader, a student negotiated work experience is available within this Programme at Levels 5.

This means that, with prior written agreement, a student may undertake:

- a work experience in place of an assessed component within one of the named modules below (referred to as a 'Short Term Work Experience'); or,
- a work experience entirely in place of one of the named modules below (referred to as a 'Medium Term Work Experience').

In the case of a Medium Term Work Experience, the student will be de-registered from the chosen module and registered upon 5CTA1009 Professional Work Experience 30: Visual Arts instead.

The module that is approved within this Programme for work experience/placement are:

5CTA1254 – Fine Art Studio Practice 2A (30 credits) 5CTA1255 – Fine Art Studio Practice 2B (30 credits) 6CTA1160 - Fine Art Practice 3B (60 credits) ('Short Term' only)

Students normally undertake their work placement *during* Level 5, with the assessment submission made during the period of the module, or alternatively may negotiate with the programme leader to allow a placement undertaken at a different time (for example, during a vacation or non-teaching period) to be accredited within an approved module - with appropriate evidence submitted (including a reflective report).

Students (and staff when considering approval) should carefully consider any potential difficulties which may arise when attempting to undertake work experience simultaneously with their academic study (for example, Timetable constraints for other modules). In terms of exemption from academic study whilst undertaking a work placement, a time equivalent to 30 credits is normally the maximum permitted.

Additional advice on these modules is available in the School's Accredited Work Experience Handbook and the Professional Work Experience Definitive Module Document (DMD). Students will need approval of the programme leader or nominee for the work experience, to ensure that the scope and level of challenge / learning of the work submitted in reflection upon a work experience, is appropriate and as far as possible, matched in scope and level to any work being substituted.

The programme supports the student in opportunities to undertake live projects which may arise through



their own endeavour and works to build such opportunities into the student's learning and assessment through negotiation of briefs and presentable outcomes. The term 'live projects' refers here to a range of activities that extends well beyond those that are primarily commercial and includes social enterprise projects undertaken in connection with community groups, arts organisations and other agencies. Where a student wishes to undertake a live project, it is a requirement that before it commences there is in place a learning contract that specifies clearly how it enables the student to fulfil the module Learning Outcomes; the materials to be submitted for assessment; the date of submission for that material; what the work means in terms of the student's attendance and workload and an appropriate strategy for supervision by a tutor. That contract has to be agreed by both the module tutor and the Programme Leader

#### **Incoming CATS International Students**

With prior agreement from the School's CATS Tutor and Programme Leader, incoming International students on the CATS scheme may participate in this Programme by undertaking modules and gaining the associated credit, typically at Level 5. Additionally, the following modules are available to those students seeking credit for their work submitted within a single semester timeframe, whilst studying alongside UH/Home students registered on two-semester modules:

5CTA1213 Visual Arts Studies A (15 credits) 5CTA1214 Visual Arts Studies B (15 credits) 5CTA1215 Visual Arts Studies C (15 credits) 5CTA1216 Visual Arts Studies D (15 credits)

In such cases, an Approved Study Pattern for single-semester study will be determined at the commencement of the study period. The Study Pattern should clearly specify the format/quantity/weighting of assessments that are to be submitted at the conclusion of the study period – please see the relevant DMDs for more information.

NOTE: Visiting students wishing to study for a single semester in the School of Creative Arts may participate in the Level 5 activities within a *single* Programme only during the required semester.

Progression to levels 5 and 6 requires a minimum of 90 and 210 credits respectively and passes in all compulsory modules.

The award of an honours degree requires 360 credit points passed with a minimum of at least 120 at level 6 including the final degree project appropriate to the award title.

A portfolio of creative arts work is required, with evidence of previous Fine Art and an interview is usually required. The interview takes the form of a portfolio-based discussion of the applicant's precursor experiences and learning and their aspirations within the field of Fine Art.

All international students are required to demonstrate suitable levels of English language competence. This can be through previous study in English, but we often require specific performance in English tests. All undergraduates must be able to prove a minimum of IELTS 6.0, TOEFL 213 or equivalent.

The programme is subject to the University's Principles, Policies and Regulations for the Admission of Students to Undergraduate and Taught Postgraduate Programmes (in <u>UPR SA03</u>), along with associated procedures.
