A. Programme Rationale

The Fashion and Fashion Business Programme offers a comprehensive education in the global fashion industry, encompassing creative, theoretical, and business disciplines. Its goal is to raise awareness of the industry's challenges and to educate the next generation of students on the importance of sustainable practices and environmental responsibility.

The curriculum covers a broad range of topics that are relevant to the industry, including design, sustainability, buying, merchandising, e-commerce, digital marketing, promotion, sales, and ethical, cultural, and historical issues. The program fosters creativity, exploration, curiosity, and innovation while developing essential technical and theoretical skills for various roles in the fashion industry. Live projects, competitions, and work-based learning opportunities are facilitated by experienced academics, industry professionals, and visiting lecturers.

The program collaborates with well-known fashion brands, businesses, and organizations that share similar values, providing students with a dynamic and engaging learning environment. Students are encouraged to participate in national and international study trips and work experience placements to gain practical exposure to the industry.

Graduates of the program possess a diverse set of skills, including creative, technical, theoretical, business, and communication skills. They have an understanding of the global fashion industry, preparing them for successful careers in fashion.



B. Educational Aims of the Programme

Diversity and Inclusion

Our programmes are purposefully designed to enable all students to engage meaningfully with the curriculum by being accessible and representative. We will support students to shape their learning experience, removing barriers and enabling them to succeed. The curriculum explicitly includes multiple and representative perspectives, valuing collective identities and individual diversity. Learning, teaching and assessment activities help students to understand how they can enhance outcomes both for themselves and for others. All students belong to a learning community, and during their studies we really want to hear their voices, encourage them to listen to others, and express themselves.

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in UPR TL03.

- enable students to make reasoned judgements, frame appropriate questions, undertake quantitative and qualitative analysis and draw independent conclusions;
- foster the transferable skills which will enable students to respond to current and future career challenges;
- provide an opportunity for a student to respond to debates around conscious fashion, be active in affecting change behaviour and reflect through their own practice, responses to tackle the issues surrounding fashion's impact on, environments, climate change, over consumption and over production in fashion;
- · consideration given to the engagement of cultures, issues of identity and diversity;
- promote the values of ethical behaviour, sustainability and personal contribution. Our graduates will
 understand how their actions can enhance the wellbeing of others and will be equipped to make a
 valuable contribution to society;
- provide the opportunity for students to develop critical insight into contemporary fashion practices
 and debates. Students will be able to locate their own work within a wider cultural context, with a
 clear understanding of the cultural, aesthetic and professional forces that shape contemporary



fashion design, fashion business and fashion communication, using them to reflect on their own practice;

- prepare students for further academic or professional study in fashion or related fields by equipping them to initiate and manage an independent course of study;
- develop the ability to create, evaluate and assess a range of options together with the capacity to apply ideas and knowledge to a range of situations.

Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject.

At level 6, students demonstrate their knowledge and understanding of a particular aspect of fashion through a programme of course work, much of which is determined by them with sufficient guidance.

Intellectual skills are developed throughout the programme by the methods and strategies outlined in section A, above.

Teaching and learning methods

Typically, the student's conceptual development will be evident in a design process that demonstrates creative critical and analytical thinking and problem solving, analysis and judgement in the development of solutions and a willingness to explore a range of media.

Conceptual development is an integral part of studio work and is fostered by set-briefs, incourse exercises, workshops, self-determined briefs, seminars and tutorial work.

Throughout, the learner is encouraged to develop intellectual skills further by independent study

Assessment strategy

Intellectual skills are assessed by in-course assessments of outcome submissions and presentations.

Typically, evidence will consist of work sheets, sketchbooks, research, design ideas. development and outcomes, digital medium and proposals, essays, reports, case studies, data analysis.

Intellectual skills relevant to marketing and communication is assessed through set and negotiated projects, surveys, data analysis and case studies.

Practical skills refer to the practical and professional skills employed in the production of design ideas and solutions.

At levels 4, 5 and 6 these skills are developed through set briefs, exercises and workshops. At level 6, students are expected to demonstrate professionalism together with aesthetic, and functional judgements in the presentation of their ideas.

Practical skills are evidenced in the production values of course work and are assessed through outcome submissions and presentations.

The skills of research, digital technology and self-management are integral to coursework at all levels. Personal responsibility becomes an increasingly important skill as students progress to level 6 study.

Assessment strategy

Transferable skills are assessed through a range of assignments built into the curriculum. In-course assessment is by submission of a portfolio, essays, reports, case studies, spreadsheets, digital communication methods and digital and physical written and oral presentations.

Critical awareness and flexibility are developed through selfassessment and negotiated projects and self-determined projects.

Communication skills are developed through oral presentations and in written work. The ability to work flexibly with others is developed through group projects.

Business, marketing and communication skills are taught using group working, directed reading, independent study, role-play and presentations.

Throughout, the learner is encouraged to develop transferable skills by maintaining a record of evidence and completing a personal development plan.

D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full-time (3 years), sandwich or with a year abroad (4 years), study abroad and with Employment Experience (4 years), sandwich and a year abroad (5 years) and part-time (6 years) modes and leads to the award of:

BA (Hons) Fashion and Fashion Business with a Year Abroad (Sandwich)

Entry is normally at level 4 with A-level or equivalent qualifications as detailed on the University website, but is possible at subsequent levels subject to appropriate qualifications and experience. Intake is normally Semester A (September).

Work-Based Learning, including Sandwich Programmes

A designated Sandwich programme leads to a University award in the sandwich mode, with the word "(Sandwich)" appearing on the final award certificate. In order for the programme to lead to an award in the sandwich mode, the student must undertake a period of approved work experience of not less than 30 weeks full-time equivalent with no possibility of exemption, usually between the end of Level 5 and the beginning of Level 6. This will usually be completed within the United Kingdom but, with prior approval, may be completed within other countries. Progress of the student's training and development is monitored through visits from University academic staff and/or through reports from the student. Students will be



required to document this period of work in accordance with the guidelines produced by the School. Students on the Sandwich programme will be registered on the Sandwich Year Module (6CTA1008).

Students who have not achieved the minimum progression requirements at the end of Level 5 may be prevented from undertaking a sandwich placement. Students who are on the sandwich programme but have a 'Failed' grade in any Level 4 or Level 5 module will not normally be allowed to register to repeat this module until they return from placement.

Students may choose to combine study abroad and work experience awards, by completing a full Year Abroad followed by a Sandwich, over 2 years, leading to the award of "with a Year Abroad (Sandwich)".

Where a student enrols on Year Abroad or Sandwich, but encounters circumstances that prevent completion of the minimum number of weeks required, they may, with permission from their programme leader, be transferred onto single semester Study Abroad and/or Employment Experience.

Other Work Experience (Short and Medium Term)

In addition to offering a full Sandwich year (as explained above and referred to in the School as a 'Long Term Work Experience'), we encourage students to participate in shorter work experiences/placements.

With agreement from the Programme Leader, a student negotiated work experience is available within this Programme at Level 5.

This means that, with prior written agreement, a student may undertake:

- a work experience in place of an assessed component within one of the named modules below (referred to as a 'Short-Term Work Experience')
- a work experience entirely in place of one of the named modules below (referred to as a 'Medium-Term Work Experience')

5CTA2028 Advanced Fashion Product Development (L5) (15 credits, Semester B)

For Medium-Term Work Experience, the student will be de-registered from the chosen module and registered upon 5CTA1004 Professional Work Experience 15: Design instead.

Student Exchange programme Incoming Exchange

Incoming Study Abroad students study the course at level five.

In such cases, an Approved Study Pattern for single-semester study will be determined at the commencement of the study period. The Study Pattern should clearly specify the format/quantity/weighting of assessments that are to be submitted at the conclusion of the study period – please see the relevant DMDs for more information.

NOTE: Visiting students wishing to study for a single semester in the School of Creative Arts may participate in the Level 5 activities within a single Programme only during the required semester.

Study Abroad

All students on the course are eligible to complete a study abroad option, usually between levels four and five, or levels five and six. Study abroad is normally one full year, but students can opt to complete one semester of study abroad and one semester of work experience, with the permission of the school.

Students wishing to study abroad at a host institution in another country, or to complete a work placement during their studies, may choose to undertake one of the following:

- Sandwich (for a full year)
- Year Abroad (for a full year)

Some students may alternatively be eligible for the following:

- Study Abroad (for a single semester only)*
- Employment Experience (for a single semester only)**
- Employment Experience and Study Abroad (Employment Experience for a single semester + Study Abroad for a single semester)***
- * Students can choose to Study Abroad for a <u>single</u> semester only in either semester A or B. Students will be made Dormant for the semester they are not engaged with.
- ** Students can choose Employment Experience for a <u>single</u> semester only in either semester A or B. Students will be made Dormant for the semester they are not engaged with. Students wishing to undertake Employment Experience for the whole year will be registered on the Sandwich option.
- ***Students can choose to combine Employment Experience for a single semester and Study Abroad for a single semester in the same academic year only. There is no condition to which way around this takes place.

Students choosing to undertake Sandwich, Year Abroad, Study Abroad and/or Employment Experience will need to decide in advance of the following eligible academic year and discuss this with the Programme Leader and Student Record Administrator first.

Students normally progress to the next level of study in the academic year following any of the above.

A designated Year Abroad programme leads to a University award in Study Abroad mode and the words "with a Year Abroad" appear on the award certificate. The Year Abroad will provide students with the opportunity to expand, develop and apply the knowledge and skills gained at the start of their course in the School of Creative Arts (UH), within a different organisational and cultural environment in a partner academic institution. The host institution will appoint a Programme Co-ordinator who will oversee the student's programme during the Year Abroad and will liaise with the appointed UH Supervisor.

Students undertaking a full Year Abroad may undertake a period of study at an approved partner institution as <u>an additional year either between Levels 4 and 5 (students must have passed 120 credits)</u> or <u>between Levels 5 and 6 (students must have passed 240 credits)</u>.
