A. Programme Rationale

The award is aimed at students who wish to develop an understanding of the discovery and development of new medicines and their use in the treatment of disease. The study of pharmacology will consider both the actions of drugs on the body and its systems through an interaction with cells, receptors, enzymes and genes, and the ability of the body to absorb, distribute, metabolise, and excrete drugs. Pharmacology staff have over 50 years combined experience working in the pharmaceutical industry. Their expertise feeds into the content and delivery of the programme. This programme has been accredited by the Royal Society of Biology. Accreditation by the Royal Society of Biology recognises and supports the advancement of skills and education in the biosciences, throughout the UK and internationally. Graduates from accredited degree programmes are equipped with well-rounded knowledge and skill sets, making them highly employable both within and beyond their chosen field. All students wishing to complete a Level 6 laboratory-based research project will have the opportunity to do so, which is a substantial skills enhancement for students going on to study for research degrees and move into research roles. Successful students will be equipped for graduate employment in pharmaceutical and related industries. The strong foundation provided is endorsed by our alumni. In addition, graduates are well prepared for further study in the field including medicine.

B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in <u>UPR TL03</u>.

Enable students to develop knowledge, understanding and investigative skills relevant to:

- · the source and development of new medicines, including clinical testing;
- the factors influencing the absorption, distribution, biotransformation and excretion of drugs;

- support the development of the transferable skills and attributes necessary for the students' future professional development through academic study and continual lifelong learning as scientists.

Teaching and learning methods

Problem analysis and solving skills (B1) will be developed in all Level 4 and 5 modules but focused on in Bioscience Research Methods at Level 5. Analysis of pharmacology problems will be focused on in final year modules with integration across the topic areas in Applied and Integrated Pharmacological Science. Students are given a firm grounding in ethical practices in science (B2) throughout Level 4 and issues pertinent to Pharmacology are developed in the Level 5 module, Bioscience Research Methods.

Aspects relevant to independent research (B3) are introduced in the Level 5 module, Bioscience Research Methods and come into fruition in the Project module at Level 6. The relationship of theory to practice (B4) is achieved throughout the whole programme, focused on in case studies in Applied and Integrated Pharmacological Science, and is the fundamental basis of the placement training (where appropriate).

Workshop exercises in all modules make a significant contribution to B5 and this is enhanced by taught material in Bioscience Research Methods

To acquire B6 the student is introduced to the analysis of published literature as part of Bioscience Research Methods at Level 5 and other written assignments, evaluation is developed at Level 6 in lectures, assignments including problem-based learning, and their project. Maths skills are introduced as part of Practical and Transferable Skills at Level 4. developed in practical reports throughout Level 5 and in the Bioscience Research Project. Data handling and statistical analysis is introduced in Practical and Transferable Skills at Level 4, developed in assignments and Bioscience Research Methods at Level 5 and reinforced in the project at Level 6.

Throughout, the learner is encouraged to develop intellectual skills further by independent study.

Assessment strategy

B1. B2 and B4 are assessed in laboratory reports and written assignments. In addition B1 is assessed by unseen examinations. The development of the project proposal in Bioscience Research Methods demonstrates B1, B2 and B4. The Project (B3) is tested by the assessment of performance whilst undertaking the research, the assessment of the report and a poster. B5 and B6 are assessed in laboratory reports, unseen examinations, interpretative exercises, seminars, vivas and the project. Regular on-line assessments are used for maths skills and data analysis.

Acquisition of D2 is through induction classes at all three Levels and in lectures and workshops in Level 4, in particular in Practical and Transferable Skills and Level 5, Bioscience Research Methods; scientific writing is throughout the course and the Project module in which information seeking will be facilitated by the project tutor.

The teaching of D3 is initiated in Practical and Transferable Skills with exercises on report writing; during year 1, personal tutors give feedback on written assignments from a number of modules to facilitate the development of skills; Bioscience Research Methods at Level 5. feedback on assignments at all Levels, seminars at Level 6 and the project introduction make a significant contribution to the development of

D6 (numeracy) is assessed in numerous assignments throughout the programme and monitored by the personal tutor in a portfolio in Practical and Transferable Skills and Bioscience Research Methods.

D7 is assessed in Practical and Transferable Skills and Bioscience Research Methods The placement report will

The acquisition of D4 and D5 is throughout all the practical components of the programme where students are required to work alone or as part of a team and in some modules, to carry out group assignments. In addition, working as a member of a team is introduced in Human Physiology with Pharmacology at Level 4, explored through an interdisciplinary assignment in Level 5 in Bioscience Research Methods and further enhanced during an exercise in final year induction week.

The acquisition of D6 (numeracy) is initiated in lectures, workshops and class exercises in Practical and Transferable Skills (Level 4) and is developed and reinforced throughout the programme in laboratory classes, workshops, personal tutor meetings and the project. Students have access to the 'Maths Drop-in Centre' and self-learning 'MyMaths lab' compute- based learning package.

Statistical knowledge is developed in Bioscience Research Methods and applied in data analysis in Level 5 and 6 modules including the Bioscience Research Project.

The development of self-management skills (D7) is facilitated, and monitored, by personal tutors involving discussion of skills relevant to successful performance on the degree and future employability. The placement year (if taken) makes significant contributions to the attainment of this skill.

The importance of graduate attributes (D8) is discussed in Practical and Transferable Skills in Level 4 and focused upon in Level 5 induction programme and Bioscience Research Methods where students prepare their CV and reflect on their career development. Finally the importance of graduate attributes is a key part of the placement year/Bioscience Work Experience (if taken) and the Applied and Integrated Pharmacological Science module

Throughout, the learner is encouraged to develop transferable skills and graduate attributes by maintaining a record of evidence and completing a personal development plan.

D8 is assessed in Practical and Transferable Skills and Bioscience Research Methods and as part of the placement year portfolio and/or Bioscience Work Experience (if taken).

D9 is assessed as part of the portfolio in Bioscience Work Experience and in the placement report for those who undertake a placement year.

D10 is assessed by successful completion of the Year Abroad.



D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full-time (3 years), Sandwich (4 years), with a Year Abroad (4 years) and part-time (6 years) modes and leads to the award of a BSc (Hons) Pharmacology, BSc (Hons) Pharmacology (Sandwich) or BSc (Hons) Pharmacology with a Year Abroad. Entry is normally at Level 4 with suitable A Levels or equivalent qualifications but is possible at Level 5 or Level 6 with suitable qualifications (eg successful completion of Level 4/5 of comparable degrees elsewhere). Intake is normally at the beginning of Semester A in September.

The course structure and progression information below is provided for the final awards (Table 1).

The Programme Learning Outcomes detailed in section C are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed.

Professional and Statutory Regulatory Bodies

The awards of BSc (Hons) Pharmacology, BSc (Hons) Pharmacology (Sandwich) and BSc (Hons) Pharmacology with a Year Abroad are accredited by the Royal Society of Biology.

Work-Based Learning, including Sandwich Programmes

BSc (Hons) Pharmacology (Sandwich)

A designated sandwich programme leads to a University award in the sandwich mode and the word "Sandwich" appears on the award certificate. In order for the programme of study to lead to an award in the sandwich mode, the student must undertake a period of approved work experience (industrial/hospital-based placement) of not less than 30 weeks excluding holidays, normally between the end of Year 2 and the beginning of Year 4. This is an academic requirement regarding the minimum number of weeks necessary in order to gain a sandwich award. Students may be expected to work further additional weeks in order to fulfil their contractual obligations to the employer. Students must start their placement before 1st October. The placement will normally be completed within the United Kingdom but there is also the opportunity for a placement abroad subject to University approval. Students on a sandwich placement will be registered on the module Sandwich Year: Bioscience (6LMS0023) for the placement year.

Bioscience Work Experience (5LMS0003)

We encourage students to participate in work experience and all students are encouraged to enrol on the optional 5LMS0003 Bioscience Work Experience module. This is additional to the taught modules on the programme. Students undertaking the module are required to complete a minimum of 50 hours within the workplace, either paid or voluntary, and to submit a portfolio to demonstrate their employability skills. The portfolio will include evidence of any employment experiences the student has, evidence of any voluntary work experience, a reflection on the employability skills gained during work experience and a careers action plan, including a curriculum vita, to further their employability skills following graduation.

Student negotiated work experience is available, by agreement with programme staff at Level 5. It is also possible for a student to undertake a summer placement between Level 5 and Level 6.

Student Exchange programme

Incoming Exchange

Incoming students are permitted to study modules on the course at Levels 4, 5 and 6, subject to timetabling constraints.

Study Abroad

BSc (Hons) Pharmacology with a Year Abroad

There is also an option to study abroad at approved partner institutions. A year abroad is deemed to be not less than two semesters in the host institution. Progress of the student's training is monitored by visits from the University's academic staff. Students will be required to document this period of work in accordance with



the guidelines produced by the Department of Biological and Environmental Sciences. Students who study abroad on Year Abroad will be registered on the module Year Abroad: Bioscience (6LMS0022).

Students who have not achieved the minimum progression requirements at the end of Level 5 may be prevented from undertaking a sandwich placement. Additionally, students on placement, but who have Level 4 or 5 modules to repeat will not normally be allowed to re-enrol on these modules until they return from placement. This is to avoid a conflict between UH attendance requirements and the student's commitment to their employer. There is also a minimum achievement at Level 5 required for the Year Abroad which is set by the partner institutions.

Students who do not take the Sandwich or Year Abroad option, progressing directly to Level 6, are automatically transferred to the full-time or relevant part-time mode.

The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed.

Progression to level 6 requires a minimum of 105 credits at level 5. The module 5LMS0003 Bioscience Work Experience may not be included in the credits required for progression.

The award of an Honours degree requires 360 credit points passed with a minimum of at least 120 at Level 6 including the final year project.

Mode of Study Part-time

This requires the same modules to be completed as per the full-time pathway. The following describes the standard part-time programme structure, with completion of 60 credits per year. Deviations from this structure are possible, subject to meeting module prerequisites and agreement by the Programme Leader. Part-time students may study up to 75 credits a year. The progression requirements above also apply for this mode of study. Students on the part-time mode may also take a sandwich placement year or year abroad option but any of these need to be completed in 1 year (so that the programme is completed in a maximum of 7 years in total) as described below in the programme-specific regulations.

Further programme-specific regulations (requiring School-level approval) are given below:

- The grade achieved in the optional 5LMS0003 Bioscience Work Experience module will not contribute to the classification of the final award.
- Progression to Level 5 requires a minimum of 105 credits and a pass in the module Practical and Transferable Skills.



- Progression to Level 6 requires a minimum of 105 credits at Level 5. The module 5LMS0003 Bioscience Work Experience may not be included in the credits required for progression.
- A pass grade in the final year project is required for a final award.
- A pass grade for the Sandwich Placement Year is mandatory for the receipt of BSc (Hons) Pharmacology (Sandwich) award.
- A pass grade for the Year Abroad is mandatory for the award of BSc (Hons) Pharmacology with a Year Abroad.
- All modules which include practical sessions have an attendance requirement of at least 50% of the practical sessions in order to meet the learning outcomes of the module. Failure to attend the required proportion of sessions will normally result in the award of an FREN (Fail, re-enrol) grade.
- All Level 6 modules of the programme have an attendance requirement of at least 75% of the classes specified in the module. Failure to attend the required proportion of classes and failure of the module assessment at the first attempt will normally result in the award of an FREN (Fail, re-enrol) grade by the Module Board of Examiners.
- The maximum period within which a student may gain an award on the programme is normally 5 years from their date of registration as a full-time student or 7 years from their date of registration as a parttime student.
- Students on the part-time mode may take a placement or year abroad but either of these needs to be completed in 1 year.

- The programme committee, the membership of which includes student representatives, academic and professional staff.

G. Entry requirements

The normal entry requirements for the programme are:

112 UCAS points to include 2 science GCE A Levels (or equivalent) one of which must be a grade C in Biology or Chemistry (acceptable science A Levels are Human Biology, Psychology, Geography, Maths and Physics) or BTEC Extended Diploma in Applied Science with a minimum DMM profile. A pass in the practical element of the science A Level is required. For IB 112 points from a minimum of 2 HL subjects at H4 or



above to include Biology or Chemistry and one other Science (with the remaining points to come from a combination of HL, SL and Core).

Plus GCSE English language, Mathematics and double science (or 2 single sciences) at grade 4 or above (grade C under the old grading structure) (or equivalent).

Successful completion of Access to Science (or approved equivalent) with Merit profile in 45 credits at Level 3.

All International students are required to demonstrate an English Language capability of IELTS 6.0 (with no less than 5.5 in any band) or GCSE English language grade A-C.

All entrants must be a minimum of 18 years of age at the start of the course.

Students who undertake a placement year or enrol on the 5LMS0003 Bioscience Work Experience module may be required to complete a satisfactory Disclosure and Barring Service check prior to taking up the placement, workplace or volunteering opportunity as a requirement of the place of work.

For current entry tariff point requirements, please refer to the relevant page for the Course on the University website or on the online prospectus.

The programme is subject to the University's Principles, Policies and Regulations for the Admission of Students to Undergraduate and Taught Postgraduate Programmes (in <u>UPR SA03</u>), along with associated procedures.
